****	Elected Officials: State Attorneys are automatically included under Pay Plan 5 (no time sheet required, no leave granted and no payouts at end of term - except for DROP). State Attorneys may choose Pay Plan 16 where they maintain timesheets, accrue and take leave, they can be assigned to Senior Management accruing 240 hours annually per year and payouts of 480 annual and sick if accrued upon retirement/resignation etc.
