SEVENTEENTH ANNUAL REPORT

This report is submitted to the Administrative Procedures Committee and to the Administration Commission in compliance with the requirements of Section 120.70, Florida Statutes, which provides:

Not later than February 1 of each year, the division shall issue a written report to the Administrative Procedures Committee and the Administration Commission, including at least the following information:

- (1) A summary of the extent and effect of agencies' utilization of hearing officers, court reporters, and other personnel in proceedings under this act.
- (2) Recommendations for changes or improvement in the Administrative Procedure Act or any agency's practice or policy with respect thereto.

GENERAL

The Department of Health and Rehabilitative Services' total cases increased from 4,033 in 1989 to 4,910 in 1990, an increase of 21.75 percent. Of this increase, Baker Act Cases increased by 617 in 1990, an increase of 22.56 percent; non-Baker Act cases increased by 260 cases, an increase of 20.03 percent. Child abuse cases have remained steady during 1990, with 714 cases filed.

Department of Corrections cases increased from 76 in 1989 to 109 in 1990, an increase of 43.42 percent. Department of Corrections cases include an upsurge in Rule Challenge cases, from 202 in 1989 to 276 in 1990, an increase of 36.63 percent.

Growth management cases continued to dramatically increase, from 83 cases in 1989, to 134 cases in 1990, an increase of 61.45 percent. This increase is reflected in the number of cases filed by the Department of Community Affairs, which increased from 110 in 1989 to 171 in 1990, an increase of 55.45 percent.

Department of State cases increased from 54 in 1989 to 84 in 1990, an increase of 55.56 percent. Significant to this increase was the number of Division of Licensing cases filed, from 39 in 1989 to 68 in 1990, an increase of 74.36 percent.

Department of Banking and Finance cases increased from 75 in 1989 to 140 in 1990, an increase of 86.67 percent.

Department of Labor and Employment Security cases increased by 100 percent, from 23 cases filed in 1989 to 46 in 1990.

In December 1989, the Division received the first requests for hearings in medical negligence cases, which require the use of a Hearing Officer as Chief Arbitrator of a three person panel. The constitutionality of the statute, which imposes caps on non-economic damages in return for the arbitration process, was challenged in Echarte et al. v. University of Miami School of Medicine, Case No. 89-36270, in Dade County Circuit Court.

The Division assigned a Hearing Officer to conduct the certification hearing for the Magnetic Levitation Demonstration Project. That case is awaiting final hearing.

In addition, in late 1989, the Florida High Speed Rail Transportation Commission requested the Division to conduct the hearings required in connection with the proposed high speed rail line. A three Hearing Officer panel has been appointed to handle this case which could be a complex and lengthy proceeding. Final Order authority in both of these transportation proceedings is placed in the Governor and Cabinet.

The enactment of Chapter 89-91, Laws of Florida, providing for the use of Division Hearing Officers to conduct proceedings on disputed citrus canker compensation claims will now be implemented due to the recent decision of the Florida Supreme Court in the case of State of Florida v. Bonanno, So.2d ____ (1990).

In June, 1989, the Division initiated a Settlement Assistance Program designed to assist parties in the early settlement of selected types of cases to increase the availability of hearing dates for contested cases. After six months of experience, it has been decided to modify the program whereby only one Hearing Officer will provide settlement assistance when requested by the parties.

UTILIZATION OF PERSONNEL

The Division has 62 established positions comprised of the Director, Assistant Director, 30 Hearing Officers, 1

Executive Assistant, 4 Administrative Assistants, 5 Staff Assistants, 1 Personnel Technician, 1 Office Automation Specialist, 1 Accountant, 1 Senior Executive Secretary, 2 Senior Word Processing Systems Operators, 12 Administrative Secretaries and 2 Senior Clerks.

In 1990, the Division used OPS funds to contract with two attorneys to serve on a panel with one FTE hearing officer to conduct prehearing and trial proceedings for the High Speed Rail Siting and certification case.

WORKLOAD INCREASES

During calendar year 1990, the Division processed 8,202 hearing requests, an increase of 1,008 cases (14.01 percent) from 1989. The cases opened are itemized by agency in the attached Appendix 1.

Of the 8,202 cases, 3,352 were Baker Act cases. The remaining cases were filed pursuant to Section 120.54, 120.56, and 120.57, Florida Statutes. In 1990, each Hearing Officer handled an average of 236 new cases, conducted an average of 141 hearings, and wrote an average of 132 recommended or final orders of varying length and complexity. In 1990, the Division held a total of 4,964 hearings, an increase of 17.13 percent over the 4,238 hearings held in 1989. During the year, the Division closed 8,082 cases, an average of 231 closures per Hearing Officer, an increase of 607 case closures (8.12 percent) over 1989.

OFFICE AUTOMATION

The Division's computer system consists of a Unisys XE530 (shared resource processor) and 66 cluster workstations. The system was upgraded to the XE530 in 1990. The XE530 provides faster processors, more disk space and more memory. Each DOAH employee now has a workstation.

The two primary applications are word processing and a custom Case Tracking System (CTS), with secondary office automation applications including electronic mail and an automated desk calendar.

OPERATING BUDGET

The Division's FY 1990-91 approved operating budget decreased by 7.33 percent from the previous fiscal year. Three positions (2 hearing officers and one senior clerk) were also deleted in FY 1990-91. In an attempt to eliminate projected shortfalls in the Division's salaries and expenses appropriation categories, the Division submitted a budget amendment in November, 1990, requesting additional spending authority, which has not yet been authorized. Appendix 2 is a summary of the Division's operating budgets for FY 1989-90 and FY 1990-91, and its FY 1991-92 amended legislative budget request.

In FY 1989-90, the Division's actual expenditures were under its approved operating budget by \$209,857, or 4.67 percent. The return of these funds is attributed primarily to the Division's efforts to exercise fiscal restraint, and to position vacancies.

Since FY 1987-88, the Division has conducted studies to determine a more equitable method of apportioning its operating costs among all users. The Division is responsible for preparing annual reports which summarize the number of hours scheduled by agencies for prehearing conferences, motion hearings, cancelled/continued hearings, and final hearings. On December 1, 1990, the Division submitted the results of its fourth annual study and funding recommendations to the Legislature and Executive Office of the Governor (see Appendix 3). In 1990, agencies scheduled a total of 28,022 hearing hours with the Division, an increase of 17.33 percent over 1989's 23,883 hearing hours scheduled. Of the 28,022 hours scheduled in 1990, the Division's hearing officers actually spent 9,501 hours in administrative proceedings, an increase of 26.73 percent over the 7,497 hours expended in 1989. In 1990, 18,521 hearing hours scheduled were cancelled or continued; an increase of 13.03 percent over the 16,386 hours cancelled in 1989.

In FY 1990-91, the Division receives 86 percent of its approved operating budget from the Departments of Banking and Finance, Business Regulation, Environmental Regulation, Education, Health and Rehabilitative Services, Insurance, Professional Regulation and Transportation, and 14 percent from the General Revenue Fund. Based on the results of the December, 1990, report, the Division recommended that all agencies and entities utilizing the Division's services contribute to the Division's Administrative Trust Fund. This would result in funding 100 percent of the Division's FY 1991-92 operating budget from the Administrative Trust Fund.

RECOMMENDATIONS CONCERNING THE A.P.A.

The Division has no current recommendations concerning
the Administrative Procedure Act.

The Division continues to track by agency the number of hours it expends for prehearing conferences, motion hearings, cancelled/continued hearings, and final hearings. Since submission of the last annual report on December 1, 1989, DOAH has also submitted interim reports to the Legislature and Governor's Office (see Attachment A).

FINDINGS

The following findings are based on the Division's Final Report on Hours Scheduled by Agency for the period December 1, 1989 through November 30, 1990 (see Attachment B).

SUMMARY

Cost Apportionment Study Conducted by the Division of Administrative Hearings

December 3, 1990

BACKGROUND

Pursuant to Chapter 120, Florida Statutes, and other law, the Division of Administrative Hearings (DOAH) provides the services of hearing officers to conduct hearings for state agencies and other governmental entities. Prior to FY 1988-89, only two agencies, the Departments of Professional Regulation (DPR) and Transportation (DOT), contributed to the Division's Administrative Trust Fund. Because the services provided by DOAH to these two agencies were identical to services provided to other state agencies, DOAH was directed by the Legislature to conduct studies to determine a more equitable method of apportioning its operating costs among all users.

Since December 1, 1987, DOAH has prepared annual reports summarizing its analyses of administrative hearing hours scheduled by agencies. Based upon these report results, funding of the Division's operating budget has shifted significantly over the last three fiscal years from the General Revenue Fund to the Administrative Trust Fund, as illustrated in the following table:

1. The ratio of cancelled/continued hearing hours to final hearing hours is 2.32:1. Because cases settle or continue near the scheduled hearing date and DOAH must provide two weeks notice of a hearing pursuant to Section 120.57, Florida Statutes, time cannot be rescheduled easily. However, the hours scheduled are not attributed to an agency if it gives at least thirty days notice of cancellation or continuance of a hearing.

2. A total of 31 agencies and entities utilized the Division's services for the period December 1, 1989 through November 30, 1990. Of the 31, four agencies accounted for 68 percent of the total hearing hours expended by DOAH: the Departments of Health and Rehabilitative Services (28%), Professional Regulation (18%), Environmental Regulation (13%), and Education (9%).

CONCLUSIONS:

The Division concludes that the following recommendations are practical and fair in apportioning the costs of providing hearing officer services and avoiding funding inequities experienced in the past. These recommendations could be effectuated without any rule or legislative changes, other than those contained in subsequent General Appropriations Acts.

RECOMMENDATIONS:

1. It is recommended that the Division continue to track hours scheduled by agency and provide the Legislature and Executive Office of the Governor with final reports on December 1 of each year. Interim reports should also be submitted to track agency activity and assist with development of DOAH's Legislative Budget Request (LBR) and legislative appropriations.
2. To fund 100 percent of the Division's FY 1991-93 LBR, it is recommended that the Legislature appropriate transfers to DOAH from all state agencies and governmental entities using the Division's services. These transfers should be based on the utilization rates provided in the LBR (see summary below).

SUMMARY

The Division prepared its Final FY 1991-93 LBR in accordance with interim report #4 dated October 25, 1990 (Attachment A) and the above recommendations. Based on the percentages contained in Attachment A, the Division's total LBR was apportioned among all agencies, and a fund shift from the General Revenue Fund to the Administrative Trust Fund was calculated. This shift resulted in funding 100 percent of DOAH's request from its Administrative Trust Fund. A copy of the budget issue detailing the apportionment is attached (see Attachment C).
