EXECUTIVE DIRECTOR'S MESSAGE

December 31, 2003

Since 1944, the State of Florida has recognized the need for a state government entity to ensure that Florida's military veterans have maximum access to benefits guaranteed by federal law. In 1988, the citizenry of Florida favorably endorsed a constitutional amendment to create the Florida Department of Veterans' Affairs (FDVA) with the charter to provide advocacy and representation for Florida's veterans in their dealings with the U. S. Department of Veterans' Affairs (USDVA).

It is useful to reflect on *why* Florida has an agency to advocate for veterans. *There are two fundamental reasons:* The first has to do with the public policy of honoring veterans whose contributions over the years have guaranteed the freedoms we all enjoy in our nation today. The other is business based in that such advocacy appropriately serves the State's financial interests.

Honoring Veterans

Dating back to colonial times, America has maintained a commitment to address and resolve the needs of citizens who have served in its Armed Forces. In order to encourage enlistments and keep morale up and the number of deserters down, the Continental Congress, by means of a resolution passed on August 26, 1776, promised pensions to soldiers and officers who were disabled during the course of service.

From relatively meager beginnings, this Nation's present day commitment to veterans now exceeds \$64 billion dollars annually. Almost 1.9 million veterans now call Florida home. Honoring these citizens is reflected in FDVA plans, programs, and budgets, and is intended to be highly visible to convey the message that all of Florida values their national service.

Florida Department of Veterans' Affairs Value Added and Cost Avoidance

Every time the federal government funds a service required by a Florida resident, the State of Florida has avoided having to make that same or a similar expenditure. Such "cost avoidance strategy" is at the heart of much of the FDVA advocacy in support of Florida's veterans and their access to USDVA benefits.

The "business" of veterans' affairs has evolved into a major industry in the United States. Within the context of access to a proportionate share of federal resources, Florida is particularly well positioned among states to justify veteran resource needs given its large and aging veteran population. Currently the state with the second largest veteran population, Florida is projected to have the largest veteran population before 2020.

The FDVA has developed programs to recognize this rapid increase in the general and aging veteran population. One of the residual effects of innovated programs and increasing services to meet veteran needs is the growth of contracts and outsourcing in the public sector. This has resulted in the FDVA's meeting many of the Governor's Priorities such as in Priority #4 – "Create a Business Climate That is Conducive to Economic Opportunity".

The business of Veterans' affairs is one of the economic engines of Florida's economy.

Direct infusion of over \$7 Billion into Florida's economy for veterans from the federal government:

- \$3.42 Billion in military retirement pay.
- \$1.9 Billion in direct payment for USDVA Compensation and Pension.
- \$1.5 Billion in medical care and vocational rehabilitation.
- \$140 Million in education benefits.
- \$22.8 Million in construction funding.

Payments and expenditures represent:

- Direct payments to individuals.
- Additional spending power for Florida families.
- Contracts for construction and for outsourcing to non-government organizations.

Veterans do not present a distinct appearance:

- Blend into the general population, difficult to isolate their spending habits and traits.
- They cross lines of race, gender and age.
- Represent a distinct group in their ethic of work and sacrifice.
- Expect economic opportunity for their family and are willing to work to achieve it.

Long-term health care is a vital concern for an aging veteran population. There are over 805,033 veterans in Florida over the age of 65 and 69,110 veterans over the age of 85 with a projected increase of age 85+ veterans to 129,152 by September 2010. For over ten years, Florida has participated in the State Veterans Nursing Home Program offered by the USDVA. This program is a benefit to the State as it enables cost avoidance for the Medicaid program. The majority of our nursing home residents do not rely on Medicaid funding to pay for their care. Instead federal per diem payments are received, and many veterans also qualify for an additional 'Aid and Attendance' allowance. This results in estimated cost avoidance to the state Medicaid program of \$4,570,000 annually.

This Annual Report summarizes the major areas of service to veterans that the Department currently provides. It highlights the assistance given in helping veterans gain access to earned benefits; it summarizes the operations of five, soon to be six, long-term healthcare facilities providing both Domiciliary and Nursing Home services for eligible veterans; and it relates other successes that the Department has achieved during this year.

The Department will continue the pursuit all available federal resources in order to minimize Florida's expenditures for services that might otherwise be funded by the state government. We will strive to maximize the Federal benefits due Florida's veterans. Finally, we will continue to enhance outreach efforts to ensure that the contributions veterans have made to the nation are recognized, and that veterans know about the entitlements they have earned by virtue of their military service to our Nation.

IV. DIVISIONS OF THE DEPARTMENT OF VETERANS' AFFAIRS

<u>DIVISION OF BENEFITS AND</u> ASSISTANCE

The Division of Benefits and Assistance provides professional assistance to Florida's veterans and their dependents in their efforts to obtain benefits and treatment from the USDVA. The Division is comprised of a Division Director and support staff and three bureaus: Bureau of Claims Services, Bureau of Field Services, and the Bureau of State Approving for Veterans' Training.

Bureau of Veterans' Claims Services: The Bureau of Claims Services provides counseling and assistance to veterans, their dependents, and survivors with the preparation, submission and prosecution of claims and appeals for state and federal entitlements as well as applications to correct military records.

The Bureau's primary responsibility is to work directly with the decision resources in the USDVA Regional Office to expedite client's claims and to influence through proactive advocacy, the most positive outcome. To this end, Veterans' Claims Services provides a quality control function by reviewing completed USDVA benefits rating decisions and paralegal due process assistance in the prosecution of veterans' disagreements with and appeals of USDVA rating decisions and debt identification/relief.

The prosecution of veterans' disagreements with and appeals of USDVA rating decisions results in retroactive benefits and compensation and debt relief to veterans. The dollar amounts awarded to veterans, their dependents and survivors are tracked as a performance measure of successful client's claim resolution.

^{*} Adjusted retroactive compensation is based on the delay of the reporting of awarded claims for service connected disabilities and pensions by the USDVA. Pensions for Florida veterans are now processed in Philadelphia, PA and are not physically reviewed by the FDVA when initially approved or disapproved. Large dollar amounts of retroactive compensation (over \$50,000) requires multiple levels of agency review and audit within the USDVA. Credit for the work completed is captured in the FDVA V-Bolts data base only when the USDVA grants final approval of the rating decision and makes payment to the veteran.

Bureau of Veterans' Field Services:

Field Services provides benefits counseling services to all inpatients and outpatients in the 15 USDVA medical facilities in Florida, the State Veterans' Homes, and the outreach activities for FDVA throughout the state to include supporting the Transitional Assistance Program at military installations. The Bureau's primary responsibility is to help veterans to initiate, develop, submit, and prosecute claims and appeals for state and federal entitlements.

The focus of Field Services is face-to-face with the client/ customer and the resolution of any number of issues related to the submission of claims to the USDVA.

The Bureau of Field Services also provides invaluable advocacy assistance to all veterans who utilize the U. S. Department of Veterans Affairs Medical Facilities by interacting with medical staff to resolve eligibility, access, billing issues, prosthetic problems, etc. This is done on a daily basis at all USDVA medical facilities.

Bureau of State Approving for Veterans'
Training (SAA): SAA is charged under the provisions of Title 38, United States Code and the federal contract entered into between the Florida Department of Veterans' Affairs and the USDVA, and governed by the Florida Statute 295.124. The Bureau reviews, evaluates and approves programs of education (secondary

and post secondary, public and private) training, and conducts annual on-site supervisory visits to approved educational institutions to determine continued compliance with appropriate state and federal laws and regulations so that Florida's veterans may avail themselves of federal veteran's educational programs.

STATE VETERANS' HOMES PROGRAM

The Program Director for State Veterans' Homes is responsible for the overall efficient operation of the State Veterans' Domiciliary Home, and the five State Veterans' Nursing Homes. In addition, the Program Director directs the grant application, design and construction processes for new and planned future homes. Two new State Veteran's Nursing Homes were constructed during this Fiscal Year. Detailed individual facility Annual Reports are included as appendices.

The information contained in this section includes additional data on revenue and expenses and the fiscal status of the

Operational and Maintenance Trust Fund. Summary remarks regarding occupancy, fiscal status, and quality of care follow.

State Veterans' Homes Occupancy Rates:

Concerted efforts to increase census, and the increases at Pembroke Pines, combined to show **an increase of 12% in overall** occupancy compared to the previous fiscal of FY 2001-2002: up to 83% from 71.5%. This trend is expected to continue into next fiscal year as we strive to achieve 90% occupancy goals at each facility. The Springfield and Port Charlotte, Florida facilities were not in operation in fiscal year 2002-2003.

Revenues/Expenses: Annual revenues were \$1,197,087 more than expenses. Revenues were up over the last year by \$4.8 million. This was due to an increase in revenues at the Pembroke Pines facility and the construction of the two new facilities.

The current O & M TF cash flow has improved and the Department is currently operating with a small positive balance. Internal management actions to improve the long-term outlook continue to be implemented and will achieve substantial savings once fully implemented. FDVA accounts payable are within the prescribed state guidelines. This trust fund is

projected to continue to operate with a positive cash flow next year.

One of the larger factors affecting expenses is Temporary Agency Staffing costs. It is difficult to recruit and retain nurses at current state pay rates. This past legislative session FDVA obtained proviso authority to submit a proposal to the Executive Office of the Governor and the Legislative Appropriations Committees regarding this issue. The proposal will review nursing staff rate increases as well as other options intended to aid in recruitment and retention of nursing staff. The department is working diligently to decrease the costs expended for Temporary Agency Staff.

VETERANS' PREFERENCE. Chapter 295, Florida Statutes, sets forth certain requirements for public sector employers to accord preferences in appointment, retention and promotion, to certain veterans and spouses of veterans. The relevant portions of the law apply to "the state and its political subdivisions", Section 295.07 and Section 295.09, Florida Statutes. Public utilities, state universities, school districts and special taxing districts are subject to the requirements of Chapter 295. Section 295.11 Florida Statutes, tasks the FDVA, upon the written request of any eligible person, to investigate complaints filed with the FDVA alleging violation of veterans' preference rights. FDVA reviews each case and issues an opinion to the Public Employees Relations Commission as to the merit or lack of merit of each case. Veterans' Preference statistics are provided in the table below.

The 2003 Florida Legislature has passed significant changes to the laws concerning veterans' preference. Governor Bush signed the bill and the changes became effective


May 23, 2003. The changes align Florida veterans' preference law with federal statutes and include:

- Adds new preference eligibility for veterans who served in a campaign or expedition for which a campaign badge has been authorized by the Department of Defense.
- Excludes active duty for training from the criteria for eligibility for veterans' appointment and retention preference.
- Amended the definition of wartime service to provide an ending date to the Persian Gulf War. The ending date for the Persian Gulf War is January 2, 1992.

INFORMATION TECHNOLOGY

The CIO and a small Information Technology staff provide technical support to the department's divisions and assist them by seeking enabling technologies to support vital business processes.

These activities support the operations of the department's wide area network and telephone systems, access to the State's legacy computer applications (i.e., FLAIR, SPURS, COPES, LAS/PBS, etc.) via the State's metropolitan area network, information security policy, procedures and certification, annual Enterprise Resource Planning Reporting, and review of computer systems training.

The IT responsibilities require close coordination with the State Technology Office, the State's Technology Review Workgroup, the State's CIO Council and all FDVA divisions, programs and bureaus.

APPENDIX I

ACTIONS TAKEN BY THE DEPARTMENT RELEVANT TO ss 292.05(4), (5), & (7), FLORIDA STATUTES

ss 292.05(4). The Department may apply for and accept funds, grants, gifts, and services from the state, the United States Government or any of its agencies, or any other public or private source and may use funds derived from these sources to defray clerical and administrative costs as may be necessary for carrying out its duties

State Approving Agency for Veterans' Training.

FDVA maintains a contract with the USDVA to provide for State Approving Agency for Veterans' Training. Costs are 100% reimbursed by the USDVA and include coverage of clerical and administrative expenses of the Department.

<u>Veterans' Nursing and Domiciliary</u> Homes.

The Veterans' Domiciliary and Nursing Homes of Florida operated by this Department apply for and receive federal funds from the USDVA. These funds cover more than 21 percent of the cost of operating the homes, including administrative costs.

- ss 292.05(5). The Department shall conduct an ongoing study on the problems and needs of those residents of this state who are veterans of the Armed Forces of the United States and the problems and needs of their dependents. The study shall include but not be limited to:
- (a) A survey of existing state and federal programs available for such persons that specifies the extent to which such programs presently are being implemented, with recommendations for the improved implementation,

- extension, or improvement of such programs.
- (b) A survey of the needs of such persons in the areas of social services, health care, education, and employment, and any other areas of determined need, with recommendations regarding federal, state, and community services that would meet those needs.
- (c) A survey of federal, state, public, and private moneys available that could be used to defray the costs of state or community services needed for such persons.

Continuous efforts include feedback through counseling thousands of veterans, training critiques, participation on numerous governmental committees concerned with veterans, regular meetings with veterans' organizations and their leadership, and analysis of official USDVA data and reports. In 1999, FDVA commissioned a survey that was conducted by Florida State University. The results of the survey have been posted on the FDVA web site and are being incorporated into the long range planning process. A follow-on survey has been scheduled for the 2003-04 fiscal year.

A survey of existing State and Federal programs available to veterans and their dependents and a survey of Federal, State, Public, and Private monies available has been completed previously. A comprehensive list by Federal, State, County, Public and Private agency resources are available for reference.

<u>ss 292.05(7)</u>. The Department shall administer this chapter and shall have the authority and responsibility to apply for

and administer any federal programs and develop and coordinate such state programs as may be beneficial to the particular interests of the veterans of this state.

State Approving for Veterans' Training.

Under the provisions of Title 38 United States Code (USC), and the contract maintained between the FDVA and the USDVA, State Approving for Veterans' Training is charged with inspecting, approving, and supervising programs and courses offered by accredited and nonaccredited institutions (public and private). A list of such educational institutions, and specific courses which it has approved, is furnished to the USDVA Regional Office at Bay Pines so that eligible veterans or other eligible persons enrolled in such courses may receive veterans' benefits to which they are entitled. Federal benefits and entitlements for veterans are contained in Title 38 U.S.C.

State Veterans' Home Program.

The Department operates the Veterans' Domiciliary Home of Florida in Lake City, and the Veterans' Nursing Homes in Daytona Beach, and Land O' Lakes, Pembroke Pines and Springfield. The Springfield facility was completed this year and started receiving residents in October 2003.

Construction has been completed on the newest facility in Port Charlotte. With the approved funding for final staffing and start-up the facility will open for residents in January 2004.

The homes' receive federal funds that provide approximately 21 percent of the cost of operations. The Veterans' Homes of Florida Annual Reports are included in this report as Appendix VII, VIII, IX and X.

Florida's veteran population continues to age. Based on the 2000 Census there are over 805,033 veterans in Florida over the

age of 65 and 69,110 veterans over the age of 85 with a projected increase of 85+ veterans to 129,152 by September 2010. Long-term health care is a vital concern for our aging veteran population, as well as the general population. For over ten years, Florida has participated in the State Veterans' Nursing Home program offered by the USDVA and we continue to do so. This program is a benefit to the State as it enables cost avoidance for the Medicaid program. The majority of our nursing home residents do not rely on Medicaid funding to pay for their care. Instead federal per diem payments are received. This results in estimated cost avoidance to the state Medicaid program of \$4,570,000 annually.

With the start up of Springfield and Port Charlotte facilities FDVA will bring the total number of beds in the Florida State Homes Program to 750, of which 600 will be in nursing homes. According to Florida's Agency for Health Care Administration, Florida has 29.1 nursing home beds per 1,000 seniors in the general population. According to USDVA estimates, even after the build-out of nursing homes in Bay and Charlotte counties, Florida stills offer less than 1 bed per 1,000 veterans and the State will still be in " need" of additional beds.

FDVA continues to evaluate the trends and conditions that the 2000 census data reveals. Adjustments to FDVA's long-range plans will be made to better meet the needs of Florida's veteran population. Preliminary plans are being drafted to begin an additional phase of the State Homes program in 2005-2010. The Federal Grant pre-application for five additional homes has been submitted and Florida's additional requirements are now listed in USDVA planning for this program.

The new phase of additional State Veterans' Nursing Homes are subject to approval and funding by the Governor and the legislature.


