

#### Definition of a Minority-, Woman-, Service-Disabled Veteran and/or Veteran Owned Business

To become certified as a minority-, woman-, service-disabled veteran and/or veteran-owned business enterprise in Florida1, a business must be:

- Engaged in commercial transactions
- Domiciled in Florida
- A minimum of 51 percent owned, managed, and controlled by an African-American, Hispanic
  American, Asian American, Native American, woman or service-disabled veteran who is a permanent
  resident of Florida and a United States citizen; and
- A small business that is independently owned and operated, with a net worth of no more than \$5
  million and that employs less than 200 full-time permanent employees, or is recognized as a certified
  business by the federal governmentt

#### Certification benefits include:

- First-tier referrals to state agencies for order and contract opportunities
- Mentor-Protégé opportunities for business development guidance from established corporations
- Exclusive listing of state-certified minority business enterprises in an online directory
- Participation at regional workshops, seminars, and corporate roundtables
- Workshops to help grow business
- Loan mobilization to assist eligible businesses with funding

#### **Agency Compliance**

Section 287.09451 (4) (0) 2,Florida Statutes, annually requires all state agencies and universities to submit Business Utilization Plans to the Office of Supplier Diversity. Each plan must include the organization's strategy for ensuring diversity in the organization's purchasing and contracting opportunities, as well as the previous fiscal year's spending with minority-, women-, and service-disabled veteran-owned business enterprises. Plans must also include a statement and assessment of good faith efforts taken by each state agency and a status report of agency compliance with subsection (6), as determined by the Minority Business Enterprise Office.


#### Businesses Certified During Fiscal Year 2012-13

During fiscal year 2012-13, the Office of Supplier Diversity (OSD) certified 407 new minority-, woman-, and service-disabled veteran and veteran owned business enterprises statewide. The breakdown of new certifications is as follows:

- 165 were Caucasian woman-owned business enterprises
- 96 were Hispanic American-owned business enterprises
- 63 were African-American-owned business enterprises
- 18 were Asian American-owned business enterprises
- 57 were Service-Disabled Veteran-owned business enterprises (SDVBE)
- 8 were Native American-owned business enterprises

Note: Ethnic business enterprises and service-disabled veteran businesses include men and women




- 644 were Caucasian woman-owned business enterprises



# Fiscal Year 2012-13 Total Agency Expenditures by Industry

In fiscal year 2012-13, the total state government expenditures for commodities, construction, contractual services and architects and engineers surpassed \$73.2 billion. Of these amounts

- 1 percent was architect and engineering related services
- 10 percent were construction related purchases
- 12 percent were contract related services, and
- 77 percent were for commodities purchases
