EXECUTIVE SUMMARY

The FY 2012-2013 Annual Report and Long Range Plan for the Division of Medical Quality Assurance (MQA), as required by section 456.026, *Florida Statutes (F.S.)*, presents the division's Long Range Plan, performance data and statistics related to the regulation of health care practitioners and facilities established in section 20.43(3)(g), *F.S.* This report also details the revenues, expenditures, and cash balances for FY 2012-2013, and a review of the adequacy of existing fees.

MQA's continuous improvement efforts have resulted in sustained improvement in several areas during FY 2012-2013:

- MQA regulated 1,091,306 health care practitioners, a 3 percent increase from 1,059,958 health care practitioners regulated in FY 2011-2012 (Table 1).
- MQA regulated 25,286 establishments, a 6 percent increase from 23,809 establishments regulated in FY 2011-2012 (Table 2).
- MQA issued 515 emergency actions, a 37 percent increase from 376 emergency actions issued in FY 2011-2012 (Table 7).
- MQA completed 30,299 inspections and 5,407 investigations, an increase of 25 percent and 2
 percent respectively from 24,169 inspections and 5,294 investigations completed in FY 20112012 (Table 8).
- The average cost per licensee was \$54.57, compared to \$59.46 in FY 2011-2012, an 8 percent decrease (Table 17).
- 26 out of 34 (76 percent) of boards, councils, and professions had sufficient renewal fees, compared to 25 out of 34 (73 percent) in FY 2011-2012 (Table 17).
- The Prosecution Services Unit reduced its year old case inventory to 874 cases, an 8 percent decrease from 946 cases in FY 2011-2012 (Page 6).

- They are responsive. Upon recognizing the sacrifices made by Florida's veterans and the importance of assisting them as they reintegrate themselves into civilian life, our MQA team waived licensure fees for veterans for up to 24 months after honorable discharge.
- Lastly, they promote excellence, working hard to remind Floridians everywhere that they should settle for no less from their health care practicioners.

As a former trauma surgeon, medical director and now as State Surgeon General and Secretary of Health in Florida, I am wholeheartedly committed to improving the health of Florida's people. MESSAGE FROM THE DIVISION DIRECTOR



It is my pleasure to present MQA's 2012-13 Annual Report and Long-Range Plan. This was a memorable year in which we focused on our strategic priority of cost-effective regulation while meeting the challenge of a health crisis that made national headlines.

A national outbreak of fungal meningitis associated with sterile products compounded by a Massachusetts pharmacy impacted Florida residents. This outbreak required an immediate and decisive response by the Department and Division. Our Division played an integral part in the public health response, notifying patients and medical providers of the recalled products. The Department remains committed to ensuring that all medications in Florida are safe, including compounded products.

While responding to new challenges, we remained focused on our strategic priority of cost-effective regulation. The results reflect innovative thinking and collaboration with our internal and external stakeholders and partners.

We are proud to announce another reduction in the overall average cost of regulation for the 2012-2013 fiscal year. Beginning in FY 2006-2007, the average cost per license to regulate was \$72.02. Each year the cost has decreased and at the end of FY 2012-2013, the average cost per license to regulate was \$54.57, a 24 percent reduction since FY 2006-2007. A number of cost savings strategies have achieved this result. One example is the expansion of online services to include initial applications.

MQA offers the ability to apply online for initial licensure of 60 health care license types. In FY 2011-2012, 63 percent of the applications available online were received online, representing a 72 percent reduction in application intake costs. In FY 2012-2013, 70 percent of the applications received were received online, representing a 75 percent reduction in application intake costs. The total savings over the two fiscal years is \$587.590.

With data-driven decision making and continuous process improvement, MQA is able to license and regulate more licensees with fewer resources. Since FY 2009-2010, the licensee pool has increased by 12.42 percent with the total number of FTEs reduced by 1.56 percent. This has increased the average number of licensees per FTE by 14.20 percent. These improvements have translated into 17 professions reducing 56 fee types since FY 2008-2009.

During the next several years, the Division is in a unique position to help the Department achieve its vision of being the Healthiest State in the nation. Daily, our licensees touch the health care consumers of Florida, and numerous opportunities exist to spread our message of healthy lifestyle and healthy weight. Let's do all we can as a Division to help the Department and Floridians see this vision come to light.

REDUCTION OF YEAR OLD CASES

Section 456.026, F.S., requires the MQA Annual Report and Long Range Plan to contain a description of the strategies and results of the efforts to reduce or otherwise close any investigation or disciplinary proceeding not before the Division of Administrative Hearing (DOAH) under Ch or otherwise not completed within one year after the initial filing of a complaint pursuant to section 456.026(8), F.S.

The Prosecution Services Unit (PSU) established the reduction of open cases that either were not before DOAH or had not been completed within one year of their initial filing as one of its top priorities for FY 2012-2013. Addressing disciplinary matters in a timely manner is a fair and just way of ensuring that the Department protects the public and serves Florida's licensees.

The strategies adopted by PSU to address these cases included:

- Compile a comprehensive and accurate case list of all cases for the twenty-eight Boards and Councils that the Department regulates that had a case number of 2010 or older and focus legal resources on the oldest first.
- Identify the cases that had not been presented to the probable cause panel and prepare them for probable cause with a recommendation that the case be prosecuted or closed.
- For cases that had been presented to the probable cause panel, focus on resolving them either with a Settlement Agreement or with a referral to DOAH for the scheduling of a hearing.
- Communicate the year-old case goals to each Board and seek assistance in resolving the cases. If necessary, request special or additional probable cause panel meetings to address older cases.
- With customized management reports for each team leader, closely monitor the progress being made toward achieving the goal and set benchmarks throughout the year to ensure success.

At the end of FY 2011-2012, PSU had 946 cases that were over one year old. At the end of FY 2012-2013, PSU had 874 cases that were over one year old, an 8 percent reduction.

PSU's plan for FY 2013-2014 is to continue to prioritize the resolution of older cases. PSU has established performance expectations for all prosecutors to resolve older cases. PSU has also increased the number of cases it refers to DOAH. This will help resolve cases that cannot be resolved through settlement, and encourage settlement of more cases.


