



As Surgeon General and Secretary, it gives me great pleasure to join the Division of Medical Quality Assurance (MQA) in presenting this *Annual Report and Long-range Plan Fiscal Year 2015-2016*.

This year the Department is celebrating the honor of receiving first-in-the-nation national accreditation as an integrated department of health through the Public Health Accreditation Board. This is a testament to the Department's ability to keep communities ahead of emerging health threats and signifies that the state health office and all 67 county health departments meet or exceed national standards based on the 10 essential public health services.

Public health plays a crucial role in the growth of our state and ensuring access to quality health care is fundamental in this process. MQA, as the liaison between the public, health care professionals and their boards and councils, ensures the Department effectively and efficiently regulates health care professions in order to achieve the Department's mission of promoting and protecting the health and safety of all people in Florida.

In order to attract, retain and better meet the needs of Florida's health care work force, MQA launched a new and improved Online Services Portal this year that provides access to updated features while making it easier to navigate the licensure and renewal process. Since its rollout, the new online system has resulted in substantial time savings for both licensees and applicants. In addition, new laws currently under implementation for the 2016-2017 fiscal year will result in more efficiencies, which will expedite the licensure and application process. In March, the Division of Disease Control and Health Protection needed MQA's assistance to reach a select group of health care professionals for Zika virus guidance regarding donor screening, deferral and product management to reduce virus transmission. Within hours, MQA provided this emerging health threat information to 294,000 health care professionals. Timely, effective and continuous communications are paramount to protecting Florida residents and visitors' health.

The Department is currently leading efforts to update our State Health Improvement Plan (SHIP) with many other state agencies and community organiziations. Moving forward, MQA will remain focused on process improvements and continue its dedication to educating the public. I applaud the dedicated MQA staff and all that they accomplished this year. I am confident MQA will continue its stellar performance, and working together with our boards, professional societies, and many other partners we will continue to experience great success as a state.

This fiscal year we remained focused on our strategic priority of regulatory efficiency and our successes are a direct result of innovative thinking and rigorous collaboration with our internal and external stakeholders and partners. We streamlined processes to provide the quality service our licensees and health care consumers deserve and expect.

Last October, MQA launched its new and improved Online Services Portal to better meet the needs of over one million licensed health care professionals and applicants in Florida. The new user-driven layout provides access to many updated features, providing licensees and applicants with increased functionality to manage and maintain their personal user accounts. We will also continue our Are You Renewal Ready? and medical education campaign, which prepares licensees to use an online tracking system to track continuing education credits for license renewal.

MQA also offers several licensure support services to qualified military families. One of many services offered is the Florida Veterans Application for Licensure Online Response (VALOR) system, which provides an expedited licensing process for honorably discharged veterans with an active license in another state. Military veterans who apply through the VALOR system are granted a waiver for most licensing fees. Since the beginning of the 2014 fiscal year, veterans who used the VALOR system saved more than \$80,000 in licensure fees, and we are committed to increasing this number in the coming years. This year, the legislature also passed House Bill 941, which extends the eligibility of the VALOR program to spouses of active duty service members practicing in most MQA regulated health care professions.

Ensuring the safety of the public remains a top priority and through the dedication of staff, MQA has seen significant improvements in several key areas. The number of unlicensed activity investigations completed increased nearly 60 percent from 901 (2014-2015 fiscal year) to 1,430 (2015-2016 fiscal year). The number of days to resolve these complaints decreased by 26 percent during the same period.

In addition, MQA is committed to helping licensees get to work at a lower cost, faster. This fiscal year, MQA saw improvements in these areas as the average days to issue an initial license for a qualified applicant decreased by eight percent, while the average days to renew a license for a qualified applicant decreased by 48 percent. In addition, the average number of days to complete an opening pharmacy inspection has improved by 30 percent.

Over the next several years, MQA is in a unique position to improve upon these successes and help the Department achieve its mission of protecting, promoting and improving the health of all people in Florida through integrated state, county and community efforts.

EXECUTIVE SUMMARY

The Division of Medical Quality Assurance (MQA) is dedicated to the mission of the Florida Department of Health to protect, promote and improve the health of all people in Florida through integrated state, county and community efforts. Working in conjunction with 22 boards and six councils, MQA licenses and regulates seven types of health care facilities and more than 200 license types in over 40 professions. The 2015-2016 Annual Report for MQA, as required by section 456.026, Florida Statutes, contains the division's long-range plan and performance data and statistics related to the regulation of health care practitioners and facilities established in section 20.43(3) (g), Florida Statutes. Additionally, this report includes financial information relating to the division's revenues, expenditures, cash balances and adequacy of existing fees for the 2015-2016 fiscal year. The information provided in this report is organized around MQA's three key processes of licensure, enforcement and information, with an emphasis on performance-driven results.

In the area of licensure, MQA is consistently focused on improving our business processes to meet the demands of a growing health care industry. During the 2015-2016 fiscal year, the division issued 100,244 initial health care profession licenses which is a three percent increase from the number of initial licensees issued during the previous fiscal year. In order to best serve Florida's 1.2 million health care professionals, the division recently launched the new and improved Online Services Portal. This portal provides a new, user-friendly system that allows health care licensees and applicants to have more control over their licenses and applications. Currently, over 94 percent of health care practitioners are renewing their licenses online.

The Department is committed to making Florida a welcoming place to live and work for our armed forces and their families. Effective July 1, 2016, the Veterans Application for Licensure Online Response (VALOR) program for expedited licensing and fee waivers was expanded to a broader group of qualified military veterans and spouses of active duty service members for most health care professions. During the 2015-2016 fiscal year, 126 military veterans were licensed through VALOR and anticipates an increased number of licenses the next fiscal year. The Department has strengthened its investigative and enforcement efforts to ensure the safety of Florida's residents and visitors. During the 2015-2016 fiscal year, MQA investigators followed up on 20,772 complaints filed against licensees and the Department issued 267 emergency orders restricting and/or suspending licenses of health care practitioners for serious violations that posed an immediate and serious threat to the general public.

The Department's Unlicensed Activity (ULA) program is dedicated to protecting Florida's residents and visitors from the potentially serious and dangerous consequences of receiving health care services from an unlicensed person. The ULA unit works in conjunction with law enforcement and the state attorney's offices to prosecute individuals practicing without a license and actively provides education and outreach to stakeholders with a vested interest in protecting the public. During the 2015-2016 fiscal year, ULA investigators looked into 1,430 tips regarding unlicensed activity and issued 628 cease and desist notices, a 58 percent increase from the previous fiscal year.

In the area of information, MQA tracked, monitored and responded to 5,433 public record requests and 281 media requests. Through its commitment to providing excellent customer service, MQA's Customer Call Center received and responded to 536,983 requests. Additionally, customers have the option to provide feedback through the Online Customer Service System.

Unhealthy weight remains one of the top health threats and MQA remains committed to helping achieve the Department's goal to be the healthiest state in the nation. The division, through its board and councils, continued to facilitate conversations about healthy weight between health care practitioners and the general public. This fiscal year MQA accounted for a total of 85 Healthiest Weight related events and reached more than 8,600 people. Events included 5K fun runs, board and liaison meetings, a sponsored bike ride and public outreach. The Bureau of Enforcement also launched a challenge called "Spring into Action" to encourage staff to stay active and healthy.

The division is constantly reviewing the adequacy of the MQA trust fund. During the past year, the MQA trust fund maintained a sufficient cash balance, as recurring revenues are adequate to cover existing recurring expenditures. MQA is committed to ensuring administrative costs foster a healthy and successful business environment for the health care industry in the state of Florida.

STRUCTURE OF MQA

BOARDS

Boards are responsible for approving or denying licensure applicants, reviewing and approving continuing education courses and providers, promulgating administrative rules authorized by statute, determining probable cause, and disciplining licensees found to be in violation of applicable laws. MQA supports the Governor's appointment of qualified representatives and appropriate people to serve on 22 regulatory boards comprising 180 professional and lay persons.

Section 456.005, Florida Statutes, requires MQA to develop and implement a long-range plan. This plan serves as a road map for accomplishing our mission. It is an active plan, and must be revised and modified to remain current with trends in health care services and regulation. In an effort to stay current with the trends in health care services and regulation. MQA management met with the boards and councils on September 24, 2015 to discuss the plan for 2016-2018.



PROCESSING AGED INVENTORY

The Prosecution Services Unit (PSU) is responsible for the review, recommendation for action, and prosecution of alleged violations by licensees of the practice acts within the jurisdiction of MQA. PSU identified action steps necessary to its processes that will reduce or otherwise close these investigation or disciplinary proceedings. Currently, MQA has approximately 1,901 investigation or disciplinary proceedings that were not brought before the Division of Administrative Hearings under Chapter 120, Florida Statutes, or otherwise not completed within one year after the initial filing of a complaint.

Before PSU could take the first step to identify which cases met the criteria for inclusion in the reduction plan, PSU met with MQA's Bureau of Operations and Bureau of Enforcement to design new reports for gathering the necessary data. Once the reports were available, analysis of the cases and creation of a plan began.

Plans for reduction of year old cases in the boards with the greatest increases include determination of the minimum number of aging cases required to be presented to Probable Cause Panels (PCP) over the course of the year. With the cooperation of the boards and panel members, more frequent PCP meetings are being scheduled to handle the higher volume of cases. Additional actions are also planned.

As an example of one plan of action, PSU established a Focused Year-and-Older Action Team to be solely responsible for aging cases review, case triage and taking action to process cases.

Areas identified as requiring process improvement include monitoring for:

- pending/overdue/returned supplemental investigations;
- status changes in the MQA database;
- confirmation of service (i.e., hand service, publication, etc.);
- · follow up on settlement offers; and/or
- cases that can be presented to the board (i.e., waivers, Election of Rights (EOR) returned but not logged, etc.).

DIVISION OF ADMINISTRATIVE HEARINGS REFERRALS

Another delay in processing year and older cases can occur when the respondent requests a formal hearing. In support of its commitment to referring cases to the Division of Administrative Hearings (DOAH) when it becomes apparent a case cannot or will not be settled, PSU implemented a Litigation Action Team. The action team is tasked with prioritizing the cases and being the lead attorneys in litigation.

This will increase efficiency by:

- allowing a core of attorneys to focus on drafting Administrative Complaints, Closing Orders and Letters of Guidance, thereby increasing production of PCP/Board ready cases;
- · allowing DOAH cases to be processed faster; and,
- possibly yielding higher settlement rates for Post-PCP cases.

PSU is aware that for this plan to be successful, it will need to keep up with the current caseload while also processing the year and older cases. Since the 2014-2015 fiscal year, PSU is committed to utilizing attorneys across teams and sections to assist in prosecuting cases. Section 456.079, Florida Statutes, requires the MQA Annual Report and Long-range Plan to contain a status update on development and implementation of rules providing for disciplinary guidelines.

With the economy on the rise, Florida has become the perfect climate for families and businesses alike to grow. To help sustain this growth, the Florida Department of Health has made a concerted effort to reduce regulation and eliminate unnecessary barriers to licensure. Since 2010, Florida's health care population has increased by 16.7 percent. To ensure every practitioner has the necessary education and experience to obtain a license, the Division of Medical Quality Assurance (MQA) developed a robust licensure process which thoroughly reviews applications. Florida was also one of the first states to include background screenings in its credentialing process. MQA is committed to getting practitioners to work and since last fiscal year, the average time to issue an initial license has decreased by 8.82 percent.

MQA licenses more than 1.2 million health care practitioners and health care facilities and, on average, renews over 400,000 licenses per year. Most health care licensees and facilities are required to renew their license every two years in order to maintain the right to practice, while some professions require annual licensure renewal. To facilitate an efficient and effective renewal process, MQA encourages licensees to renew their license online. This fiscal year, nearly 95 percent of licensees utilized the online renewal system.

The Department has a specific unit within the Prosecution Services Unit dedicated to reviewing all cases in which a licensee may pose an immediate danger to the health or safety of the public. In the event that a health care provider poses an immediate danger to themselves or the public, the Department has the authority to restrict or suspend a health care license through an emergency order. During the 2015-2016 fiscal year, the Department issued 267 emergency orders for serious violations posing a danger to patients and the public.

One of MQA's core business functions is ensuring the safety of the citizens and visitors of Florida through the enforcement of the regulatory laws and rules for health care practitioners. MQA has a team dedicated to receiving, reviewing and investigating consumer complaints made against a health care provider. All complaints received by the Department are treated equally and reviewed thoroughly. MQA investigators followed up on thousands of complaints against licensed health care providers and completed 5,792 investigations this fiscal year. In addition, the average number of days to complete an inspection for a new pharmacy decreased by nearly 30 percent.

The number of Florida's health care practitioners continues to rise. To ensure the safety of Florida's residents and visitors, the Department is increasing its investigative and enforcement efforts. As a result, MQA is able to provide better and increased evidence in each case. Each board or council has a designated panel to determine if there is probable cause or sufficient evidence to bring formal charges against a licensee. This fiscal year probable cause was found in over 1,700 cases. Furthermore, the number of cases presented to the Probable Cause Panels increased by 10 percent.

From educating the public, to conducting complex investigations and issuing cease and desist orders, the Department's Unlicensed Activity (ULA) program is dedicated to protecting the people of Florida, and remaining at the forefront of health care regulation. Working in Tallahassee and 11 field offices throughout the state, the ULA program investigates all unlicensed health care activity complaints and has long-standing partnerships with law enforcement and state attorney offices to prosecute individuals practicing without a license. This fiscal year saw a 35 percent increase in complaints received and a nearly 75 percent increase in investigations referred to law enforcement for further prosecution, indicating a trend of continuous quality improvement in the enforcement of ULA cases.
