### Inmate Escape Report Fiscal Year 2019-20

This report is provided in accordance with Florida Statute 944.151 (7). The data provides information for Fiscal Year 2019-20 in reference to attempted escapes, escapes and recaptures from Florida's correctional facilities. This report summarizes the following:

- Attempted escapes;
- Escapes by level, facility type, and facility type by region;
- Recaptures, recaptures within quarter, by time to recapture, and time to recapture by facility type;
- Escape rates and rates by region, and facility type by region;
- Escapes by facility type, by month; and
- Escape rates by region, by quarter.

For purposes of this report, attempted escape and escape are defined as follows:

- Attempted escape: Inmate is apprehended before completion of the escape act.
- **Escape:** Unauthorized absence from the designated facility boundary or absence from any official assignment outside this boundary.

An escape is further defined as one of the following levels:

- Level I: Escape from non-secure environment, such as a community correctional center or an outside work squad, in which no Level III behaviors are exhibited.
- Level II: Escape from a secure perimeter or supervised environment in which no Level III behaviors are exhibited.
- **Level III:** Escape that involves hostages, weapons/tools, outside assistance, or violence during or after the escape.

An **escape rate** is defined as the number of escapes/(total population on the last day of the month for each month in the quarter/3)\* 1,000.

A **perimeter escape** is defined as one initiated from inside the perimeter of a correctional facility other than a community release facility.

#### Summary:

The number of escapes decreased by 11.8% from 34 in FY 2018-19 to 30 in FY 2019-20. One (3.3%) of the 30 escapes was from a Correctional Institution (C.I.). The escape from a Correctional Institution was an escape from a secure perimeter, during which an inmate used a homemade ladder to climb the perimeter fence undetected. Due to the use of the homemade ladder the escape was deemed a Level III escape. One (3.3%) of the 30 escapes was from a Work Camp/Road Prison, and was a Level II escape. The remaining 28 (93.3%) escapes were from Work Release/Contract Centers and all of the 28 were Level I escapes.

Of the 30 escapes, 28 (93.3%) were recaptured as of July 7, 2020. Of the 28 recaptured, 22 (78.6%) were recaptured within the same quarter the escape occurred. Of the 22 recaptured within the quarter, 13 (59.1%) were recaptured within 24 hours of the escape.

The overall escape rate for Fiscal Year 2019-20 was 0.33 escapes per 1,000 inmates. This is lower than the 0.36 rate observed for Fiscal Year 2018-19 as well as the 0.52 rate observed for Fiscal Year 2017-18. The escape rate for Correctional Institutions was .01 per 1,000 inmates and the escape rate for Work Camps/Road Prisons was .10 per 1,000 inmates. Work Release/Contract Centers had the highest escape rates for Fiscal Year 2019-20 at 8.76 per 1,000 inmates. Region IV had the highest escape rate at 0.72 per 1,000 inmates and Region I had the lowest rate at .10.

There were 8 attempted escapes in Fiscal Year 2019-20.




