Florida Department of Highway Safety and Motor Vehicles Red Light Camera Report for Fiscal Year 2020-2021

Introduction

For the purposes of this report, the Florida Department of Highway Safety and Motor Vehicles will be referred to as the department.

The terms "Traffic Infraction Detector" and "Red Light Camera" are interchangeable, but this report will use red light camera, or R L C, for simplicity.

The counties and municipalities covered in this report will be referred to as jurisdictions.

Notices of Violation will be referred to as N O V's.

Uniform Traffic Citations will be referred to as U T C's.

<u>Section 316.0083(4)(b)</u>, Florida Statutes, directs the department to provide a summary report on the use and operation of red light cameras in Florida. The report "must include a review of information submitted to the department by the counties and municipalities, and must describe the enhancement of the traffic safety and enforcement programs."

<u>Section 316.0083</u>, Florida Statutes, describes the process for violations of red light cameras. A traffic infraction enforcement officer issues a Notice of Violation, or N O V, to the violator within 30 days of the violation. The violator may pay the notice or contest the violation through an appeals process within 60 days. If the violator fails to pay or appeal the notice, a local jurisdiction issues a Uniform Traffic Citation, or U T C, to the violator, with a copy to the Clerk of Court for adjudication.

Part 1 Survey Methodology

The department created an online survey to gather information and data from jurisdictions responsible for the administration of red light cameras during Fiscal Year 2020-2021. The 29-question survey included topics such as procedures, N O V's, and program size, and covered activity that occurred from July 1, 2020 through June 30, 2021. As there is no statewide oversight of red light camera programs, the department relies on monies remitted to the Department of Revenue to identify which jurisdictions potentially operated red light cameras during the reporting period. Jurisdictions were also asked to complete a spreadsheet of their camera and intersection locations and dates of operation. With this self-reported information, the department independently collected crash data related to red light camera intersections throughout the state.

Surveys were distributed to all jurisdictions who responded to previous red light camera surveys, and to those who remitted red light camera monies to the Department of Revenue during the reporting period.

Summary of Survey Responses

In total, 47 jurisdictions appeared on the Department of Revenue report for remittance of red light camera penalties during Fiscal Year 2020-2021. Details can be found in the Supplemental Resources section of this report. Of the 47 jurisdictions, 4 indicated they are no longer operating R L C programs,

even though monies may have been remitted after the conclusion of their program. Violations are sometimes paid late, which is why some jurisdictions remitted monies after the conclusion of their program. The survey portion of this report focuses on 44 jurisdictions that indicated red light cameras were operational during the reporting period of July 1, 2020 through June 30, 2021. Reference Appendix F for a list of the 44 jurisdictions and their responses.

The following information is the Camera and Intersection Data as reported by local jurisdictions in the R L C survey:

- There were 497 red light cameras active on July 1, 2020, compared to 510 on July 1, 2019.
- There were 485 red light cameras active on June 30, 2021, compared to 504 on June 30, 2020.
 - o 32 jurisdictions had no change in the number of red light cameras.
 - 5 jurisdictions had an increase in the number of red light cameras, which includes one new jurisdiction with 4 red light cameras.
 - o 7 jurisdictions had a decrease in the number of red light cameras.
- There were 296 intersections with active R L C's on July 1, 2020, compared to 312 on July 1, 2019.
- There were 297 intersections with active R L C's on June 30, 2021 compared to 310 on June 30, 2020.
 - 34 jurisdictions had no change in the number of intersections with R L C's.
 - 4 jurisdictions had an increase in the number of intersections with R L C's, which includes one new jurisdiction with 4 intersections.
 - o 6 jurisdictions had a decrease in the number of intersections with R L C's.

The following information is the Notice of Violation Data as reported by local jurisdictions in the R L C survey:

- A total of 955,297 N O V's were issued. Two jurisdictions indicated they did not have this
 information at the time they submitted their surveys.
 - 563,297 N O V's were paid;
 - 8,437 were contested and are pending;
 - 5,231 were contested and dismissed:
 - 4,578 were contested and upheld;
 - o 212,229 were issued as U T C's:
 - o 15,717 are pending issuance as U T C's; and
 - 145,808 are of unknown status, as availability of N O V status varies by jurisdiction, leaving some in an unknown status.

Table 1 below shows the number of N O V's issued for red light camera violations over the past nine fiscal years, which run from July 1st through June 30th. Also provided are the number of citations for running a red light issued in-person by law enforcement. The N O V data is self-reported by jurisdictions. The citation data is collected from the department database as of November 22, 2021.

Personnel

Jurisdictions were requested to identify who reviews the camera images before issuing N O V's, who reviews contested N O V's, and who ultimately issues U T C's. Personnel categories included law enforcement officers, non-sworn government employees, non-sworn contractor employees or vendors, and other.

Note: Jurisdictions could select multiple options for each question, so numbers may not sum to the total number of respondents. The data is as it was reported by the local jurisdictions in the R L C survey.

Right-Hand Turns

Pursuant to section 316.0083, Florida Statutes:

An N O V and U T C may not be issued for failure to stop at a red light if the driver is making a right-hand turn in a careful and prudent manner at an intersection where right-hand turns are permissible.

An N O V and U T C may not be issued under this section if the driver of the vehicle came to a complete stop after crossing the stop line, and before turning right at a red light, if permissible, but failed to stop before crossing over the stop line or other point at which a stop is required.

The terms in this section of statute are left to the interpretation of each respective jurisdiction. Appendix G provides right turn definitions provided to the department. For Fiscal Year 2020-2021, 25 of 44, or 57 percent, of the responding jurisdictions issued N O V's for persons making right turns on red signals. Nineteen jurisdictions indicated they do not track the number of violations issued for right turns on red.

Alternative Safety Measures

The department also requested what other actions jurisdictions had taken to improve safety measures at intersections during the reporting period. Seventy-two percent, or 31 of 43, of the jurisdictions indicated they had implemented at least one action. Sixty percent, or 26 of 43, indicated they had implemented more than one action. The results of this question are shown below in Table 4. Appendix F provides responses by jurisdiction.

Less than a third of the jurisdictions, 12 out of 44, reported that court cases have impacted their red light camera program. Seven jurisdictions indicated they have conducted an independent red light

camera analysis. Forty-one jurisdictions responded they are continuing their program in Fiscal Year 2021-2022. Thirty-four jurisdictions responded they report crashes electronically, one reports via paper, and eight submit both.

Part 2 Crash Analysis

As with previous fiscal year reports, jurisdictions self-reported the dates of operation and locations of intersections with red light cameras. Intersections were selected to be included in the crash analysis based on their dates of operation. Taking input from jurisdictions who operate red light camera programs, the department refined its methodology to *only include crashes* that occurred on or after July 1, 2012. Therefore, intersections were only included if the activation date was between January 1st, 2013 and December 31st, 2020, allowing at least six months before, and after, the date the camera was activated. In total, 162 intersections were included in the crash analysis from 31 jurisdictions.

Note: While the methodology remains consistent with prior reports, we worked closely with our partners to verify the locations of red light camera intersections and dates of camera operation. This additional step further validated the analysis.

Crashes occurring within 250 feet of the center of the intersection were analyzed before and after the installation of cameras at each intersection. Table 9 shows the breakdown of crashes analyzed based on their distance from the center of the intersection.

Measures were taken to exclude crashes that occurred anywhere other than the roadway, such as

parking lots. The before and after periods used for analysis were unique to each intersection based on the dates of operation, with an equal number of days within each window. Crashes were broken down by manner of collision, injury severity, inclusion of a non-motorist, and whether the crash report indicated a driver ran a red light. See Appendix D for the definition of a non-motorist.

Table 10 shows the breakdown of crashes that occurred before and after the activation of red light cameras at intersections included in the analysis. As with last year, the department excludes crashes that occurred outside of the roadway. Reference Appendix A for a more detailed breakdown of crashes by reporting jurisdiction. Appendix B is specific to crashes where the officer indicated a driver ran a red light, and Appendix C is specific to crashes involving non-motorists.

This data was provided by Signal Four Analytics using intersection location information and operation dates reported by local jurisdictions.

The department maintains partnerships with local jurisdictions to improve the completeness and accuracy of crash report data. The crash analysis should be put into context of the overall complexity of the issue at hand, as many factors may contribute to the change in number of crashes outlined in this report.

One such factor is the increase in Vehicle Miles Traveled, or V M T. The probability of a crash occurring increases as people drive more, and as of January 5, 2022, VMT in Florida increased 9.08 percent from calendar years 2012 to 2020. For more information, use the links under Supplemental Resources below.

Another factor is the fluctuation in crash reports with accurate location information, latitude and longitude. In order to analyze crashes that occurred at certain intersections, it is necessary to know both the location of the intersection and the location of the crashes. Intersection locations, latitude and longitude, were submitted along with the survey; however, latitude and longitude are not included in every crash report.

Part 3 Recommendations

The following recommendations would allow for more accurate reporting of information that cannot currently be tracked through existing systems.

- 1. Require jurisdictions to track camera information including location with GPS coordinates and dates of operation.
- 2. To ensure the ability to reconcile N O V's issued with monies remitted and U T C counts, require jurisdictions that end their red light camera operations to maintain all data regarding the program for a minimum of two years.

- 3. Require jurisdictions to track the issuance of N O V's, including the status of those violations paid, contested, and issued as U T C's.
- 4. Require jurisdictions to track the issuance of N O V's for right-hand turns.
- 5. Create a standard for administering violations for right-hand turns on red signals. Define "careful and prudent manner" to allow for a uniform procedure statewide.
- 6. Require jurisdictions to report alternative safety countermeasures taken prior to and after the installation of red light cameras.
- 7. To determine the enhancement of traffic safety, the department recommends a more thorough analysis be conducted by an independent organization using appropriate local and state agency resources.

The department will continue to collaborate with local jurisdictions operating red light camera programs to improve the data collection and reporting methodology associated with evaluation of the active programs across the state.

We have examined intersections with red light cameras, when compared to a similar intersection, (size, traffic volume, etc.) without a camera. The question of volume is only relevant when comparing crash year over year. The findings have shown that overall there are higher numbers of angle crashes at interactions that do not have red light cameras. Overall angle traffic crashes are up throughout the State of Florida. Any reduction in angle crashes is welcomed.
