We are proud to present Volunteer Florida's 2020 annual report. This year was truly like no other. Despite the unexpected challenges we faced as a nation, our agency was proud to support local communities in our state through our work in volunteer service, emergency management and national service.

Volunteer Florida kicked off 2020 by hosting the fifth annual Suits for Session service project with Uber. In total, Volunteer Florida collected 4,796 items that were donated by state agencies, legislative leaders and individuals across the state. Collected items were donated to organizations that support job-seekers in Florida who are striving to enter or re-enter the workforce.

The 2020 Legislative Session, which ended in March, proved to be very successful one for Florida's volunteers. With the support of Senator Manny Diaz and Representative Randy Maggard, Volunteer Florida was able to pass the Disaster Volunteer Leave for State Employees Act which was signed by Governor Ron DeSantis in June.

In spring, Volunteer Florida, along with the rest of the country, began responding to the COVID-19 pandemic. Volunteer Florida staff immediately deployed to the State Emergency Operations Center to manage ESF 15: Volunteers and Donations. Volunteer Florida's AmeriCorps and Volunteer Generation Fund programs immediately shifted their service model to serve Floridians in need virtually. Programs were able to serve thousands of meals to families in need, as well as provide services like tutoring and mentoring online.

Throughout the summer, Volunteer Florida continued to find new and unique ways to support Florida's communities. Volunteer Florida's Volunteer Services Department held a series of webinars for organizations and volunteers. This ultimately led to the planning of a three-day Virtual Volunteer Leadership Convening in the fall which featured speakers like First Lady Casey DeSantis and Points of Light CEO Natalye Paquin. Volunteer Florida also promoted Volunteer Connect, Florida's official volunteer opportunities platform, as a way for Floridians to start serving their communities in-person and virtually.

During this challenging year, Volunteer Florida's commitment to serving Florida's communities never changed. In August, Volunteer Florida welcomed 1,497 AmeriCorps members who are serving in 36 programs in 32 counties during the 2020-2021 program year. In October, Volunteer Florida's Volunteer Generation Fund program welcomed 24 Florida nonprofits who will spend the next year recruiting skills-based volunteers to serve Florida communities. The Volunteer Florida Foundation also provided funding to nine organizations supporting long-term recovery efforts for Hurricane Irma and 10 organizations supporting long-term recovery efforts for Hurricane Michael.

As we reflect on 2020 and kick off 2021, we extend our heartfelt gratitude to Governor and First Lady DeSantis, our partners in the Florida legislature, and our Volunteer Florida Commissioners, Foundation Board members, staff, partners, and sponsors who continue to support our efforts. We could not **#ServeFL** without you!

AMERICORPS

- In the 2019-2020 grant year, Volunteer Florida's 1,620 AmeriCorps members provided 1.32 million hours of service, valued at \$32.9 million dollars.
- Volunteer Florida administered 38 AmeriCorps programs with 1,620 AmeriCorps members serving 43,620 Florida students in 325 Florida schools.
- AmeriCorps members were eligible to receive \$7,428,145 in education awards upon completion of their year of service.
- AmeriCorps members leveraged an additional 4,604 volunteers who served alongside national service programs for an additional 70,364 hours valued at \$1,754,174.
- AmeriCorps members provided direct support, including health and wellness services to 12,773 veterans and their family members.
- 38 AmeriCorps programs received innovative, multi-day training through Volunteer Florida's first AmeriCorps Virtual Training event.

COVID-19 - NATIONAL SERVICE RESOURCES AND RESPONSE

In March of 2020, AmeriCorps programs pivoted to address unique community needs and provide critical community support. Volunteer Florida provided key technical support including weekly webinars and a centralized digital platform for resources.

Throughout Florida, AmeriCorps members addressed a wide variety of community needs including:

- **Boys and Girls Club of Martin County, Hobe Sound**

AmeriCorps members dedicated approximately 16,000 hours of service within the community as well as offered virtual support to the Martin County School District. Members collected and sorted food donations of 8,034 lbs. as well as packaged and served 28,652 meals and served 102 children through academic enrichment.

- **Peacemakers, Miami**

AmeriCorps members supported students through remote learning, online tutoring and food distribution. Members provide approximately 6,000 total meals and distributed 26,800 pounds of food in the community.

- **Breakthrough Miami, Miami**

Breakthrough Miami provided a virtual Summer Institute, engaging 680 scholars in an eight week summer academic program. In addition, members helped distribute over 600 meals to families in need.

- **Goodwill Industries of the Big Bend, Tallahassee**

AmeriCorps members provided services to 803 individuals including: employment services, skills trainings workshops as well as provided wellness checkups for individuals with disabilities and their families. Member services included 517 safety wellness checks and the distribution of 611 lbs. of food and 122 lbs. of masks and fabric.

- **Centro Campesino, Florida City**

AmeriCorps members provided virtual educational programming to students and served over 5,000 people through collecting and distributing over 30,000 lbs. of food.

To assist Florida communities, Volunteer Florida offered a planning grant funding opportunity for interested organizations to develop future AmeriCorps programming in response to COVID-19. As a result, Volunteer Florida funded five AmeriCorps Planning Grants who will develop a proposal for a future operational AmeriCorps program, providing local response to community need in the upcoming year.



VOLUNTEER GENERATION FUND

- In the 2019-2020 grant year, Volunteer Florida's 16,180 skills-based Volunteer Generation Fund (VGF) volunteers provided 289,717 hours of service in Florida. A value of \$7,222,65 million dollars.
- VGF grantees recruited 33,108 new skills-based volunteers to provide disaster related services.
- VGF grantees recruited 1,681 new skills-based volunteers to provide outreach and education on the opioid crisis.
- Volunteer Florida hosted a presentation on VGF's impact in Florida at the America's Service Commission virtual VGF Convening with participation from 23 State Service Commissions.
- VGF partners participated in the first ever, virtual VGF Annual Training, as part of the Volunteer Leadership Virtual Convening. VGF partners attended sessions related to volunteer management practices, including skills-based volunteering, effective volunteer management practices and contract compliance.
- VGF programs engaged volunteers in diverse volunteerism activities including the following:
 - Big Bend Hospice engaged 107 volunteers who provided over 1,800 hours of direct organizational care during the COVID-19 health crisis.
 - Girls on the Run of the Big Bend engaged 51 coaches in the spring to serve 225 3rd-7th grade girls in a ten-week, curriculum based program focused on friendship, confidence and strength.
 - New Hope for Kids trained 165 skills-based grief facilitator volunteers who provided grief support to 400 children attending grief support programs and camps.
 - St. Lucie County Oxbow Eco-Center removed 1,482 pounds of invasive plants from protected pine flatwoods forest.

 - 536 volunteer opportunities posted, mobilizing 819 volunteers
 - Database currently houses opportunities representing more than half of Florida’s counties

VOLUNTEER LEADERSHIP VIRTUAL CONVENING



Volunteer Florida's Volunteer Leadership Virtual Convening provided volunteer engagement leaders with tools to navigate micro and macro changes in Florida's communities and grow effective, creative volunteer programs. Highlights included:

- More than 370 virtual attendees
- Nationally recognized speakers and experts facilitated 14 sessions covering topics such as strategic planning, diversity, equity and inclusion, virtual volunteerism, mental health awareness, skills-based volunteerism and more
- Special guests included Florida First Lady Casey DeSantis, panelists from Florida State University, Merit and Duke Energy Foundation, and a keynote address from Natalye Paquin, President & CEO of Points of Light.

EMERGENCY MANAGEMENT

- Activated Emergency Support Function 15 (Volunteers and Donations) in order to prepare and coordinate volunteer activities in support of the State Emergency Operations Center (SEOC) as a part of the mass care function for the ongoing 10-month COVID-19 activation.
- Activated ESF-15 for Hurricanes Isaias, Laura, Marco, Sally and Eta.
- Committed almost \$7 million to fund 16 new Florida Disaster Fund grants.
- Continued to manage 14 current Florida Disaster Fund grants worth approximately \$8 million.
- Signed more than 85 new MOUs with nonprofit and faith-based organizations in order to understand their capacity and capability to support various disaster activations in the future.
- Conducted an efficient and timely close out of the Irma Disaster Case Management Program (DCMP). Overall, DCMP Irma managed 11 regional offices and four providers supporting 49 counties that helped more than 100,000 contacts and closed out over 35,000 cases.
- Managed DCMP Michael including two contracted support providers and six regional offices that support 12 counties. To date, DCMP Michael has served more than 36,178 contacts and 1,682 cases.



EMERGENCY MANAGEMENT

- Hosted an Emergency Management State Convening in March 2020. The event was very successful and included almost 100 attendees and a service project with Stars of Hope.
- Updated and revised the Volunteer Florida Continuity of Operations Plan (COOP) including a new pandemic response annex.
- Due to COVID-19, Volunteer Florida extended all FY19/20 CERT/Citizen Corps contracts through August 2020.
- Established 20 new FY20/21 CERT/Citizen Corps grants with contracts totaling \$120,000.
- Established the first-ever ESF-15 Volunteer Liaison Program. Based on lessons learned from prior hurricane responses, Volunteer Florida developed a concept for an ESF-15 Volunteer Liaison training program with the goal of creating a bullpen of qualified volunteers who are capable of supporting state and county EOCs with manpower to fulfill ESF-15 duties during disaster. The concept included bringing on a volunteer staff position with ESF-15 and developing disaster curriculum. Dr. Jerry Hernandez has been selected to fill the Volunteer ESF-15 Liaison Training position and over the next six-months, he will work with Pinellas County on a pilot program that we hope will become a statewide success.



VOLUNTEER FLORIDA FOUNDATION

The Volunteer Florida Foundation is Volunteer Florida's direct support organization, providing funds to administer high-impact national service programs and promote volunteerism throughout the state, while managing the Florida Disaster Fund - Florida's official fund to assist communities with disaster response and recovery. The Foundation is also responsible for the Governor's special initiatives, including the Black History Month and Hispanic Heritage Month celebrations and student contests.

- In February, the Volunteer Florida Foundation was proud to support Governor DeSantis' and First Lady Casey DeSantis' 2020 Black History Month Art, Essay and Excellence in Education Awards Contests in October. This year's theme was Celebrating Untold Stories and Contributions of Hispanic Americans in Florida.
- In the fall, the Volunteer Florida Foundation, along with the Executive Office of the Governor, Florida Department of Education and Florida Department of State hosted the 2020 Hispanic Heritage Month contests. Due to the ongoing COVID-19 pandemic, the event was conducted virtually for the first time!
- The Florida Disaster Fund, administered by Volunteer Florida Foundation, was established in 2004 to fulfill unmet needs after disasters. This allows Floridians to benefit from all available resources with maximum efficiency, limiting duplication of effort. The Volunteer Florida Foundation distributes the Florida Disaster Fund among voluntary organizations that have identified unmet needs and are engaged in disaster response and long-term recovery activities in Florida.
