Executive Summary

The Department of Management Services (DMS), Division of State Purchasing, Office of Supplier Diversity (OSD), administers the certification program for eligible woman-, veteran- and minority-owned businesses. Eligibility requirements include being at least 51% owned by a woman-, veteran-, or minority-person, being a small business, and being domiciled in Florida. OSD also educates businesses on state government contracting and partners with other state, local, and federal programs across the state to facilitate networking and outreach events that provide vendors with business opportunities. During Fiscal Year 2021-22, OSD continued educational and outreach efforts to support certified firms, and OSD advised other state agencies as they sought to diversify their spending activities.

Successes in the 2021-2022 FY include the following:

- Certifying 1,063 new firms as woman-, veteran- and/or minority-owned businesses. Last year, due to various economic and health factors, OSD received an unprecedented amount of applications for certification.
- Developing new technologies and tools to improve the customer experience. The
 certification and recertification process was integrated into Next Generation
 MyFloridaMarketplace (MFMP), the modernized, cloud-based procurement platform used
 by the State of Florida. This enhancement improves customer experience and is able to
 evolve with procurement processes.
- Providing networking and outreach opportunities for a total of 6,357 certified firms in Florida.
- Achieving nearly \$440,000,000 in total spend with certified business enterprises (CBEs).
 This figure once again is a decline in total spend as noted above. The previous year due to extra funding allowed the opportunity to increase spend with Certified Business Enterprises (CBEs).
- Attracting over 500 attendees to regional OSD Supplier Diversity Exchanges.
- OSD was honored to partner with Enterprise Florida and other stakeholders such as Florida Small Business Development Centers (SBDCs), Florida Agricultural and Mechanical University, and Florida State University. This year, OSD launched a Minority and Small Business Boot Camp to provide training workshops and networking opportunities to grow minority and small business.

The following pages include details on these successes and provide insight on how OSD continues to prove a valuable resource for Florida small businesses.

Office of Supplier Diversity Overview

OSD is the specialized team within the Division of State Purchasing at DMS that manages the certification program for Florida-based woman-, veteran- and minority-owned businesses. By providing education, outreach and marketing efforts, OSD helps improve opportunities for small businesses through the following activities:

- Assisting small business owners with applicable state certification and recertification.
- Targeting outreach and communications of opportunities specific to unique commodity listings.
- Advocating for the utilization of certified woman-, veteran- and minority-owned businesses with state, local and private industries.
- Planning, hosting and supporting Florida networking and business exchange events geared toward woman-, veteran- and minority- business owners.
- Providing educational information to state government procurement professionals to help increase the use of small businesses in state and local government procurement contracts.
- Promoting procurement opportunities across a variety of industries.

To become a certified woman-, veteran-, or minority-owned business, the following requirements must be met by the business:

- Must be engaged in commercial transactions.
- Must be domiciled in Florida.
- Be 51 percent owned and managed by a woman, veteran, or minority who is a U.S. citizen or permanent resident alien.
- Independently owned and operated, with a net worth of no more than \$5 million and that employs fewer than 200 full-time permanent employees.

Certification benefits include the following:

- First-tier referrals to state agencies and other public/private entities for purchase order and contract opportunities.
- Exclusive listing of state-certified woman-, veteran- and minority-owned business in an online directory.
- Direct messaging from state agencies and other organizations about procurement opportunities.
- Participation and networking at regional events.
- Mentor-protégé opportunities for business development and guidance from established corporations.

Supplier Diversity Exchanges

Through events and outreach opportunities, OSD engages and educates woman-, veteran- and minority-owned small businesses to help them better understand government procurement and how to benefit from public sector contracting. The signature event of OSD, the Supplier Diversity Exchange, is a networking-style experience that positions small businesses to meet directly with local, federal and state buyers. With the help of regional partners, OSD ensures each Supplier Diversity Exchange is unique, supplying local vendors with a wide range of educational opportunities, such as trainings, presentations, question and answer discussions, one-on-one scheduled appointments, and reverse trade shows. OSD held multiple Supplier Diversity Exchanges throughout Florida in the 2021-2022 FY, including the following:

Office of Supplier Diversity 2021-2022 FY Certification Data

During the 2021-2022 FY, 1,063 firms were newly certified as woman-, veteran- and/or minority-owned businesses.



As of June 30, 2021, OSD has a total of 6,357 certified firms in Florida. Recertification occurs on a biannual basis and during the 2021-2022 FY, 1,264 firms were recertified as woman-, veteranand/or minority-owned businesses.

Data Calculation for the 2021-2022 FY

Over the past several years, total agency spending on CBEs includes the dollar amounts and percentages instead of the dedicated contract funds for each agency. This calculation excludes any transfers, grants, subsidies or other pass-through payments to other state agencies or recipients as those expenditures do not represent active and deliberate contracting decisions on the part of the agency. This way of collecting data provides a more relevant representation of expenditures of the state on woman-, veteran- and minority-owned small businesses.
