# No Net Loss of Hunting Lands 2021-22 Annual Report

The 2006 Florida Legislature committed the State of Florida to the preservation of hunting lands and hunting opportunities for the future. Section 379.3001(6), Florida Statutes (F.S.), "No Net Loss of Hunting Lands", requires the Florida Fish and Wildlife Conservation Commission (Commission) to provide an annual report to the Legislature on the status of hunting lands available to the public.

This report describes the acreage managed by the Commission that was open and closed to hunting during Fiscal Year (FY) 2021-22. As defined in s. 379.3001(2), F.S., "Commission-managed lands" are lands owned by the Commission, lands owned by the state over which the Commission holds lead or cooperative management authority, or privately-owned lands that are leased or managed by the Commission. Other state agencies and water management districts that own or manage land are also required in s. 379.3001(7), F.S., to report properties with acreage open and closed to hunting during the previous fiscal year (except for right-of-way lands, parcels under 50 acres, and state parks).

Under the provisions of s. 379.3001(4), F.S., Commission land management decisions and actions, including decisions made by private owners to close hunting land managed by the Commission, shall not result in any net loss of land acreage available for hunting opportunities on Commission-managed lands that existed on the effective date of the act (June 7, 2006). This law also requires that the Commission expeditiously find replacement acreage for hunting to compensate for closures of any existing hunting land. Furthermore, replacement lands shall, to the greatest extent possible, be located within the same administrative region of the Commission and shall be consistent with the hunting discipline that the Commission allowed on the closed land.

Approximately 3,331,485 acres of Commission-managed public hunting lands existed on the effective date of the act. The total acreage of Commission-managed public hunting lands existing as of June 30, 2022, is 3,619,698. Decisions and actions taken by the Commission since the adoption of the No Net Loss of Hunting Lands legislation have resulted in a net increase of 288,213 acres of Commission-managed public hunting lands.

In addition to the 3,619,698 acres of Commission-managed public hunting lands, there were approximately 2,450,542 acres of federally owned lands in the wildlife management area system available for public hunting during FY 2021-22. This resulted in a total of 6,070,240 acres of land managed by the Commission open for public hunting in Florida. Exhibit 1 provides the complete list of these properties. Exhibit 2 shows the list of Commission-managed lands that were *not* open for public hunting, 34,377 acres, during FY 2021-22.
