INTRODUCTION

EXECUTIVE SUMMARY

Pursuant to <u>section 381.989</u>, Florida Statutes, the Florida Department of Highway Safety and Motor Vehicles (department) maintains statewide impaired driving education campaigns to raise awareness and prevent marijuana-related and cannabis-related impaired driving. Beginning in 2017 and annually thereafter, the statute required the department to capture data on the number of marijuana-related citations, crashes and arrests, and report this data on January 31 of each year to the Governor, the President of the Senate and the Speaker of the House of Representatives.

To assist in capturing the data on marijuana-related and other drug impairment crashes, the department implemented a supplement to Florida's Traffic Crash report. The supplement has been implemented by all law enforcement agencies in the state and captures seven (7) drug types based on the National Highway Traffic Safety Administration's (NHTSA) recommendations for drug impairment. This supplement is required to be provided with all crash reports indicating a person was impaired by drugs at the time of the crash.

The department conducts workshops with Florida law enforcement agencies across the state to improve the accuracy and completeness of crash data. A portion of each of these workshops is dedicated to ensuring adherence to the requirement for reporting positive drug test results. In addition, the department trains additional Florida Highway Patrol Troopers as Drug Recognition Experts (DRE). DREs are highly-trained law enforcement officers with expert knowledge in an extensive range of driver impairments and their associated signs and symptoms. DREs are dispatched to assist investigations and obtain convictions in cases involving impaired driving.

IMPAIRED DRIVING EDUCATION CAMPAIGN

In 2017, the department was allocated \$5 million in non-recurring funds to implement a statewide impaired driving campaign. To fulfill the requirements of the law, the department contracted with the University of Florida to conduct surveys to evaluate awareness of impaired driving laws. In 2018, the department released the "DRIVE BAKED, GET BUSTED" campaign to educate Floridians on the dangers of impaired driving and promote awareness of impaired driving laws. A follow-up survey was completed by the University of Florida evaluating the impact of the "DRIVE BAKED, GET BUSTED" campaign. The four-month campaign garnered over 2.5 billion impressions from print, outdoor, TV, radio, streaming radio, cinema, social media and digital media.

The department continues to educate Floridians on the dangers of impaired driving through regular traffic safety campaigns, partnerships with federal, state and local law enforcement and traffic safety organizations.

IMPAIRED DRIVING CAMPAIGNS

The department continues to promote traffic safety and educate Floridians on the dangers of impaired driving through ongoing public awareness campaigns.

In March 2020, the department used "NEVER DRIVE IMPAIRED" as part of the Spring Break campaign, focusing on educating high schoolers and college-aged students on the seriousness and consequences of driving while impaired by targeting popular Spring Break destinations and where the most DUI citations and crashes occurred in Florida, using strategically placed paid media. This campaign garnered over 7 million impressions through paid media ads on Google, YouTube, Facebook, Instagram, Snapchat, Spotify, Pandora, and Gas Station TV. Additionally, the department developed messaging and graphics and provided marketing materials to Florida Highway Patrol Public Affairs Officers, campaign partners, and other stakeholders throughout the state.

In October 2020, the department launched its first driver-safety podcast. The podcast, 3PointTurn, contains 12 episodes focused on various driver-safety topics. On episode 6 of the podcast, "Choice vs. Consequence," the FLHSMV team provided meaningful dialogue on the dangers of poor choices and the consequences from improper decision-making while driving, including the life-altering consequences of impaired driving

In November and December 2020, the department used "Give the Gift of Safety – Never Drive Impaired" as the overall theme for the two-month Safe Holiday Travel campaign. The campaign encompassed many topics, but the impaired-driving prevention and educational messaging was the main focus. Based on the "Give the Gift of Safety – Never Drive Impaired" message, graphics were designed to show how civilians and law enforcement alike can give the gift of safety to each other during the holidays – and every day – by choosing to never drive impaired. This campaign garnered over 20 million impressions through paid media ads on social media and online, internet radio, billboards, and Gas Station TV.

Throughout 2020, the department launched two major campaigns focused on impaired-driving prevention and education and incorporated the message throughout the entire year. The department will continue to educate Floridians on the dangers of impaired driving.

OTHER ACTIVITIES

During the Spring/Summer of 2020, FLHSMV's Office of Driver Safety produced a *Driver Education Teacher Guide* to assist Driver Education Licensing Assistance Program (DELAP) instructors with preparing students for the Class E Knowledge Exam, as well as providing important information on driver safety and Florida traffic laws (including the dangers of impaired driving, the effects of drugs/alcohol on one's ability to drive, zero tolerance, and implied consent). The Teacher Guide consists of three weeks' worth of instructional materials, including: lesson plan objectives; PowerPoint presentations; student worksheets; pre and post-tests; and answer keys. In August of 2020, more than 280 driver education instructors received a binder of all printed materials, a USB with electronic materials, and a classroom set of the *Florida Driver License Handbook*.

Individuals who commit an enhanced first time DUI (DUI with a minor present or a BAC over .15), and for all subsequent DUI offenses in Florida, face a mandatory requirement for the installation of an Ignition Interlock Device (IID) on vehicles they routinely operate. The department contracts with seven (7) IID vendors that perform the installation, monitoring and reporting of all IID activities to the department. In August of 2020, the department coordinated with each vendor to create a financial assistance program to aid individuals who otherwise could not afford the monthly rates associated with IID monitoring. The program began in September of 2020, and through December 2020 there have been 58 individuals that have complied with installation requirements while taking advantage of the financial assistance program.

During the Fall of 2020, FLHSMV's Driver Compliance Program began surveying participants of all Level I and Level II DUI courses throughout Florida. The goal is to obtain feedback on the overall curricula and use the feedback to update and improve the course content. Clients are provided a QR code specific to the course level where they can provide input on the entire curricula including videos, course content and the effectiveness of the course instructor. The survey results are being compiled and will be utilized by the department to update and improve the DUI course content in an effort to continue to reduce DUI recidivism.

FLORIDA HIGHWAY PATROL DRUG RECOGNITION EXPERT PROGRAM

The Florida Highway Patrol (FHP) is the state's enforcement authority in highway safety. FHP Drug Recognition Experts (DREs) serve as subject matter experts receiving over 100 hours of extensive, specialized training to identify a variety of drug-induced driver impairments. To become a DRE, a law enforcement officer must first complete two prerequisite courses, receive an endorsement from their local Assistant State Attorney, another DRE and their leadership, successfully complete the two-week DRE training program, complete a minimum of twelve field evaluations in the presence of an instructor, and pass both a written and practical exam.

DREs are typically deployed in scenarios requiring an evaluation of a driver suspected of impairment caused by a narcotic. The DREs' expert testimony often helps prosecutors secure convictions in cases involving impaired driving; specifically, when impairment results from the use of substances other than alcohol, including suspects under the influence of multiple impairing substances.

The FHP DRE program follows all protocols and examinations as directed by the International Association of Chiefs of Police.

The FHP has 62 of the 369 DREs in Florida, representing 16.8% of all DREs. Of these 62, 7 are Instructors. FHP has also set an aggressive goal to add 20 new DREs to their ranks each year to eventually have 300 Troopers certified as DREs. This would translate to approximately 1 in 5 Troopers (20%) credentialed as DREs on Florida's roadways at any given time.

CRASH REPORTING

UPDATING FLORIDA'S CRASH REPORT FORM

To collect information on the number of marijuana-related traffic crashes in the state, the department released a crash report supplement in late 2017. This supplement requires law enforcement agencies, upon completion of their crash investigation, to submit positive drug test results to the department. The supplement has been implemented by all law enforcement agencies and provides positive drug test results on seven (7) drug types based on NHTSA recommendations. For each crash, the supplement is provided on drivers and non-motorists tested for drugs and provides space for up to four (4) different drug results.

Since implementation of the crash report supplement, the department has worked directly with more than 300 law enforcement agencies across the state to update the crash report form and its submission process to track marijuana-related traffic crash information.

DATA AND BASELINE INFORMATION

In accordance with <u>section 381.989</u>, Florida Statutes, the department established baseline data and provides reports annually on the number of marijuana-related traffic crashes occurring in the state.

The table below depicts general impaired driving crash information reported by the department in the <u>Traffic Crash Facts Annual Reports</u>.

It should be noted that in 2020 the COVID-19 pandemic potentially influenced some of the numbers within this report. For example, travel restrictions, business closures and quarantining may have impacted vehicle miles traveled and the number of drivers on the roadways.

The information in the following tables depicts data submitted to the department as of January 13, 2021, from the crash report supplements, but is considered preliminary and may change as updates become available.

The chart below depicts the number of times a type of drug was reported in a crash during the respective year. Please note that one crash can have multiple drugs reported. Please also note that more than one driver or non-motorist involved in a single crash maybe tested for drugs. For example, if a crash involves two or more vehicles, all of the drivers may be tested for drugs.

Of the drug types reported, Marijuana was the most prevalent category, followed by Other Controlled Substance, Amphetamine, Cocaine and Opiate.

Individuals age 25-29 were the most reported age group in crashes with 388 drug-related crashes and 685 positive drug test results reported to the department. The most prevalent drug in this age group was Marijuana followed by Other Controlled Substance.

Marijuana is the most prevalent drug in teenagers and young adults involved in crashes (ages 10 through 24). Marijuana prevalence begins to decrease at 25 years of age or older.

The Other Controlled Substance drug type includes prescription drugs such as benzodiazepines. The Other Drug type includes non-prescription drugs such as allergy medication or those without a specific category for the test result. Unknown is reported when the test produces an unknown result.

The table below depicts the prevalence of drugs by type and age group of persons involved in drug-related crashes.

As there can be up to four (4) drug results reported in driver(s) and/or non-motorist(s) involved in a crash, a single crash may be counted in more than one drug type. For example, this table shows 484 crashes in 2018 in which marijuana was reported. However, the Prevalence of Drugs by Type by Year chart on page 4 shows marijuana was reported 495 times, meaning more than one person in a single crash tested positive for marijuana.
