

#### 2002-2003 GOVERNING BOARD



Colleen Castille was named by Governor Jeb Bush as Secretary of the Department of Community Affairs on January 2, 2003. Ms. Castille was born in Japan where her parents were stationed with the United States Air Force. In 1961, her parents were transferred back to the United States and retired to Miami. Ms. Castille attended Florida State University where she earned her undergraduate degree in International Affairs.

Ms. Castille's career in politics began as a campaign fundraiser for the Gallagher for Governor Campaign in 1986. Following the election, she moved to Tallahassee and along with a partner opened a lobbying firm. Two years later. she joined newly elected Insurance Commissioner Tom Gallagher's office and was eventually promoted to senior cabinet aide. In 1995, she joined Education Commissioner Frank Brogan's office as chief cabinet aide. As Brogan's aide, Castille was instrumental in the passage of many of the education reforms that were used to build the Bush-Brogan A+ Plan. In 1999, Governor Jeb Bush recruited Castille to join his leadership team as chief cabinet aide.

As senior and chief cabinet aide, Ms. Castille specialized in environmental matters. She researched and helped develop Cabinet policy regarding Local Government Comprehensive Plans, Areas of Critical State Concern, Developments of Regional Impact, Water-use Disputes, and Community Development Districts.

As Secretary of the Department of Community Affairs, Ms. Castille fills the requirement of serving as the permanent chair of the Florida Communities Trust Governing Board.



Sinny Myrick

Ginny Myrick is a private consultant focusing on new business development, government relations and nonprofit strategic planning. She has been in the government relations business for over 20 years and currently represents the largest underground utility rehabilitation companies in North America, several non-profits dealing with environmental land preservation and the largest gunite rehabilitation company in the United States.

Ms. Myrick lives in Jacksonville and served from 1987–1994 as a member of the City Council. In addition to sponsoring noteworthy legislation, she distinguished her tenure by emphasizing extensive urban park restoration using public/private contributions, and was one of the founders of the I. M. Salzbacher Center for the Homeless, chairing that Board for two years. Ms. Myrick was also partner in a private corporate meeting planning company for seven years while serving on the Jacksonville City Council. In addition to serving on the Mayor's Executive staff, Ms. Myrick was also Director for Intergovernmental Affairs for Mayor John Delaney, from 1994 to 1999, which included the responsibility of supervising Jacksonville's team of lobbyists involved in policy and leaislative issues with the Florida Leaislature.

Ms. Myrick has also served as Vice-President of Government Affairs for the Jacksonville Port Authority. She is the former Board Vice-Chair of the Florida Humanities Council and has chaired several local non-profit organizations. Currently, she serves on the Florida Advisory Council for the Trust for Public Land.

Ms. Myrick's education includes Bachelor of Arts and Master of Arts degrees from the University of Central Florida, and doctoral work at Texas Technological University. She is a Fellow in Government from the University of North Florida. Ms. Myrick was recently reappointed in May and is serving a four-year term that expires on January 31, 2007. She fills the required appointment of a former elected city official and serves as vice-chair.




Olbert Olfonso

Albert Alfonso currently serves as President and was a founding principal of Alfonso Architects in Tampa. Named as Small Business of the Year by the Tampa Chamber of Commerce in 1999, the firm today counts among its clients, Florida Power and Light, the State University System of Florida, the New York Yankees, the City of Tampa, Publix Groceries, Hillsborough Community College, Time Warner Communications, the Tampa Police Department and Target stores amona others.

Mr. Alfonso is also a member of the American Institute of Architects, Ybor Rotary, and was a member of the City of Tampa Architectural Review Committee from 1994-1997. Born in Cuba, Mr. Alfonso moved to Tampa in 1960. He attended the University of Florida and received a Bachelor of Arts in Architecture in 1981 and a Master of Arts in Architecture.

Mr. Alfonso is serving a four-year term that expires on January 31, 2005. He fills the required appointment of a representative of the development community.



Edwin C. Moure

Edwin C. Moure, of Miami, is President of the Biscayne Bay Foundation, a nonprofit conservation organization. As a native of South Florida, Mr. Moure practiced as an attorney prior to his work with the Foundation.

Mr. Moure received a Bachelor of Arts degree from Rice University in 1985 and graduated from the University of Miami School of Law in 1988. He is currently a member of the Florida Bar.

Prior to his work with the Biscayne Bay Foundation, Mr. Moure began the School of New Horizons in 1992, which he continues to own and operate today. Mr. Moure also served as Executive Director of the Everglades Restoration Campaign for the National Audubon Society.

Mr. Moure has participated in land acquisition processes at state, regional and local levels for more than a decade. Mr. Moure is serving a term that expires on January 31, 2005. He fills the required appointment as a representative of a 501(c)(3) nonprofit organization.



Fred W. Streetman

Fred Streetman retired from business in 1989 after the sale of his company, Streetman and Associates, Inc., a 20 year old Central Florida orthopedic equipment distributorship serving Florida and Georgia. A native of North Carolina. Mr. Streetman has been a Central Florida resident since 1969. He earned his Bachelor of Arts Degree from Davidson College, Davidson, NC, in 1959.

Mr. Streetman was first elected to the Seminole County Commission in 1984. During his eight years as a County Commissioner, Mr. Streetman served three terms as Chairman. He was also Chairman of the Seminole County Expressway Authority from 1985 to 1990 during the planning and initial construction of the Orlando/Seminole County eastern by-pass, the Greenway. He was also a member of the Governor's Wekiva River Protection Task Force that laid the foundation for the Wekiva River Protection Act.

Over the years, Mr. Streetman has been heavily involved in community service. He has served as President of the Longwood Area Sertoma Club, President of the Sabal Point Elementary PTA, and President of the Seminole Youth Sports Association. He was a longtime member of the 5th Congressional District Military Academies Selection Board and a member of the U.S. Small Business Administration Council. Mr. Streetman is also the former Chairman of the Seminole County Republican Executive Committee and a former GOP State Committeeman.

Mr. Streetman served a term that expired on January 31, 2003. He filled the required appointment of a former elected county official. Ms. Sue Schmitt from Brevard County was appointed by Governor Bush on May 30, 2003. Ms. Schmitt serves a four-year term which expires on January 31, 2007.



David B. Struhs

David B. Struhs was appointed Secretary of the Florida Department of Environmental Protection by Governor Jeb Bush in January 1999. In this capacity, Mr. Struhs oversees Florida's environmental regulatory and law enforcement programs, the acquisition and management of public lands, including an extensive system of state parks, and the development and regulation of Florida's water resources through the state's water management districts.

Prior to being appointed Secretary in Florida, Mr. Struhs has served as Commissioner of the Department of Environmental Protection in Massachusetts, Vice-President of The Canyon Group, Inc., a consulting firm to the gas and electric utility industry, Chief of Staff to the President's Council on Environmental Quality. and with the U.S. Environmental Protection Agency's New England Regional Office.

Upon his arrival in Florida, Mr. Struhs became chief strategist and advocate for the passage of Governor Jeb Bush's "Florida Forever" plan the largest conservation land program in the world. Mr. Struhs led Florida's effort to restore America's Everglades, widely regarded as the most ambitious environmental restoration project ever undertaken.

Mr. Struhs takes special pride and finds personal pleasure in the 150 parks operated by the Department of Environmental Protection. Florida's State Parks currently hold the National Park and Recreation Association's Gold Medal, having been voted the best state parks system in America, Mr. Struhs araduated from Indiana University in 1982 with a Bachelor's degree in Journalism and Political Science. He holds a Master's degree in Public Administration from the John F. Kennedy School of Government at Harvard, and was a Fulbright Fellow to the Weekly Review and the University of Nairobi, Kenya in

As Secretary of the Department of Environmental Protection, Mr. Struhs serves as 3 permanent member of the board.

# Overview & Accomplishments

#### What is the Florida Communities Trust?

The Florida Communities Trust is a state land acquisition grant program housed within the Florida Department of Community Affairs. The Trust provides funding through an annual competitive grant cycle to local governments and non-profit environmental organizations to acquire community-based parks, open space, and greenways. These projects must further outdoor recreation and natural resource protection needs identified in local government comprehensive plans.

The Trust is governed by a six member board that includes the Secretary of the Department of Community Affairs (who serves as permanent chair), the Secretary of the Department of Environmental Protection, and four members of the public appointed by the Governor. These appointees must include a former elected official of a metropolitan municipality, a former elected official of a county, a representative of an

environmental non-profit organization, and a representative of the development

The most unique aspect of the Trust is that it is the only state program available exclusively for locally selected projects. Unlike other state-administered acquisition programs, the local grant recipient, not the state, holds title to lands purchased. Each local

government or non-profit organization is

then responsible for land stewardship and implementation of a formal management plan written by the local government or non-profit organization and approved by the Trust.

Funding for the Trust Funding for the Trust's grant program comes from the Florida Forever program. The Trust receives 22 percent of the total proceeds from the sale of Florida Forever bonds for an annual appropriation of \$66 million. The Florida Forever Act requires that

75 percent of funds received by the Trust are matched by local governments. The Trust ensures this match requirement is met throughout the selection, evaluation, and closing processes. The Trust concluded its second year of awarding Florida Forever grants by exceeding the statutory match requirement of 25 percent in the Florida Forever Act. The Trust provides communities a unique opportunity to leverage local dollars with state funds, thereby optimizing conservation benefits.

The Florida Communities Trust is an integral part of the Department's efforts to assist Florida communities in meeting

the challenges of growth management, reducing the effects of disasters, and investing in community revitalization; while protecting the state's natural and cultural resources. The Trust's mission is to assist communities in implementing their comprehensive plans through the acquisition of land and promote innovative non-regulatory solutions to the challenges inherent in the comprehensive planning process.

#### The Spirit of Partnership

The Trust is dedicated to working with communities throughout the state to accomplish a collective goal: the acquisition of lands for recreation and open space. The Trust partners with local communities and environmental nonprofit organizations to make this goal a reality. Every grant application is a partnership, not only between the Trust and the applicant, but between applicants as well. Separate local governments often collaborate with each other, and with environmental non-profit organizations to submit applications. These partnerships allow communities to better leverage state and local dollars, distribute project management duties, and preserve locally significant lands. As of July 1, 2003, the Trust and its

Matching and full grants for land acquisition projects are provided to communities through an annual competitive application cycle.

partners have contributed over \$625 million to local communities for land acquisition projects. Through this spirit of partnership, the Trust has provided applicants the opportunity to leverage local dollars with state funds to optimize conservation benefits.

Promoting Economic Revitalization The Trust also provides a unique opportunity to balance economic growth and resource protection. The Trust awards points in its evaluation process to projects meeting a variety of economic criteria, including those within Florida Main Street Districts, Front Porch Communities, designated low income communities, Rural Areas of Critical Economic Concern, and designated urban infill areas. Projects such as the Beach and Peach Urban Park in Jacksonville, the Duval Neighborhood

Park in Gainesville, and the Ombres Property in West Palm Beach promote a sense of urban renewal and encourage local businesses to continue their presence within these urban areas. To this end, the Trust awarded over \$8.5 million in 2003 to acquire projects within the urban core of Florida's communities.

Preserving Florida's Cultural Gems While the majority of the Trust's projects center on natural resource preservation and outdoor recreation, quite a number involve cultural resources as well. The Trust has helped preserve dozens of sites having historical significance at the local, statewide, or even national level. These sites include Princess Place, the oldest existing homesite in Flagler County and former home of an exiled Russian prince; Boystown/Camp Matecumbe, Miami-Dade County, once

the temporary home for Cuban refugee boys during the Pedro Pan Operation of the early 1960's; the Seminole War-era Fort King site in Ocala, destination of Major Francis Dade before he and his command were engaged by Chief Micanopy's Seminoles in 1835; and the "1912 Cortez Schoolhouse" in Manatee County and Parrot Jungle and Gardens in Miami-Dade County, both listed in the National Register of Historic Places. The Trust has helped acquire many projects with Native American sites as well. These projects include the unique crescent-shaped midden at the Paleo Hammock Project in St. Lucie County and the large midden at the Ais Lookout Point project in Palm Bay. Both of these sites contain archaeological evidence of over 1000 years of continuous human activity. Continuing its commitment to preserve the State's historic past, the

Trust awarded over \$31 million in 2003 to acquire projects that included cultural or historical resources.

#### Promoting Education

Understanding that education plays a vital part in resource conservation, the Trust places a priority on projects the possess educational attributes; awarding points for those projects that provide for

interpretative signs, educational classes, and even environmental education centers. Of particular interest are those projects that provide for coordination between state and local agencies in providing environmental education programs. An excellent example of this multi-agency coordination is the Legacy Program at Princess Place Preserve in Flagler County.

Developed by the Flagler

County School Board in conjunction with both the Flagler County Commission, and the St. Johns River Water Management District, this program provides on-site practical training in resource management to local "at-risk" high school students. The Trust awarded over \$43 million in 2003 to acquire projects that included education programs to serve Florida's communities.

#### The Year in Review

The Florida Communities Trust Governing Board met on November 14-15, 2002, to select the second group of Florida Forever projects for funding. The Board awarded over \$80 million in grants to 23 funded projects and contingent funding to six additional projects. In its fourteen year existence, the Trust has provided over \$400 million to local governments and non-profit organizations to acquire parks and open space.

In January 2003, Governor Bush appointed Ms. Colleen Castille to replace Steve Seibert as Secretary of the Department of Community Affairs. Mr. Seibert had served four years as Secretary and Chair. During his term,

Mr. Seibert was a very valuable board member and always provided thoughtful input at meetings and insightful direction to Trust staff. As Secretary, Ms. Castille serves as the Trust Governing Board's permanent chair.

In January 2003, Fred Streetman from Seminole County completed his term on the Governing Board. Mr. Streetman was the gubernatorial appointment

Over 150 representatives of local governments, environmental non-profit organizations, and the general public attended the workshops at their various locations. The Trust announced the opening of its third Florida Forever application cycle on March 27, 2003. When the cycle closed on June 10, the Trust had received 106 applications representing over \$179 million in grant requests. With local match, these



representing a former elected county official. In May 2003, Governor Bush appointed Ms. Sue Schmitt from Brevard County as his replacement for a term ending January 2007. In addition, Ms. Ginny Myrick was re-appointed to her third term on the Governing Board. Meeting Our Customers' Needs As part of the Trust's continuing commitment to provide improved year-round technical assistance, Trust staff conducted two sets of state-wide training workshops to assist prospective applicants in navigating the application process. The first series of workshops was held by Trust acquisition staff in December 2002. Workshop locations included Bradenton, Ft. Pierce, Palatka, and Tallahassee. Trust staff discussed obtaining appraisals for funded projects, the appraisal review process, contracting and negotiating, preparing project plans, and closing procedures. Over 50 representatives of local

applications total over \$290 million in local land acquisition projects. The Governing Board will consider these applications on October 2-3, 2003, with results reported in the 2003-2004 Annual Report.

Celebrating a Banner Mear

The Trust's most significant accomplishment in 2002-2003 was its completion, with local government and non-profit organization assistance, of over 77 real estate transactions for a record \$106.5 million, placing an additional 7,362 acres in public ownership. This was the largest amount of funding the Trust has provided in a year's time since the program's inception in 1989. When this sum was added to the \$103.5 million in matching funds provided by local communities, the Trust helped fund over \$209 million in land preservation projects throughout the state. Among the notable projects closed this year were Parrot Jungle and Gardens, Village of Pinecrest, that preserved one of Florida's oldest tourist attractions; Boystown/Camp Matecumbe project, Miami-Dade County, once the

temporary home for Cuban refugee boys during the Pedro Pan Operation of the early 1960's; Jacksonville-Baldwin Rail Trail Buffer, City of Jacksonville, a 625acre multi-parcel project that provides greenway linkage to sites along the rail trail: and Wall Springs Coastal Addition. Pinellas County, which preserved the last 87-acres of undeveloped privatelyowned land in Pinellas County.

Cooking to the Future

The coming years will be an exciting and challenging time for the Trust as it proceeds through future Florida Forever application cycles and strives to maintain the high standard set by this landmark year. In the coming months, Trust staff will revise Rules 9K-7 and 9K-8, F.A.C., to further increase efficiency and streamline current processes. The Trust will also investigate how it can marry the application and acquisition processes with current technology by providing web-based applications and acquisition contracts. The Trust's staff and its Governing Board look forward to enhancing relationships with communities, developing new



# Historic Project Sites

The Florida Communities Trust has worked with communities across the state on land acquisition projects that feature the unique historical flavor of Florida. Projects have varied from sites such as the 1912 Cortez Schoolhouse in Manatee County and the Old Chimney Property in the City of Pensacola, to Fort Brooke, the Seminole War site in the City of Tampa. We have highlighted a few of these projects and our successful partnerships with Florida's communities in our annual report. #### 93-006-P3A Walter Jones Historical Park City of Jacksonville

Located on the St. Johns River in the historic community of Mandarin, the 10acre Walter Jones Historical Park provides a brief glimpse into a rural way of life that is now long gone. Originally developed as a 30-acre citrus farm after the Civil War by retired Army Major William Webb, the property was eventually bought in 1911 by Walter Jones, one of Mandarin's first postmasters. His daughter Agnes lived on the property until shortly before her death in 1992. The historical park includes a "cracker-style" main house, a barn made of cypress wood, and a one thousand-foot pier once used to load fruits and vegetables on sailing ships bound for northern cities. The City of Jacksonville has developed a small nature trail. riverfront boardwalk, and picnic shelters on the site, and may incorporate the park into a day-long driving tour of other historic features in Mandarin.

#### 96-038-P7A Indian Riverside Park/FIT Site Martin County

Indian Riverside Park is located on the Indian River Lagoon in the Jensen Beach area of eastern Martin County. The 54acre site includes a National Register-listed 60-foot high prehistoric shell midden known locally as "Mount Elizabeth." Citrus planter Charles Racey originally acquired the property in the late 1880's and built his house on the shell midden. After the Racey house burned in 1920, the property was abandoned and eventually bought by Atlanta businessman Willaford Leach, who built a second house on the midden and the first in-ground pool in the Martin County. After Leach's death, the property was used as a boarding school and by the FIT Corporation as a marine-related educational institution. The grant from the Florida Communities Trust assisted Martin County in preserving the site's natural and cultural resources from commercial and residential development. The County plans to rehabilitate the Leach House for use as a museum and provide resourcebased outdoor recreation, including fishing, canoeing, and wildlife observation.

#### 98-009-P8A 1912 Cortez Schoolhouse and Preserve Manatee County

The 3-acre 1912 Cortez Schoolhouse and Preserve is located in a National Register Historic District in the Village of Cortez in Manatee County. The schoolhouse is the last of six such buildings built by the County in the early twentieth century, and was one of the few structures in the Village to survive a destructive hurricane that ravaged the area in 1921. The structure has been used as a school, an art studio, and was the private residence of the internationally known weaver Robert Sailors until his death in 1995. The grant from the Florida Communities Trust assisted Manatee County in preserving both the historic schoolhouse and adjacent mangrove swamp from residential development. Manatee County is currently restoring the building for use as a museum and community center.

#### 98-048-P8A Fort Brooke Park City of Tampa

Fort Brooke Park is a 2-acre greenspace located on Garrison Channel in downtown Tampa. The park is located near the original site of Fort Brooke, a Seminole War-era military post established in 1823. Named after its first commanding officer, Colonel George Mercer Brooke, the fort inadvertently played a major role in starting the Second Seminole War. The conflict was sparked in December 1835 when Major Francis Dade and his command left the Fort only to be attacked and decimated by Chief Micanopy's Seminole warriors. The U.S. government eventually sold the Fort, and its land was slowly incorporated over the years into the City of Tampa. The Fort's actual location was all but forgotten until workers accidentally uncovered its military cemetery while building a parking garage. The City of Tampa is currently restoring the site to improve water quality and wildlife habitat. Future plans include a riverwalk, interpretive displays, and wildlife observation areas.

#### 98-090-P8A Old Chimney Property City of Pensacola

The 3-acre Old Chimney Site is located near Escambia Bay on a section of U.S. Highway 90 designated in 1998 as Florida's first "Scenic Highway." Originally part of a 240-acre tract granted to Emanuel Bonify in 1813 by the Spanish Crown, the park represents a period of ante-bellum Florida history that was dominated by the lumber industry. The chimney is all that remains of a large lumber mill built by Henry Hyer in the mid-1850's. Confederate troops were forced to burn the mill when they evacuated Pensacola in March 1862 to prevent advancing Union forces from using it for lumber production. The grant from the Florida Communities Trust helped the City preserve an important cultural landmark whose protection was designated a key priority in the Scenic Highway's corridor action plan. The City has repaired an existing wrought-iron fence around the chimney ruins, built a nature trail, and installed interpretive signs and security lighting.

Withlacootchee Gulf Pathways
Town of Yankeetown

The 422-acre project is located immediately west of the Town of Yankeetown and borders the Gulf of Mexico in Levy County. The project expands and enhances a regional network of public conservation lands contiguous to the existing Florida Springs Coastal Greenway, Waccassassa Bay State Preserve, Big Bend Seagrass Aquatic Preserve and Cross Florida Greenway. The project also protects wildlife habitat and several significant historical and archaeological sites, including several Indian middens. The site includes cabbage palm flatwoods, hardwood hammock, scrubby flatwoods, saltwater marsh and pine flatwoods, which provide habitat for listed wading birds and other listed species. An existing house on the site will be converted into an education center to provide ongoing environmental education programs. Recreational improvements will include nature trails, a canoe/kayak launch and boardwalk. The total cost of this project was \$890,730.00.

# OO-O67-P10 Miracle Strip Park on the Sound City of Ft. Walton Beach

The 2-acre project is located on Santa Rosa Sound in Ft. Walton Beach.
Acquisition of the site will protect the last remaining tract of open space within the West Miracle Strip neighborhood and is a key element in the City's proposed, "Walton Walk" greenspace plan. The site's natural communities include scrub and a high-quality freshwater marsh. Recreational improvements will include a boardwalk, wildlife observation platforms, and a nature trail. The total cost of this project was \$453,425.00.

#### 00-082-P10 Russell Harber Landing Expansion City of Milton

The 3-acre project is located on the east bank of the Blackwater River within the historic City of Milton in Santa Rosa County. The project provides additional river access to area residents while protecting the project's remaining natural communities. Recreational improvements include nature trails, picnic pavilions, and a boat ramp. The total project cost was \$242,625.00.

#### 01-009-FF1 Moultrie Creek St. Johns County

The 23-acre project is located on a high bluff overlooking the confluence of Moultrie Creek and the Matanzas River (Intracoastal Waterway), just south of the City of St. Augustine. The project protects the water quality of Moultrie Creek, provides public access to the creek for outdoor recreation opportunities and protects wildlife habitat. Native vegetation on the site includes both upland hardwood hammock and saltmarsh communities. The project area is used as habitat by several listed animal species, including the gopher tortoise and various wading birds. The site also includes an Indian midden. Proposed recreational improvements include a nature trail, fishing dock, playground, picnic area and canoe/kayak launch. The total cost of this project was \$2,546,744.51.



#### O1-O8O-FF1 Cedar Key Cemetery Park City of Cedar Key

The 3-acre project is located in historic Cedar Key adjacent to the old city cemetery. Natural communities on site include a high-quality saltwater marsh, scrub, and coastal berm. Acquisition of the site protects a significant historical feature site and assits the City in improving its small park system. Recreational improvements will include nature trails, canoe launch, picnic pavilions, and additional water access. The total cost of this project was \$424,055.00.



The 102-acre project is located on the St. Johns River in a rapidly developing section of northern Duval County. The project provides recreational open space in an urban area, protects the site's remaining natural communities, and provides additional public access to the St. Johns River. The site includes xeric hammock, coastal berm, tidal marsh, and a shell mound. Recreational improvements will include nature trails, picnic pavilions and wildlife observation platforms. The total project cost was \$3,058,507.00.

#### 01-120-FF1 Jacksonville-Baldwin Rail Trail Buffer City of Jacksonville

The 1,417-acre project is located in western Duval County on both sides of the Jacksonville to Baldwin Rail Trail. The project will protect several historic sites including the Civil War-era Camp Milton site, provide access to the Rail Trail, and connect ecologically important public lands on the north and south of the Trail corridor. The site includes high quality upland pine forests, several dome swamps and seepage slopes, and wet flatwoods. Recreational will include nature trails, equestrian trail and wildlife observation platforms. The total project cost was \$4.058,234,40.



The 27-acre project is located between Beach and Anders Boulevards in southeast Jacksonville. The project provides recreational open space in a highly urbanized area while protecting the site's remaining natural communities. Recreational improvements will include nature trails, picnic pavilions and wildlife observation platforms. The total project cost was \$1,467,924.50.

#### 01-134-FF1 Cradle Creek Preserve City of Jacksonville Beach

The 36-acre project is the largest undeveloped parcel on the Intracoastal Waterway in the City of Jacksonville Beach. Acquisition of the site provides the City of Jacksonville Beach the only access to the county Blueways Network. The site includes a high quality freshwater marsh and a hydric hammock. Recreational improvements will include nature trails and a canoe launch. The total cost of this project was \$1,241,147.00.



Cradle Creek Preserve, City of Jacksonville Beach

The 2-acre project is located within the National Register Historic District of the unincorporated community of Melrose in Putnam County. The project provides a park within the historic downtown area for outdoor recreation opportunities and community gatherings. A historic house will be moved to the site and converted into a museum and educational center emphasizing historic and environmental education programs. Recreational improvements will include picnic areas and a multi use trail around the perimeter of the park. The total cost of this project was \$311,837.50.

#### 01-137-FF1 Tanglewylde Center Park Putnam County

The 25-acre project is located four miles northeast of the City of Palatka on a high bluff overlooking the St. Johns River. The project provides environmental education opportunities, contributes to extending a local greenway and provides access to the river. The site includes mesic flatwoods, upland mixed forest, bluff, blackwater stream and wetland communities. Recreational improvements to the site will include a nature trail, picnic area and museum. The total project cost was \$514,602.00.

## O1-141-FF1 Blues Creek Ravine and Fox Pond Alachua Conservation Trust

The 160-acre project is located in unincorporated Alachua County and within the City of Gainesville's urban service area. The Alachua Conservation Trust will manage the site as a public nature preserve. The project protects a large percentage of the floodplain and drainage basin for Blues Creek and its tributaries. The site includes a number of threatened plant species, including the crane-fly orchid and southern lady fern. Recreational improvements will include nature trails, picnic pavilions, and a playground. The total project cost was \$1,675,896.00.



# O1-152-FF1 St. Marks Headwaters (Booth Property) Leon County The 426-acre project is located in eastern Leon County and protects the headwaters of the St. Marks River, an Outstanding Florida Water. The project is a major element of Blueprint 2000, a locally adopted program of infrastructure improvements and land acquisition for

Blues Creek Ravine, Alachua Conservation Trust

Leon County and protects the headwaters of the St. Marks River, an Outstanding Florida Water. The project is a major element of Blueprint 2000, a locally adopted program of infrastructure improvements and land acquisition for floodplain preservation and ecosystem protection. The site includes intact bottomland hardwood forests, freshwater marshes, seepage streams, and active sinkholes. The total cost of this project was \$2,338,817.00.

#### O1-153-FF1 Coral Bean Addition to Under the Oaks Park City of Parker

The 12-acre project is located within the City of Parker on East Bay in southern Bay County. The project is located on the site of the former "Baptist Camp," a historic recreation area used by City residents since the 1900's. This project expands the adjacent Under the Oaks Park, improves surface water quality in East Bay, and protects an Indian shell midden. Recreational improvements will include a nature trail, picnic pavilions, swimming area, and canoe launch. The total project cost was \$1,119,030.00.



#### O1-O13-FF1 Palm Coast Greenway City of Palm Coast

The 57-acre project borders the St. Joe Canal and Palm Coast Parkway corridor within the City of Palm Coast. The project provides a trailhead for the City's bike trail and provides a linkage to the Flagler County Coastal Greenway network. The project will enhance the wetlands and water quality of the adjacent St. Joe Canal. Native vegetation on the site includes pine flatwoods, hardwoods and wetland communities. Recreational improvements will include a nature trail, playground, picnic pavilion, canoe/kayak launch and shuffleboard courts. The total cost of this project was \$8,321,013.90.

#### 00-042-P10 Clam Bayou City of St. Petersburg

The 20-acre project is located in the southern section of the City of St. Petersburg on Clam Bayou. The project will enhance the water quality of Clam Bayou and protects the habitat of a remnant coastal wetland ecosystem in a highly urbanized area. The City will remove invasive exotic vegetation from the site and replant the area with native vegetation. An interpretative center for the Clam Bayou Nature Preserve will also be developed on the project site. Recreational improvements will include a canoe/kayak launch, hiking tails and boardwalks. To date, the total cost of this multi-parcel project is \$1,651,992.40.

#### 01-015-FF1 Kapok Wetland and Floodplain Restoration City of Clearwater

The 37-acre project is located within the City of Clearwater in Pinellas County. The purpose of the project is to better manage stormwater within a flood-prone community and provide an urban park. Wetlands will be created and restored, and nature trails and boardwalks will be provided. The City's Park and Recreation Department will offer environmental education programs at the project site. Future plans include a linkage to the Clearwater Trail, a locally designated recreational trail. The total cost of this project was \$7,245,725.00.

#### 01-029-FF1 Eagle Nest Cornerstone Park City of Orlando

The 100-acre project is located in southwest Orlando and borders Lake Fran is surrounded on three sides by the 521acre county-owned Eagle Nest Park. An elementary school is proposed for construction adjacent to the western boundary of the project site. The project will expand a city-owned park, provide passive and active outdoor recreation facilities and close the gap in a local bike

trail. The site consists of remnant mesic flatwoods. Recreational improvements will include a multi-use trail, picnic pavilion, open play areas and lighted baseball, softball and soccer fields. The total cost of this project was \$1,230,337.87.

#### 01-048-FF1 Triple Creek Greenway Hillsborough County

The 751-acre project is located in central Hillsborough County immediately north of the county-owned Balm Boyette Scrub Preserve. The project expands an existing wildlife corridor and trail system in the central portion of the County and protects listed animal species habitat. The site includes a mix of native communities, including basin marsh, bottomland forest, upland mixed forest and mesic flatwoods, which provide habitat for the gopher tortoise, Sherman's fox squirrel, sandhill crane, and tri colored heron. Recreational improvements will include nature trails, a BMX bicycle track, playground and picnic area. The total cost of this project was \$2,281,203.08

#### 01-049-FF1 Town 'n Country Preserve Hillsborough County

The 127-acre project is located in northwestern Hillsborough County. The

> project expands the Upper Tampa Bay Trail, which is part of the Hillsborough County Greenway System. Natural communities on site include cypress/hardwood swamp and pine flatwoods, which provide habitat for the gopher tortoise and several wading bird species. The adjacent Alonso High School will use the site for environmental education programs. Recreational improvements will include a picnic pavilion, hiking trails and equestrian trails. The total cost of this project was \$2,208,733.77.

#### 01-056-FF1 Kelly Park Addition Orange County

The 109-acre project is located in northwestern Orange County, adjacent to a previously funded Florida Communities Trust project Kelly Park Expansion, (92-010-P2A). The site is located adjacent to the West Orange Trail and Wekiva River Corridor Greenway. The project includes an environmental education center and a multi-use trail for bikers, skaters and walkers. The site includes wetlands and a sandhill community that provide habitat for gopher tortoises, fox squirrels and various listed bird species. Recreational improvements will include a playground, wildlife observation area, picnic areas and volleyball courts. The total cost of this project was \$1,039,225.10.

#### 01-071-FF1 Doris Leeper Spruce Creek Preserve Volusia County


The 80-acre project site is located on Spruce Creek adjacent to the 2,000 acre state-owned Doris Leeper Spruce Creek Preserve in Volusia County. The project protects the water quality of the creek, and important archaeological features. The site includes pine flatwood, oak hammock and saltmarsh communities, which provide habitat for the gopher tortoise and listed wading birds. An existing house will be converted into an education center and meeting facility for the purpose of providing ongoing environmental education programs. Proposed recreational improvements include a multi use trail system, picnic areas, fishing pier and canoe/kayak launch. The total cost of this project was \$1,651,100.00.

#### 01-129-FF1 Town Center City of Port Orange

The 0.9-acre project is located on the Halifax River (Intracoastal Waterway) in the City of Port Orange in Volusia County. The project extends a riverwalk along the Halifax River, expands an adjacent cityowned park and protects the water quality of the Halifax River. The site includes a mangrove fringe along the river shoreline, which provides habitat for listed wading birds. Recreational improvements will include a picnic area, fishing pier and wildlife observation platform. The total cost of this project was \$296,275.50.

#### 01-143-FF1 Shingle Creek Recreational Preserve North Osceola County

The 160-acre project is located in Osceola County on Shingle Creek, a tributary of Lake Tohopekaliga and the Kissimmee River, just north of State Road 192. Acquisition of the project site provides an important addition to an existing 182-acre county-owned park, which was a previously funded Florida Communities Trust project Shingle Creek Recreational Preserve. (98-065-P8A). The site includes mesic oak flatwoods, cypress swamp, and freshwater marsh, which provides habitat for the gopher tortoise. Sherman's fox squirrel, sandhill crane and white ibis. Existing historic homes on the site will be the focal point of the park with the Osceola County Historical Society and Kissimmee Valley Audubon Society providing on-going historic and environmental education programs on the site. Recreational improvements will include a playaround, nature trails, boardwalks, canoe/kayak trails and volleyball court. The total cost of this project was \$5,130,835.00.

#### 01-144-FF1 Historic Bayview Environmental Park City of Clearwater

The 4.3-acre project is located on Tampa Bay in eastern Clearwater in Pinellas County. The park is located in the historic Bayview area and contains two archeological sites. Environmental education programs offered at the site will emphasize the site's historic significance. More than 100 large live oak trees will be preserved and protected. Park amenities will include a picnic pavilion, wildlife observation platform, and interpretive signs. The total cost of this project was \$1,917,015.00.

#### 02-073-FF2 Fish Hawk Creek Preserve Hillsborough County

The 934-acre project is located in central Hillsborough County along Fish Hawk Creek and is adjacent to lands owned by the County and the Southwest Florida Water Management District. The project protects the water quality of the creek, expands a wildlife corridor and protects archaeological features. The site includes mesic flatwoods, scrub, sandhill, mixed upland forest and floodplain forest communities that provide habitat for the

gopher tortoise, scrub jay and listed wading birds. Recreational improvements will include picnic pavilions, nature trail, basketball court and exercise trail. The total project cost was \$5,129,189.60.

#### 02-093-FF2 Fort Brooke - Phase III City of Tampa

The 2.5-acre project is located in downtown Tampa on Garrison Channel adjacent to two previously funded Florida Communities Trust projects, Fort Brooke Park (98-048-P8A and Fort Brooke Park Addition (00-045-P10). The three phases of the park total 6.34 acres. Fort Brooke was a U.S. military installation from 1823 to 1888. The project provides open space in an intensely developed urban core area and contributes to the creation of a riverwalk through the downtown area connecting downtown Tampa with the County's greenway network. The City will replant the channel shoreline with native vegetation and landscape the uplands to provide foraging habitat for migratory songbirds. Recreational improvements will include a walking and fitness trail, canoe/ kayak launch, bocce ball court and playground. The total cost of this multiparcel project was \$19,510,945.00.

#### O2-O35-FF2 Wall Springs Coastal Addition II Pinellas County


The 84-acre project is located on the Gulf of Mexico in unincorporated Palm Harbor community in northwestern Pinellas County. This property was the last significant privately-owned undeveloped land in the built-out county. The site is an addition to the county-owned Wall Springs Park and a previously funded Florida Communities Trust project, Wall Springs Coastal Addition (01-022-FF1). Several natural habitats will be protected including mesic flatwoods, salt marsh, and sandhill.

The natural communities on site provide habitat for listed species such as the gopher tortoise and Sherman's fox squirrel. The project will provide a welcome center, boat launch, canoe/kayak launch, picnic shelters, nature trail, volleyball, horseshoe and playground area. Environmental education signage and programming will be provided. The project also offers a destination point along the Pinellas Trail. The total cost of this project was \$21,465,530.00.

#### 98-006-P8A Grassy Point Preserve City of Holmes Beach

The 37-acre project is located in the City of Holmes Beach on the shores of Sarasota Bay and contains the last remaining large parcel of native vegetation in the City. The project will be developed as a nature preserve. The wetland and upland communities on the project site, in conjunction with other wetland communities along Sarasota Bay, will support the recovery and maintenance of a significant population of listed wading birds. Recreational facilities will include a kayak and canoe launching site, nature trails, boardwalks, observation platforms, and an urban wilderness canoe trail. The cost of this multi-project parcel project was \$359,945.51.

#### 99-022-P9A Poppleton Creek City of Stuart

The 25-acre project, is located in the City of Stuart along Poppleton Creek in Martin County. Acquisition of the site preserves native habitat in the Poppleton Creek floodplain and uplands, improves storm water quality, and increases public access to Poppleton Creek. Natural communities include sand pine scrub, scrubby flatwoods, wet prairie, and mangrove swamp. The City plans to create a retention lake and flow-through marsh to improve the quality of stormwater. Recreational improvements will include a nature trail, observation platform, canoe/ kayak landing, and playground. The total cost of this project was \$1,026,285.81.

#### 00-019-P10 Manasota Scrub Preserve Sarasota County

The 108-acre project is located in southwestern Sarasota County. It protects eight native habitats including dry prairie, scrub, scrubby flatwoods and depression marsh which provide important habitat for the threatened Florida scrub jays that inhabit the site. The project will offer nature-based recreational opportunities

including a nature trail with interpretive signage, wildlife observation deck, and picnic area. To date, the total cost of this multi-parcel project is \$2,666,385.10.

#### 00-022-P10 Tree Island Park Miami-Dade County

The 120-acre project is located in west central Miami-Dade County. The project preserves 70 acres of everglades wetland prairie and tree islands while providing 50 acres of recreational facilities for a rapidly developing urbanized area. The project will also preserve a significant archeological site. Melaleuca trees and other exotic vegetation will be removed and the area replanted with native vegetation. The prairie habitat will be maintained by prescribed burning that will mimic naturally-occurring historic everglades fires. Recreational facilities include soccer fields, ball fields, tennis courts, basketball courts and a roller hockey arena. Interpretive displays will be provided in both English and Spanish. The total cost of this project was \$8,187,461.50.

# OO-O53-P1O Pinecrest Gardens (Parrot Jungle and Gardens Acquisition) City of Pinecrest

The 13-acre project is located in the City of Pinecrest in southeastern Miami-Dade County. The property was once the home of the Parrot Jungle and Gardens, a popular tourist attraction that opened in 1936 and which recently relocated to Watson Island. The property is now designated as an historic site showcasing it's roots as a tourist attraction, unique botanical features, and limestone architecture dating back to the mid-1930's. The park will offer sub-tropical botanical gardens and paths, picnic areas, a playground, and educational programs. The total cost of this project was \$8,044,274.80.

#### 00-055-P10 Richardson Property City of Wilton Manors

The 5.4-acre project is located along the South Fork of the Middle River in the City of Wilton Manors in Broward County. Acquisition of the site protects the native tree canopy and a historic house. The house will be preserved and used as a museum and cultural and educational resource center. Recreational improvements will include a picnic shelter, playground, trails, and canoe/kayak launch. The total project cost of this project was \$3,891,477.50.

#### 00-071-P10 Pembroke Pines Preserve Expansion City of Pembroke Pines

The 8.5-acre project is located in the City of Pembroke Pines in western Broward County. It is adjacent to other publicly and privately-owned lands which are being restored to Everglades wetland habitats. It is also adjacent to a City park, which offers a nature center, picnic area, nature trails, boardwalk, and canoeing. The freshwater wetlands at, the project site, will be restored by removing invasive exotic plants, grading the site to wetland elevations, and planting appropriate native vegetation. The total cost of this project was \$1,421,900.00.

#### 01-008-FF1 Pocono Trails Preserve Sarasota County


The 9.8-acre site is located in western Sarasota County on Dona Bay. The project site is one of the few remaining large undeveloped bay-front parcels between the cities of Sarasota and Venice. The project protects scrub, hammock, and wetland communities which offer habitat to the gopher tortoise and Florida scrub jay. The preserve will offer nature-based recreational activities such as hiking, wildlife observation, canoeing and kayaking. The total project cost was \$1,076,132.15.

#### 01-018-FF1 Bayshore Linear Park Charlotte County

The 9.4-acre project is located on the shores of Charlotte Harbor near the mouth of the Peace River in Charlotte County. The project is a key element in the urban revitilization project developed by the County for this area. Facilities proposed for the site include picnic pavilions, walking trails, fishing piers, a playground and water play area. Educational signage and programming will highlight the historical significance of the area. To date, the total cost of this multi-parcel project is \$932,467.47.

#### 01-023-FF1 Westmoreland RiverPark City of Port St. Lucie

The 32-acre project is located along the North Fork of the St. Lucie River in the City of Port St. Lucie. The primary purpose of the project is to protect the riverine corridor. Natural communities on site include scrubby flatwoods, tidal swamp, scrub and baygall. Recreational improvements will include a canoe launch, picnic shelters, and nature trail. The site also provides public access to the North Fork of the St. Lucie River for fishing. The total cost of this project was \$2.731,726.68.




#### O1-O24-FF1 Cedar Point Park Charlotte County

The 17-acre project is located on the shore of Oyster Creek near Lemon Bay in west Charlotte County. The project expands the adjacent Cedar Point Park and two projects previously funded by Florida Communties Trust, Oyster Creek Park (98-026-P8A) and San Casa Addition (99-064-P9A). The site consists predominantly of natural communities including hydric and mesic pine flatwoods, and a mangrove fringe along the shore. The project provides additional nature trails and a wildlife observation platform to the existing parks and will serve as an important trail connector to the adjacent Oyster Creek Park. The total cost of this project was \$983,974.00.

#### 01-026-FF1 South County Regional Park Charlotte County

The 90-acre project is located in central Charlotte County near the City of Punta Gorda. The site will be developed as a regional park and will provide recreational facilities in a low-income community. Proposed facilities include soccer fields, baseball fields, tennis courts, basketball courts, picnic pavilions, walking trails, and an outdoor pool. Environmental education programs will be offered at the site. The total cost of this project was \$517,233.25.



#### 01-028-FF1 Curry Creek Preserve Sarasota County

The 80-acre project is located within the City of Venice in Sarasota County. The project provides additional acreage to an adjacent city-owned 15-acre preserve. The project preserves wetlands, hammocks, flatwoods and scrubby flatwoods, which provide habitat for the Florida scrub jay, gopher tortoise, and eastern indigo snake. Passive recreation and environmental education will be provided including nature trails with interpretive signage and a wildlife observation deck. The total cost of this project was \$3,259,244.10.

#### 01-031-FF1 Caloosahatchee Creeks Preserve Lee County

The 1,116-acre project is located northeast of Ft. Myers on the Caloosahatchee River in Lee County. Acquisition of the project protects the largest remaining undeveloped parcel along the river in Lee County. The preserve contains a mix of upland forests including a 161-acre scrub community, swamp, freshwater marshes and saltwater marsh. The preserve provides habitat for listed wading birds and gopher tortoises. The County will restore the upland habitat by removing spoil berms, invasive exotic plants, and replanting the disturbed area with native plants. Recreational improvements will include nature trails, canoe/kayak trails,

picnic facilities, and wildlife observation areas. The total cost of this project was \$6,350,744.34.

#### 01-033-FF1 North Jupiter Flatwoods Palm Beach County/Town of Jupiter

The 132-acre project is located within Palm Beach County in the Town of Jupiter adjacent to the Jupiter Community Park. The project preserves a natural area and enhances an existing community park. Natural communities include mesic and wet flatwoods. The site contains habitat for the gopher tortoise, a species of special concern. Recreational improvements will include a nature trail and wildlife observation pavilion. The total cost of this project was \$2,139,206.02.

#### O1-O35-FF1 Overlook Scrub Natural Area Town of Hypoluxo

The 97-acre project is located in the Town of Hypoluxo within Palm Beach County. Acquisition of the site preserves approximately 25 percent of the Town as a natural area, provides a recreational area adjacent to the Town Hall and preserves rare scrub habitat. The site is also home to several endangered Florida scrub-jay families. Recreational improvements will include a nature trail and wildlife observation tower. The total cost of this project was \$4,310,506.61.

#### 01-037-FF1 Acreage Pines Natural Area Palm Beach County

The 128-acre project is located adjacent to Acreage Community Park in unincorporated Palm Beach County. The project site provides educational and recreational opportunities for the community and preserves a unique natural area in the County. Acreage Pines Elementary School is adjacent to the site and students will be able to directly access the trail system and use the site for environmental education classes. Natural communities include wet prairie, hydric hammock, mesic flatwoods, wet flatwoods, and depression marsh. Recreational improvements will include a playground, baseball fields, softball fields, picnic facilities, hiking trails, and a wildlife

observation platform. The total cost of this project was \$925,868.40.

#### 01-039-FF1 Pond Apple Park City of Sanibel

The 8.6-acre project is located on Sanibel Island in Lee County. The acquisition of this property furthers the City's aggressive program of protecting environmentally sensitive lands on this barrier island. The site contains tropical hardwood hammock and barrier island freshwater wetlands, which are habitat for species such as listed wading birds, Sanibel Island rice rat, and numerous migratory birds. Invasive exotic vegetation will be removed and appropriate native vegetation will be planted. The preserve will contain picnic facilities, nature trails, and provide an additional destination point along the Sanibel Island Bike Trail. The site will be managed in cooperation with the Sanibel-Captiva Conservation Foundation and the U.S. Fish and Wildlife Service. The total cost of this project was \$5,597,000.00.

# O1-O43-FF1 Deering Estate-Cutler Glade Rehydration Addition Miami-Dade County

The 9.6-acre project is located in southeastern Miami-Dade County. The project is an addition to the Deering Estate, and a previously funded Florida Communities Trust project, the Deering

Estate Coastal Wetland Addition (91-001-P1A). Acquisition of the site provides a necessary link to enable land managers to introduce water flow from the nearby canal back into the historic freshwater glade, which flows through the Deering Estate property. Tropical hardwood hammock and freshwater wetlands on the project site will be restored. The site will feature an education building, nature trails, and picnic areas. The total cost of this project was \$1,417,738.00.

#### O1-O47-FF1 Plantation Central Open Space City of Plantation

The 199-acre project is located within the City of Plantation in Broward County. The City will re-develop an abandoned golf course in an environmentally sensitive manner and provide additional park facilities to the community. The project will be landscaped with native vegetation and wetlands will be created to provide habitat for wading birds. An Indian midden on the site will also be protected. Other recreational facilities to be provided at the site include picnic pavilions, nature trails, and a playground. The total cost of this project was \$7,338,140.00.

#### 01-055-FF1 Hallstrom Farm Indian River County

The 99-acre project is located along Dixie Highway in southern Indian River County. The project will preserve the Old Hallstrom Farmstead that surrounds the historic Hallstrom House. The historical house will be managed by the Indian River County Historical Society. The project will preserve aspects of the old working farm, including agricultural fields and six historic out buildings. The site will be used by the Indian River County Historical Society for educational classes to be held throughout the year. The acquisition of the property also provides for the preservation and restoration of approximately 80 acres of imperiled scrub habitat. Nature trails on site will link to a planned recreational trail system along the County's canals. The County will construct a replica of an early pioneer pole barn to serve as a classroom and picnic area. The total cost of this project was \$1,643,164.00.



#### 01-058-FF1 North Village Park Islamorada, Village of Islands

The 3.6-acre project site is located in the newly incorporated Village of Islamorada, on Plantation Key in the northern Florida Keys. The project provides urban open space along U.S. Highway 1 within a built-up urban activity center. The site is also adjacent to the Overseas Heritage Trail, a planned pedestrian/bicycle trail system extending from Key Largo to Key West. The Village will develop the site as both a trailhead facility and a destination point on the Overseas Heritage Trail. Recreation facilities will include a canoe launch, walkways, and picnic pavilions. The total cost of this project was \$528,250.00.

#### 01-067-FF1 Sheraton Plaza Preserve St. Lucie County

The 68-acre project is located in northeastern St. Lucie County near the City of Fort Pierce. The project preserves habitat for the endangered Florida scrubjay, expands an existing county park, and assists in the development of a county greenway system. The site contains mesic flatwoods and scrubby flatwoods communities. Recreational improvements will include hiking trails and a wildlife observation platform. The total cost of this project to date is \$773,735.00.

#### 01-069-FF1 Indrio Scrub Preserve St. Lucie County

The 23-acre project is located along U.S. Highway 1 in northern St. Lucie County. Acquisition of the site protects the endangered plant species, Lakela's Mint, and provides recreational opportunities. The project is the first publicly–owned site that contains Lakela's Mint. The site also contains scrub oak and sand pine scrub communities, which provide habitat for listed species including the scrub lizard and gopher tortoise. Recreational improvements will include nature trails and a canoe launch. The total cost of this project to date is \$487,455.00.

#### 01-074-FF1 Pleasant Oceanside Preserve City of Deerfield Beach

The 0.7-acre project is located on the Atlantic Ocean in the City of Deerfield Beach in Broward County. The project will include a boardwalk connecting the City's North Pavilion Park and the International Fishing Pier and will assist the City in attaining it's goal of providing one mile of public beachfront boardwalk. The City plans to enhance the beach dune vegetation on the site and provide beach observation platforms, interpretive signs, picnic facilities, and beach volleyball. The total cost of this project was \$3,108,646.50.



#### 01-075-FF1 Ancient Oaks St. Lucie County

The 48-acre project is located in the historic community of White City in eastcentral St. Lucie County. The project preserves some of the largest and oldest trees remaining in the urban area and provides multiple recreational opportunities. Natural communities on site include hydric hammock and mesic flatwoods. Recreational facilities will include trails, playground, picnic pavilions, and baseball fields. The total cost of this project was \$857,302.76.

#### 01-081-FF1 The Bonair Beach (Gomez Tract) Town of Jupiter Island

The 46-acre project is located directly north of the Hobe Sound Wildlife Refuge on Jupiter Island in Martin County. The project further the creation of Barrier Island Greenway that stretches over seven miles in length. Manaroves and coastal strand natural communities are found on site. The Town will restore the hydrological connections between the Indian River Lagoon and the Bonair Beach site. Recreational improvements will include a hiking trail and wildlife overlook areas. The total cost of this project was \$8,013,344.00.

#### 01-100-FF1 **Ombres Property** City of West Palm Beach

The 3.7-acre project is located along the Intracoastal Waterway and the Lake Worth Lagoon within the City of West Palm Beach. The project provides greenspace and access to the Intracoastal Waterway in an area adjacent to low income and urban redevelopment neighborhoods. The site will be landscaped with native vegetation and provide an open space park for the adjacent Pleasant City - Northwest Front Porch Community. Recreational opportunities will include a picnic pavilion, playground, volleyball court, and a canoe/ kayak launch that provides access to Peanut Island and the historic Kennedy Bunker. The total cost of this project was \$2,422,757.00.

#### 01-113-FF1 Sheridan Street ESL Addition **Broward County**

The 5.4-acre project is located in the City of Hollywood and is adjacent to Broward County's West Lake Park. The County plans to re-grade and restore the project site to a mangrove, tidal pool, and mudflats habitat. A planned nature trail will connect to the adjacent natural areas. The total cost of this project was \$2,104,794.75.

#### 01-118-FF1 Miramar Pinelands Environmentally Sensitive Land Addition City of Miramar

The 52-acre project is located within the City of Miramar in Broward County and is adjacent to the 98-acre Miramar Pineland Environmentally Sensitive Land. The project protects a pine flatwood and wet prairie community and provides environmental educational opportunities. The City and County plan to build a nature center on the project site and hold ongoing educational classes. Recreational improvements will include a nature trail and wildlife observation area. The total cost of this project was \$13,876,845.00.

The 78-acre project is located along the Indian River Lagoon within the Town of St. Lucie Village. Acquisition of the site protects almost one-half mile of the Indian River Lagoon shoreline and natural resources on site. The project also provides recreational opportunities for the Village. Natural communities include hydric hammock, tidal swamp, marsh and scrub. Recreational improvements will include a canoe launch, nature trails, volleyball court, horseshoe pit, and picnic area. The total cost of this project to date is \$2,203,192.00.

#### 01-098-FF1 North Fork of the St. Lucie River -Phase 2 St. Lucie County

The 60-acre project is located along the North Fork of the St. Lucie River within the historical area of White City. The project closes a gap within the North Fork of the St. Lucie River Greenway and within the boundaries of the North Fork of the St. Lucie River Aquatic Preserve. Natural communities on site include floodplain forest, hydric hammock, and floodplain swamp. Recreational improvements will include a canoe launch and nature trails. The total cost of this project to date is \$616,832.65.

#### 01-133-FF1 Delaplane Peninsula Blueway Martin County Land Trust

The 51-acre project site is located in Martin County along the South Fork of the St. Lucie River and protects over 9,400 feet of shoreline. The County and the Land Trust will jointly develop the site as an urban nature preserve. The project furthers county, state and local efforts to create a 10-mile conservation greenway and wildlife corridor along the South Fork of the St. Lucie River. The site contains mangrove swamps, hydric hammocks and mesic flatwoods. Invasive exotic vegetation will be removed and the area replanted with native vegetation. Recreational facilities will include nature trails, wildlife observation platforms, picnic pavilions, and a canoe/kayak launch. The total cost of this project to date is \$4,707,264.80.

#### O2-O27-FF2 Red Bug Slough Sarasota County

The 72-acre project is located just south of the City of Sarasota. The project protects water quality and upland and wetland communities that provide habitat for listed wading birds. The project also provides access to a regional greenway along the Phillippi Creek corridor. Recreational improvements will include a nature/fitness trail. picnic pavilions, fishing/ observation platform and playground. The total project cost was \$4,096,482.00.

#### 02-034-FF2 Wilson Family Park Sarasota County


The 50-acre project site is located east of the City of Sarasota, near Interstate 75. The site is one of the last remaining natural areas west of Interstate 75. The project protects oak scrub, dry prairie, pine scrub, oak hammock and wetland communities that provide habitat for gopher tortoises and wading birds. Environmental education programs will be provided on the site and recreational improvements will include nature and fitness trails, picnic pavilions and wildlife observation platforms. The total project cost was \$6,032,817.25.

#### O2-71-FF2 North Fork of the St. Lucie River Phase III St. Lucie County

The 93-acre project site is located along the North Fork of the St. Lucie River near the City of Port St. Lucie. The primary purpose of the project is to enhance the St. Lucie River Greenway and to help restore the North Fork of the St. Lucie River, an Outstanding Florida Waterway and State Aquatic Preserve. Natural communities on site include hydric hammock, floodplain, swamp, floodplain forest, and mesic flatwoods. The project site also provides habitat for the bald eagle, gopher tortoise, woodstork and other listed species. The County plans to create a park like stormwater lake facility in an old 14-acre citrus grove to improve the quality of stormwater reaching the North Fork of the St. Lucie River. Recreational improvements will include a nature trail and canoe docks. The total cost of this project to date is \$247,760.00.

# O1-119-FF1 Boystown/Camp Matecumbe Miami-Dade County

The 21-acre project is located in the West Kendall area of Miami-Dade County. The project site will protect this culturally significant area that served as a temporary shelter for unaccompanied Cuban refugee boys as part of the "Operation Pedro Pan" program operated by the Catholic Welfare Bureau in the 1960's. The environmental and historic significance of the site will be interpreted for the public with educational programs and displays. The site will also provide open space for recreation in a rapidly developing area. Existing facilities will be restored and upgraded including dormitories for camping, an activity center, mess hall, ball fields, playground and swimming pool. Picnic shelters and additional basketball courts will be added. The project will add 3.3 acres of globally-imperiled pine rockland to the adjacent 78-acre County-owned Boystown Preserve. The total cost of this project was \$2,483,105.22.




