



Thaddeus Cohen was named by Governor Jeb Bush as Secretary of the Department of Community Affairs on March 10, 2004. Secretary Cohen has over 30 years of experience in architecture, urban design and community planning. He has provided economic and development strategies for public and private clients. His areas of design expertise include urban planning, health care development, educational, recreational and water treatment facilities. In his approach to planning Secretary Cohen will place specific importance on the need for comprehensive planning in order to achieve a working relationship between public and private sectors.

Secretary Cohen has a history of proactive involvement in his community through professional and community organizations. Secretary Cohen is the past chairman of the Council for Black Economic Development of Broward County; past chairman of the Commission on Affordable Housing for Palm Beach County, a former member of the board of directors of the Broward Alliance. and a former Broward Workshop member. On a state level he served on the boards of 1000 Friends of Florida and the American Institute of Architects Florida Chapter.

Prior to his appointment as DCA Secretary, he was asked by Governor Jeb Bush to serve on the 2000 Growth Management Study Commission. He quickly garnered the respect and admiration of his fellow board members establishing himself as a creative thinker and charismatic speaker.

Born in California and raised in New Jersey Secretary Cohen attended Kent State University in Ohio where he graduated with a Bachelor of Arts degree in Architecture. He currently resides in Tallahassee, Florida with his wife, daughter and grand daughter.

As Secretary of the Department of Community Affairs, Mr. Cohen fills the requirement of serving as the permanent chair of the Florida Communities Trust Governing Board.

Virginia D. "Ginny" Myrick is a senior policy

advisor with Holland & Knight for new business development and government relations, focusing on local government. She represents several of the largest underground utility rehabilitation companies in North America

Ms. Myrick served from 1987-1994 as a County Commissioner on the Jacksonville, Florida City Council. In addition to sponsoring noteworthy legislation, she distinguished her tenure by emphasizing extensive urban park restoration using public/private contributions and was one of the founders of the I.M. Sulzbacher Center for the Homeless, chairing that board for two years. She also was a partner in a private corporate meeting planning company for seven years while serving on the City Council.

While serving as the director of state legislation and a member of the executive staff for Jacksonville Mayor John Delaney from 1994-1998, Ms. Myrick managed Jacksonville's team of lobbyists involved in policy and legislative issues in the Florida Legislature.Following the mayor's executive staff position, Ms. Myrick served as vice president of government affairs for the Jacksonville Port Authority. She worked on the federal, state and local leaislative levels, focusing particularly in tax, brownfields, infrastructure, and transportation and international trade issues for both the Jacksonville airport and seaport.

Ms. Myrick is a former vice chair of the Florida Humanities Council and has chaired many local non-profit groups. She currently serves as chair of the North Florida Trust for Public Land's Advisory Board and as vice chair of the Florida Community Trust as an appointee of Governor Jeb Bush.

Ms. Myrick earned her bachelor's and master's degrees in communications from the University of Central Florida and did some doctoral work at Texas Tech University. She is a Fellow in Government from the University of North Florida.



Albert Alfonso currently serves as President and was a founding principal of Alfonso Architects in Tampa. Named as Small Business of the Year by the Tampa Chamber of Commerce in 1999, the firm today counts among its clients, Florida Power and Light, the State University System of Florida, the New York Yankees, the City of Tampa, Publix Groceries, Hillsborough Community College, Time Warner Communications, the Tampa Police Department and Target stores among others.

Mr. Alfonso is also a member of the American Institute of Architects, Ybor Rotary, and was a member of the City of Tampa Architectural Review Committee from 1994-1997. Born in Cuba, Mr. Alfonso moved to Tampa in 1960. He attended the University of Florida and received a Bachelor of Arts in Architecture in 1981 and a Master of Arts in Architecture.

Mr. Alfonso is serving a four-year term that expires on January 31, 2005. He fills the required appointment of a representative of the development community.



On February 13, 2004 Governor Jeb Bush appointed Colleen M. Castille as Secretary of the Florida Department of Environmental Protection. As Secretary, Ms. Castille oversees Florida's environmental regulatory and law enforcement programs, the acquisition and management of public lands, including Florida's award-winning state parks, and the development and regulation of Florida's water resources through the State's water management districts.

Before this appointment, Ms. Castille served as Secretary of the Florida Department of Community Affairs where she supervised community growth, environmental assessment, disaster planning, community rehabilitation, local and state comprehensive planning and affordable housing provisions. During her tenure, Secretary Castille brought local government support for improved wastewater management, land conservation acquisition, and the protection of natural habitat in the Florida Keys. Governor Bush also appointed her to the Wekiva River Basin Coordinating Committee, where she served as vice chair. She was named 2003 Conservationist of the Year by the Audubon Society.

From 1999 to 2003, Ms. Castille was the chief cabinet aide for Governor Bush, specializing in environmental issues and directing the Florida Cabinet's historic restructuring. She researched and helped develop Cabinet policy on Local Government Comprehensive Plans, Areas of Critical State Concern, Developments of Regional Impact, water-use Disputes and Community Development Districts.

A Florida State University graduate, Ms. Castille holds an undergraduate degree in International Affairs. She and her husband enjoy the beauty of Florida's wilderness as avid kayakers, hikers and outdoor enthusiasts.

Ellen Lindblad is the Executive Director of the CREW Land & Water Trust, a non-profit organization formed as a public/private partnership to protect the 60,000 acre Corkscrew Regional Ecosystem Watershed that spans Lee and

Sue Schmitt, a former Brevard County Commissioner, currently resides in Melbourne, where she is a business development and marketing consultant.

During her tenure as County Commissioner, the first comprehensive land use plan was adopted, she was also instrumental in the creation and passage of the Brevard County Beach and Riverfront Acquisition Program referenda.

Ms. Schmitt has served on the boards of the East Central Florida Planning Council. Metropolitan Planning Organization, Florida Association of County Commissioners, and the Florida League of Cities.

Ms. Schmitt fills the required appointment of a former elected county official.

Mission & Accomplishments

What is the Florida Communities Trust?

The Florida Communities Trust is a state land acquisition grant program housed within the Florida Department of Community Affairs. The Trust provides funding through an annual competitive grant cycle to local governments and non-profit environmental organizations to acquire community-based parks, open space, and greenways. These projects must further outdoor recreation and natural resource protection needs identified in local government comprehensive plans. The Trust is governed by a six member board that includes the Secretary of the Department of Community Affairs (who serves as permanent chair), the Secretary of the Department of Environmental Protection, and four members of the public appointed by the Governor. These appointees must include a former elected official of a metropolitan municipality, a former elected official of a county, a representative of an environmental nonprofit organization, and a representative of the development industry. The most unique aspect of the Trust is that it is the only state program available exclusively for locally selected projects. Unlike other state-administered acquisition programs, the local grant recipient, not the state, holds title to lands purchased. Each local government or non-profit organization is then responsible for land stewardship and implementation of a formal management plan written by the local government or non-profit organization and approved by the Trust.

Funding for the Trust

Funding for the Trust's grant program comes from the Florida Forever program. The Trust receives 22 percent of the total proceeds from the sale of Florida Forever bonds for an annual appropriation of

\$66 million. The Florida Forever Act requires that 75 percent of funds received by the Trust are matched by local governments. The Trust ensures this match requirement is met throughout the selection, evaluation, and closing processes. The Trust concluded its third year of awarding Florida Forever grants by exceeding the statutory match requirement of the Florida Forever Act.

"Meeting Community Challenges"

The Florida Communities Trust is an integral part of the Department's efforts to assist Florida communities in meeting the challenges of growth management, reducing the effects of disasters, and investing in community revitalization; while protecting the state's natural and cultural resources. The Trust's mission is advance communities' to

implementation of their comprehensive plans through the acquisition of land and promote innovative non-regulatory solutions to the challenges inherent in the comprehensive planning process.

The Spirit of Partnership

The Trust is dedicated to working with communities throughout the state to accomplish a collective goal: the acquisition of lands for recreation and open space. The Trust partners with local communities and environmental nonprofit organizations to make this goal a reality. Every grant application is a partnership, not only between the Trust and the applicant, but between applicants as well. Separate local governments often collaborate with each other, and with environmental non-profit organizations to submit applications.

These partnerships allow communities to better leverage state and local dollars, distribute project management duties, and preserve locally significant lands. As of July 1, 2004, the Trust and its partners have contributed over \$770 million to local communities for land and water conservation land buying.

Promoting Economic Revitalization such as Island City Park in the City of Trust projects often make significant Wilton Manors in Broward County, the contributions to the balance of economic Bayshore Linear Park in Charlotte growth and resource protection. The County, and the Daytona Beach Historic Florida Communities Trust awards points Boardwalk promote a sense of urban in its evaluation process to projects renewal and encourage local businesses, meeting a variety of economic criteria, whether existing or new, to operate within including those within Florida Main Street these transitioning urban areas. Preserving Florida's Cultural Gems

While the majority of the Trust's projects center on natural resource preservation and outdoor recreation, guite a number involve cultural resources as well. The Trust has helped preserve dozens of sites having historical significance at the local, statewide, or even national level. These sites include Princess Place, the oldest existing home site in Flagler County and former home of an exiled Russian prince; Boystown/Camp Matecumbe, Miami-Dade County, once the temporary home for Cuban refugee boys during the Pedro Pan Operation of the early 1960's; the Seminole War-era Fort King site in Ocala, destination of Major Francis Dade before he and his command were engaged by Chief Micanopy's Seminoles in 1835; and the "1912 Cortez Schoolhouse" in Manatee County and Parrot Jungle and Gardens in Miami-Dade County, both listed in the National Register of Historic Places. The

Trust has helped acquire many projects with Native American sites as well. These projects include the unique crescentshaped midden at the Paleo Hammock Project in St. Lucie County and the large midden at the Micanopy Native American Heritage Preserve in Alachua County. Both of these sites contain archaeological evidence of over 1000 years of continuous human activity. Continuing its commitment to preserve the State's historic past, the Trust awarded over \$21 million in 2003 to acquire projects that included cultural or historical resources.

Promoting Education

Understanding that education plays a vital part in resource conservation, the Trust places a priority on projects that possess educational attributes; awarding points for those projects that provide for interpretative signs, educational classes, and even environmental education centers. Of particular interest are those

projects that provide for coordination between state and local agencies in providing environmental education programs. An excellent example of this multi-agency coordination is the Legacy Program at Princess Place Preserve in Flagler County. Developed by the Flagler County School Board in conjunction with both the Flagler County Commission, and the St. Johns River Water Management District, this program provides on-site practical training in resource management to local "at-risk" high school students. This year's list of closings features the City of Ft. Myers Beach project, the Newton Beach Museum, where visitors will learn about the interesting friendships and contributions of Thomas Edison, Henry Ford, Charles Lindbergh, Dr. Alexis Carrel and Harvey Firestone during their time in Ft. Myers in the early 20th century. The Trust awarded over \$28 million in 2003 to acquire projects that included education programs to serve Florida's communities.

I am grateful for the assistance from the Florida Communities Trust grant in securing prime beachfront property that otherwise would have been impossible to do. This property will enable the City of Daytona Beach to showcase its natural beauty and wildlife in a park setting for resident and visitors to enjoy. As a former principal, I realize that education is critical to understanding the need to protect the State's future land use.

This property is important to us because it will become an environmental learning center that will showcase and train the public about Florida's indigenous plants and endangered sea turtles that nest on our beaches. Without Florida Communities Trust our residents and over 8 million visitors would miss the opportunity to enjoy the wildlife unique to our area and other sites around the State.

Again, on behalf of the City of Daytona Beach, I applaud your wonderful works throughout the state and especially your help in preserving the natural beauty of our beaches in Daytona Beach.

Meeting Our Customers' Needs

As part of the Trust's continuing commitment to provide improved yearround technical assistance, Trust staff conducted two sets of state-wide training workshops to assist prospective and current applicants in navigating the application and acquisition process. The first series of workshops was held by Trust acquisition staff in October 2003. Workshop locations included the Town of Southwest Ranches, Vero Beach, Maitland and Gainesville. Trust staff discussed obtaining appraisals for funded projects, the appraisal review process, contracting and negotiating, preparing project plans, and closing procedures. Over 50 representatives of local governments, environmental nonprofit organizations, and the general public attended these workshops at their various locations. The Trust held its second set of workshops in March 2004 to cover the general application process.

Workshop locations included St. Petersburg, Hollywood, Maitland, Jacksonville and Tallahassee. Trust staff provided a handbook to each workshop attendee containing an application instruction guide, sample exhibits, and a self-score checklist. Over 150 representatives of local governments, environmental non-profit organizations, and the general public attended the workshops at their various locations. The Trust announced the opening of its fourth Florida Forever application cycle on February 25, 2004. When the cycle closed on May 5, the Trust had received 78 applications representing over \$136 million in grant requests. With local match, these applications total over \$222 million in local land acquisition projects.

Looking to the Future

The coming years will be an exciting and challenging time for the Trust as it embarks upon future Florida Forever

application cycles and strives to maintain the high standard set by another successful year. In the coming months, Trust staff will finalize the revision of Rules 9K-7 and 9K-8. F.A.C., to streamline current processes, making the FCT program more navigable and userfriendly. The Trust will also explore how it can join the application and acquisition processes with current technology by providing web-based applications and acquisition contracts. Other things to watch for: a new look to FCT's website with a new logo and slogan, new signage for FCT properties, and additional efforts at community outreach to attract first-time applicants to the program. The Trust's staff and its Governing Board look forward to enhancing relationships with all Florida communities, developing new partnerships, and increasing its ability to preserve lands for Florida's future generations.

01-112-FF1 **McGirts Creek Park** Expansion City of Jacksonville

The 370-acre project is located along McGirts Creek in southwest Duval County and is surrounded by residential development. The purpose of the project site is to expand the adjacent McGirts Creek Park and provide additional recreational access to the Creek. The project site's natural communities include hydric hammock, bottomland forest, and blackwater stream. Recreational improvements will include nature trails, a canoe launch, picnic pavilions, and wildlife observation platforms. The total project cost was \$952,828.00.

01-125-FF1 Egans Creek Greenway - Phase II City of Fernandina Beach

The 36.5-acre project is located on Amelia Island within the City of Fernandina Beach, and is adjacent to two previously acquired FCT projects: Egans Creek Greenway (95-059-P56) and Egans Creek Greenway Phase II (96-013-P7A). This project preserves the most pristine of the Creek's remaining floodplain marshes as well as highquality hardwood hammock and maritime hammock natural communities. The City proposes to protect and enhance the project's upland and wetland areas, and provide multi-use trails, picnic areas, and educational signs. The project site will be linked to the existing Greenway via boardwalks and a multi-use trail. The total cost of this project was \$4,076,200.00.





02-099-FF2 **Garfield Beach Access** Walton County

The one-acre project is located on the Gulf of Mexico in the historic community of Grayton Beach and will expand an adjacent County-managed beach access area. This project provides critical habitat for several federally protected species, including nesting sea turtles and the Choctawhatchee beach mouse. The project will also serve as an important link between the adjacent Grayton Beach State Park and other recreation and conservation lands along the Gulf coast. The site contains a high-quality beach dune habitat, which the Florida Natural Areas Inventory has designated as "imperiled." Due to the project's environmental sensitivity, the County will construct a dune boardwalk with wildlife observation platforms. The County plans to restore the site's beach dune habitat by installing sand fences and replanting the area with native plants. The total cost of this project was \$1,217,378.75.

02-043-FF2 Mill Creek Nature Preserve Alachua County

The 1,194-acre project is located in north-central Alachua County. The project site owners forwent developing the location as a residential subdivision and the maximum profit associated with it, offering it for public ownership to ensure the preservation of the site's natural resources. The project will be an important component of Alachua County's "Emerald Necklace" land conservation initiative by protecting Mill Creek Sink and the headwaters of Townsend and Pareners Branches. The project includes a wide variety of high quality natural communities, including three designated by the Florida Natural blackwater stream, seepage stream, and slope forest. The County will construct

02-097-FF2 Moccasin Slough Clay County

The 255-acre project is located on the St. Johns River in an area of Clay County under heavy development pressure. The project will protect one of the few remaining undeveloped large riverfront tracts in the County, and contains several undisturbed natural communities, including floodplain marsh; designated as "imperiled" by the Florida Natural Areas Inventory. Recreational facilities will include nature trails, boardwalks, wildlife observation platforms, a fitness trail, and a playground. The County will restore the project's upland and wetland areas by removing invasive exotic species and replanting these areas with native vegetation. The total cost of this project was \$4,289,969.51.

01-149-FF1 **Beville Creek** City of Gainesville

The 30.4-acre project will preserve a natural open space in the center of the City of Gainesville. This project preserves a high-quality seepage stream, as well as upland mixed forest, mesic flatwoods, and mesic flatwoods natural communities. The City will develop the project site as a nature preserve with limited recreation opportunities, and will redevelop an existing two-story house as a nature center and museum. Proposed facilities include nature trails, picnic areas, and a children's playground. The total cost of this project was \$1,529,065.00.

01-150-FF1 Pier Park City of Panama City Beach

The 62-acre project is located on Front Beach Road in the City of Panama City Beach. This project serves as the centerpiece of a major revitalization project for the City's commercial beachfront area while providing needed public access to the Gulf of Mexico. The site's natural communities include beach dune and a small freshwater lake. Recreational improvements will include an open air festival pavilion, nature trail, picnic pavilions, playground, baseball fields, and beach volleyball courts. The total project cost was \$2,656,519.00.

01-103-FF1 Micanopy Native American Heritage Preserve Town of Micanopy

The 15.7-acre project is located on U.S Highway 441 in the historic Town of Micanopy, and is the Town's first application submitted to FCT. The project will create the first heritage preserve in Florida dedicated to interpreting Native American history, and will preserve two 1200 year-old archaeological sites eligible for listing in the National Register of Historic Places. The project includes basin swamp and mesic upland forest natural communities. The Town will construct a nature/heritage trail and picnic pavilion, and will provide an educational center/ museum and interpretive signs. The Town will preserve and enhance the project's uplands and wetlands. The

total cost of this project was

\$330,155.00.

02-096-FF2 Joe Henry Anderson, Sr. Park Dixie County

The 60-acre project is located near U.S. Highway 19 on the historic Suwannee River in Dixie County and will serve as an addition to an adjacent Countyowned boat ramp. The site was Dixie County's first application to FCT and is clear evidence of the County's commitment to resource protection. The County will restore water quality on the property to help improve water quality in the Suwannee River. The project contains undisturbed natural communities, including floodplain swamp, floodplain marsh, and blackwater stream. The County will construct such resource-based recreational facilities as a nature trail and fishing dock. Other recreational facilities will include a fitness trail and playground. The County will enhance the project's upland and wetland areas by removing invasive exotic species and replanting these areas with native plants. The total cost of this project was \$336,293.50.

Moccasin Slough Celebrated

On March 7, the Florida Communities Trust, the Trust for Public Land (TPL), the Clay County Board of Commissioners, and the North Florida Land Trust celebrated the preservation of a 260-acre site in Clay County called Moccasin Slough.

The site was purchased by TPL, a nonprofit land conservation organization and partner of FCT, in December and with a grant from the Florida Communities Trust, was then conveyed to Clay County. The protection of the property was made possible by the financial contribution of and partnership with the North Florida Land Trust and the federal Land and Water Conservation Fund, administered by the Florida Department of Environmental Protection. The property will become a nature-based county park. This was Clay County's first FCT project.

"Moccasin Slough has been in the public eye for quite some time," says Christy Fitzgerald, chair of the Clay County Commission. "The slough will provide the people of Clay County with a unique natural resource where we can develop an environmental education program, as well as passive recreational activities such as bird watching, kayaking, picnicking, and a bike/ running trail head."

Located on the St. Johns River on heavily developed Fleming Island, the wooded site contains a large freshwater marsh. With 32 acres of developable property, the site was slated for imminent development. "We could have had as many as 108 houses out here," says Susan Grandin, director of TPL's Northeast Florida Office. Instead, the site is home to a wide variety of waterfowl and other wildlife.

03-041-FF3 Goffinsville-Nassau River Park Nassau County

The 20-acre project is located on the Nassau River and is adjacent to the Nassau River-St. Johns River Marshes Aquatic Preserve. The project will be an important link in a multi-jurisdictional greenway project in southern Nassau and northern Duval Counties that includes the federally managed Timucuan Ecological and Historic Preserve. The site will also provide needed recreational open space and river access for local residents. The project includes a variety of natural communities, including mixed hardwood forest, pine flatwoods, and a high quality estuarine tidal marsh. A shell midden and the remains of a Civil War-era oyster factory are also present on the project site. The County will provide a mix of recreational amenities, including a nature trail, wildlife observation platforms, picnic pavilions, fishing pier, and canoe/kayak launch. The total cost of this project was \$1,220,820.00.

02-089-FF2 San Felasco Conservation Corridor - Alachua Phase City of Alachua

The 60-acre project is located on U.S. Highway 441 in the City of Alachua and is adjacent to the San Felasco Hammock State Preserve. This project will serve as the southern link in a proposed wildlife corridor/recreational greenway that will connect the State Preserve with other publicly owned conservation and recreation areas in northern Alachua County. The project is the City's first application submitted to FCT. The City will construct such resource-based recreational facilities as a nature trail to connect to the State Preserve and a picnic pavilion. Other recreational facilities will include a baseball fields

and a playground. The County will enhance the project's disturbed upland and wetland areas by removing invasive exotic species and replanting these areas with native plants. The total cost of this project was \$619,633.00.

02-110-FF2 Tallahassee Junction City of Tallahassee

The 19-acre project is adjacent to Florida A&M University in a heavily urbanized section of Tallahassee. This project will provide badly needed recreational open space in a rapidly redeveloping portion of the City. The City plans to develop the site as a trailhead at the junction of the St. Marks Rail Trail and the proposed GF&A Rail Trail. The City will also construct such recreational amenities as a playground, a nature trail, and wildlife observation platforms. Uplands, wetlands and freshwater ponds on the project site will be preserved and enhanced. The total cost of this project to date is \$405,559.00.

03-047-FF3 Yellow Water Creek Trailhead Preserve City of Jacksonville

The 265-acre project is located in western Duval County. The project will be an important part of the City's urban greenbelt program that will eventually connect major conservation and recreational areas in Duval County. The project includes portions of Yellow Water Creek and other remnant natural communities, including dome swamps. The City will restore the disturbed areas on the site by planting native vegetation, thereby improving water quality in Yellow Water Creek. The City will construct nature-based recreational facilities, including picnic pavilions, nature trails, equestrian trails and facilities, and wildlife observation platforms. Userbased recreational amenities will include a fitness trail and dog park. The total cost of this project was \$1,635,801.00.

02-040-FF3 Carrabelle Wildlife Park City of Carrabelle

The 70-acre project is located just north of the City of Carrabelle in

unincorporated Franklin County. The project will allow the City to provide badly needed recreational open space for local residents and will provide trailhead facilities to the City's locallydesignated hiking and biking trail. The project includes a wide variety of natural communities, including scrub, mesic flatwoods, basin swamp, and swamp lake. The Florida Natural Areas Inventory has designated scrub communities as "imperiled." The site contains several active gopher tortoise burrows. The City will provide a mix of recreational facilities, including nature trails, wildlife observation platforms, picnic pavilions, playgrounds, basketball courts, and a fitness trail. The total cost of this project was \$332,509.00.

03-048-FF3 Sal Taylor Creek Preserve City of Jacksonville

The 407-acre project is located in southwestern Jacksonville. The project will be an important part of an urban areenbelt that will eventually connect major conservation and recreational areas in western Duval County. The project includes a wide variety of highquality natural communities, including dome swamp, basin swamp, and bottomland forest. The site also includes a blackwater stream, Sal Taylor Creek, which has been designated by the Florida Natural Areas Inventory as "imperiled." The City will construct mostly passive recreational facilities, including picnic pavilions, nature trails, and wildlife observation platforms. User-based recreational amenities will include a fitness trail and horseshoe pits. The total cost of this project was \$1,884,594.75.

The 507-acre project is located in the Indian River Lagoon adjacent to the Town of Indian River Shores and City of Vero Beach. The project site is composed of two main groupings of islands, a coastal wetland known as McCuller's Point, and six other small islands within the Indian River Lagoon. The islands were slated for developmen as an exclusive housing development. The acquisition of the islands prevented development of these unbridged barrier islands and preserves some of the last remaining undeveloped islands in the Indian River Lagoon. The County will remove the invasive exotic vegetation and restore the natural communities on the islands. The islands will be developed as a nature park with a boat dock and picnic facilities. The total cost of this project was \$15,324,003.

01-083-FF1 Parcel 105 Orange County

The 1,133 acre project is located in eastern Orange County north of State Road 50. The project will protect sandhill, pine flatwoods, hammock and wetlands communities and listed wildlife species. Public access will be provided

to two lakes. Proposed management includes the removal of exotic vegetation and prescribed burning. Nature and user-based recreational improvements will include a multi use trail system, soccer and baseball fields, canoe launch and fishing area. The total cost of this project was \$5,097,422.00.

01-065-FF1 Shoreside Park Town of Palm Shores

One-third of an acre in size, the project is located in the Town of Palm Shores on U.S. Highway 1, adjacent to the Indian River Lagoon. The project will protect native plant communities and water quality and provide for outdoor recreation opportunities and environmental education programs. Proposed management of the site includes shoreline restoration, removing exotic vegetation and planting native upland and wetland species. Naturebased recreational improvements will include a nature trail and boardwalk, wildlife observation station, picnic area and educational display. The total cost of this project was \$69,480.00.

Kings Bay Linear Park - City of Crystal River Revitalizing a Downtown Waterfront

01-032-FF1 Daytona Beach Pier Project City of Daytona Beach

The two-acre upland project borders the beachfront boardwalk and is within the Daytona Beach Surfside Historic District and Main Street Redevelopment Area. The site will provide open space and multi use recreation opportunities and will be landscaped with native plant species. An educational nature center will also be provided on the site. Recreational improvements will include landscaped walkways, wildlife observation area, playground, volleyball court and benches. The total cost of this project was \$6,416,543.00.

01-077-FF1 Cocoa Conservation Area City of Cocoa

The 163-acre project is located in western portion of the City of Cocoa south of State Road 524. The primary purpose of the project is to preserve natural open space in an urban portion of the City. The site is comprised of wet flatlands, mesic flatlands, oak and pine scrub, and seepage wetland. The site is adjacent to neighborhoods that are presently lacking park facilities. Recreational facilities will include a playground, volleyball court, picnic shelters, and nature trails. The project site also fits into the larger overall greenway system for Brevard County. The total cost of this project was \$946,020.82.

03-064-FF3 Ponce Preserve First Addition Town of Ponce Inlet

The 3.2-acre project is located in the Town of Ponce Inlet adjacent to a previously funded FCT site, Ponce Preserve (94-033-P4A). The site is also adjacent to the state owned Green Mound State Archaeological Site. The project site was one of three parcels in the Town that were being considered for the construction of a new Town Hall. This caused considerable reaction in the community and greatly increased citizen support for the project to be acquired as an addition to the existing park and historical site. The site includes native coastal strand and maritime hammock communities, which provide habitat for listed animal species. Nature and userbased recreational improvements will include a nature trail, picnic pavilion, playground and fitness trail. The total cost of this project was \$557,162.00

01-053-FF1 **Orange County Natural Resource** Center Orange County


The 400-acre project is located in eastern Orange County and will assist the County in developing an environmental education and agricultural learning center. The project site is adjacent to Long Branch Park and Hal Scott Preserve, which will protect approximately 10,000 acres of native habitat and extend the multijurisdictional Econlockhatchee River Greenway. Propose site management includes hydrological and upland restoration. Nature-based recreational improvements will include nature trails and picnic areas. The total cost of this project was \$1,970,215.50.

02-094-FF2 Town Center Marcantonio Property City of Port Orange

Just less than one acre, the project site located on the historic waterfront of the Halifax River (Intracoastal Waterway) in the City of Port Orange will assist the City in creating the Town Center Civic Green and Riverwalk. The project is south of a previously funded FCT site, Town Center Properties (01-029-FF1). The project will also protect the water quality of the Hailifax River and provide recreational amenities. Nature and user-based recreational improvements will include a boardwalk along the Halifax River for fishing and wildlife observation, bocci ball court and playground. The total cost of this project was \$266,434.00.

03-081-FF3 **River Tower Park** City of Tampa

The 13-acre project is located on the Hillsborough River in a low-income area of central Tampa. The project will assist the City in protecting the historic Sulfur Springs Water Tower, expand an adjacent City park and provide trailhead facilities for the Hillsborough River Greenway. A citizen group called "Save the Tower" protested the sale of the site

to commercial interests and approached the City to acquire the property. The site has been impacted by clearing activities and the City proposes to restore much of the upland area with native vegetative communities. Nature and user-based recreational improvements will include a fishing dock, canoe/kayak launch, nature trails, boardwalks, multi use trails and picnic shelters. The total cost of this project was \$2,865,100.00.

03-083-FF3 South McDill 48 City of Tampa

The 47-acre project will assist the City in protecting listed species habitat and provide a trailhead facility for the South Tampa Recreational Trail System in a highly urbanized area. The site is located in a low-income section of south Tampa, just north of MacDill Air Force Base. The site is also adjacent to a public park and playground and remains one of the last undeveloped parcels in the area and includes pine flatwoods, pine scrub, oak hammock and hydric hammock communities, which provide habitat for the appher tortoise. Naturebased recreational improvements will include a nature trail, picnic pavilion and boardwalk system. The total cost of this project was \$1,847,594.75.

The 154-acre project is located in central Manatee County. The project will provide a regional park in this rapidly developing area of the County. The property owner, Mr. Thomas Bennett, in an effort to conserve his land, made a proposal to the Manatee Board of County Commissioners to put his property into public ownership rather than develop it. The recreational complex will include ball fields, tennis courts, volleyball, amphitheater, playground, and water play area. Uplands, wetlands and freshwater ponds on the project site will be preserved and enhanced. Nature-based amenities such as fishing piers and a canoe launch will be provided. Paddlers will be provided access to a tributary of the Manatee River, which is part of the designated Manatee County "Paddle Manatee" trail. The total project cost was \$3,088,507.80.

01-018-FF1 **Bayshore Linear Park** Charlotte County

The 9.4-acre project is located on the shores of Charlotte Harbor near the mouth of the Peace River in Charlotte County. The project is a key element in the urban revitalization project developed by the County for this area. Facilities proposed for the site include picnic pavilions, walking trails, piers, a playground and water play area. Educational signage and programming will highlight the historical significance of the area. To date, the total cost of this multi-parcel project is \$1,030,285.00.

01-093-FF1 Hollywood North Beach Addition Broward County / City of Hollywood

Just less than an acre, the project site is located north of Hollywood North Beach Park and just south of John Lloyd State Recreation Area. The project site will provide an additional beach access in this highly urbanized community. The City will restore the beach dune community by re-establishing native dune vegetation. A dune crossover will be constructed to enhance access to the beach. The total cost of this project was \$192,877.00.

01-045-FF1 Venice Gulf View Park City of Venice

Just less than an acre, the project site is located within the City of Venice. The project enhances the Venice Municipal Beach Park by providing parking and additional public access to the beach. The project will be developed into an overlook pocket park for enjoying the Gulf of Mexico and watching sunsets. The design of the park will include native coastal landscaping, benches, and a multi-level fountain. The total cost of this project was \$970,203.24.

01-036-FF1 Lake Park Scrub Palm Beach County / Town of Lake Park

The 50-acre Lake Park Scrub Natural Area is located in the Town of Lake Park in northeastern Palm Beach County. The project provides a nature preserve in an extensively developed urban area. Natural communities on the site include scrub, scrubby flatwoods, and mesic flatwoods. The acquisition of the site preserves one of the few remaining scrub communities in the County. Recreational facilities include nature trails and a wildlife observation platform. The total cost of the project was \$2,515,252.62.

02-71-FF2 North Fork of the St. Lucie River Phase III St. Lucie County

The 42.8-acre parcels acquired in October 2003 completed the 60-acre project. The project site is located along the North Fork of the St. Lucie River near the City of Port St. Lucie. The primary purpose of the project is to enhance the St. Lucie River Greenway and to help restore the North Fork of the St. Lucie River, an Outstanding Florida Waterway and State Aquatic Preserve. Natural communities on site include hydric hammock, floodplain, swamp, floodplain forest, and mesic flatwoods. The project site also provides habitat for the bald eagle, gopher tortoise, woodstork and other listed species. The County plans to create a park like stormwater lake facility in an old 14-acre citrus grove to improve the quality of

stormwater reaching the North Fork of the St. Lucie River. Recreational improvements will include nature trails and canoe/kayak dock. The total cost of this project was \$674,153.00.

02-022-FF2 Last Cypress West Broward County

The 6.4-acre parcel is located in the City of Lauderdale Lakes and one block from another FCT project, Last Cypress East (02-021-FF2). The purposes of the project are to create an urban nature park and provide recreational opportunities for underserved residents of a low-income community. The project site will also provide a future trailhead facility for a segment of the Broward County's greenway system. Management activities include the removal of exotic vegetation and planting of native species. Recreational facilities include a nature trail and picnic shelters. The total project cost was \$774,519.58.

02-098-FF2 Newton Beach Ft. Myers Beach

Almost one acre, the project is located in the center of the Town of Ft. Myers Beach on the Gulf of Mexico. The Newton family compound contains three historic structures and has significant historical connections with Thomas Edison, Harvey Firestone, Charles Lindbergh and other historic figures of the early and mid-20th Century. The project site will be developed as a museum and educational facility highlighting the history of the family compound and the ecology of the area. The site will also provide additional beach access and a launching point for the Calusa Paddling Trail. The total project cost of the project was \$2,584,301.75.



02-072-FF2 San Carlos Bay – Bunche Beach Preserve Lee County


The 727-acre project is located on San Carlos Bay south of the Caloosahatchee River, between Estero and Sanibel Islands in Lee County. The project adds significant acreage to the original one-half acre of beachfront property purchased in 1950 by Lee County, which was historically designated as the African American beach. Bunche Beach was frequented primarily by African-Americans living in Lee County from the late 1930's until the early 1970's. The beach was a favorite spot for the service men who were stationed at the Buckingham Military Base and Page Field during WWII. The project preserves coastal habitat such as tidal swamp, tidal creeks, coastal grasslands, coastal berms, seagrass beds and mudflats that provide productive habitat for a wide variety of birds and other wildlife. The project will provide passive recreational uses including a boardwalk and canoe/kayak launch. The total cost of this project was \$6,380,000.00.

01-067-FF1 Sheraton Plaza Preserve St. Lucie County

Acquisition of the nine-acre parcel in December 2003 completes the 64-acre Sheraton Plaza Preserve project. The Preserve is located in northeastern St. Lucie County just north of the City of Fort Pierce. The project expands the countyowned Sheraton Plaza Recreation Area. The site protects an urban wildlife preserve that contains mesic flatwoods and scrubby flatwoods communities,

which provides habitat for the endangered Florida scrub jay. The project also enhances St. Lucie County's development of a greenway network. Recreational improvements will include a wildlife observation platform and hiking trails. The total cost of the project was \$859,684.00.

Robinson Preserve - Manatee County Resolving a Land-Use Conflict



02-006-FF2 **Robinson Preserve** Manatee County

The 459-acre project is located in northwestern Manatee County and surrounded on three sides by water bodies: Tampa Bay, Perico Bayou, and Palma Sola Bay. One of the last remaining undeveloped waterfront parcels in Manatee County, this project's exceptional nature stems from the owner's goal of seeing the tract in public ownership. The acquisition solved a land use conflict by limiting development and protecting a wildlife corridor which would otherwise be fragmented by development. Disturbed uplands and wetlands on the project site will be restored. The project will provide a visitors center, canoe launch, fitness trail, nature trail, boardwalk, observation deck, fishing piers, picnic shelters, primitive camping, and a playground. The total cost of this project was \$10,074,966.27.

02-049-FF2 Southwest Nature and **Recreational Park** City of Pembroke Pines

The 56-acre project is located in southwest Pembroke Pines, along Pines Boulevard. The purpose of the project is to provide recreational opportunities and open space in a fast growing community. The project will provide a nature trail, playground, community center, picnic pavilions and six regulation-size soccer and football fields. Management activities include the removal of invasive exotic vegetation, planting of native vegetation, and wetland restoration. The total cost of this project was \$2,351,152.50.

02-051-FF2 Blue Lake Scrub Raton

The 79-acre project is located in the northwestern section of the City of Boca Raton, at the intersection of Yamato Road and Military Trail. The project site is part of 300 acres of land formerly managed as the IBM Corporation campus. Palm Beach County acquired the most environmentally sensitive portion of the property to manage as a nature park. The City of Boca Raton acquired the adjacent 222 acres of land as a City park and library. The project preserves scrub, scrubby flatwoods, mesic flatwoods, and hydric hammock. The site provides habitat for listed species such as the Florida mouse and gopher tortoises. Five acres of wetlands will be restored by removing invasive exotic vegetation, restoring hydrology and planting appropriate native vegetation. Proposed facilities include a nature trail, educational kiosk, and wildlife observation deck which will overlook Blue Lake and the restored wetland area. The total cost of this project was \$11,569,233.83.

01-076-FF1 Island City Park Addition City of Wilton Manors

Just less than an acre, this project is located along the North Fork of the Middle River in the City of Wilton Manors. The project will be managed as an addition to Island City Park (95-055-P56), a previously funded FCT project. The purposes of the project are to create an urban nature park and provide recreational opportunities for underserved residents of a low-income community. Recreational facilities include a picnic area, fishing area, boardwalk, nature trail and multipurpose court. The total cost of this project was \$159,961.00.

02-021-FF2 Last Cypress East Broward County

The 6.5-acre project site is located in the City of Lauderdale Lakes and one block from another FCT project, Last Cypress West (02-022-FF2). The purposes of the project are to create an urban nature park and provide recreational opportunities for underserved residents of a low-income community. The project site contains a cypress strand community. Management activities include the removal of exotic vegetation and planting of native species. Recreational facilities include a nature trail, playground, and picnic shelter. The total project cost was \$858,018.01.

01-063-FF1 Tippecanoe Scrub Environmental Park, Phase II Charlotte County

The 25-acre project site is located in west central Charlotte County adjacent to the Charlotte Harbor Buffer Preserve and Tippecanoe Scrub Preserve. The project, along with the adjacent scrub habitat, will protect a regionally significant scrub-jay population in Southwest Florida. The project site will be developed as an urban wilderness preserve with nature trails, wildlife overlooks, and picnic areas. The project site contains 454 platted lots and acquisition of the project site will assist the County in reducing its overabundance of platted lots. FCT acquired 105 parcels between April 2003 and September 2003. The total cost of this project was \$369,040.25.

02-002-FF2 Central Broward Regional Park Broward County / City of Lauderhill

The 96-acre project is located in the southeastern section of the City of Lauderhill in Broward County. The park will serve a multi-cultural community in a highly urbanized area. The project provides 29 acres of sports facilities including soccer, football, cricket, basketball, tennis, netball and volleyball. Multiple picnic shelters and walking trails will be provided. An event field will be constructed and utilized for community festivals and sporting events. Canoeing, kayaking and rowboating will be available in the man-made lakes. The project will be landscaped with native vegetation. The total cost of this project was \$13,803,426.94.

01-082-FF1 St. Lucie Village Heritage Park Town of St. Lucie Village

The acquisition of the almost four acre parcel in 2004 completes the 78-acre Heritage Park project. The park is located along the Indian River Lagoon within the Town of St. Lucie Village and will provide additional public access to the Lagoon. Acquisition of the site completes the protection of one of the few remaining natural areas in private ownership located along Indian River Lagoon in St. Lucie County. The site will protect approximately one-half mile of lagoon shoreline including hydric hammock, tidal swamp, marsh and scrub. The Village will be constructing a canoe launch, volleyball court, horseshoe pit, picnic area, and nature trails at the park. The total cost of the project was \$2,325,112.40.

01-133-FF1 Delaplane Peninsula Martin County Regional Land Trust

The acquisition of the 1.4-acre parcel in 2004 completes the acquisition of the project. The nature park is located along the South Fork of the St. Lucie River encompasses 52 acres and protects over 9,400 linear feet of shoreline. The project also enhances Martin County's development of a greenway along the St. Lucie River. Invasive exotic vegetation will be removed and the native communities will be enhanced. The site will be developed as an urban wilderness park with a picnic area, nature trails and canoe trails. The total cost of this project was \$4,825,172.00.

02-100-FF2 Limestone Creek Palm Beach County

The 22-acre project site is located in northern Palm Beach County, north of the Town of Jupiter in the community of Limestone Creek. The park will provide needed urban open space for a lowincome, minority community. The site is adjacent to Limestone Creek Elementary School and will provide additional opportunities for environmental education classes. The project site will provide access to the C-18 Canal for fishing. Additional recreational opportunities include a playground, walking trails, wildlife observation platforms, and picnic pavilions. Total cost of the project was \$2,193,047.05.

01-016-FF1 Section 16 City of West Palm Beach

The 271-acre parcel is located west of Jog Road in the City of West Palm Beach. This is the third successful application the City has made to FCT to acquire lands within the City's 19.3 square mile Water Catchment Area (WCA). The purpose of the acquisition is to implement the City's long-term program to acquire a buffer around the WCA in order to protect the source of the City's surface water supply and primary recharge area for its auxiliary wellfield. Additional purposes of the project are to provide wildlife habitat and recreational and educational opportunities. The land cover at the site is a mix of pine flatwoods, shrub communities, emergent marshes, and open water areas with scattered invasive exotic vegetation. Resource management activities will focus on removal of invasive exotic and facilitating public usage through the creation of trails, observation areas, and interpretive displays. Total cost of the project was \$1,670,900.00.

03-025-FF3 Southwest Meadows Sanctuary Town of Southwest Ranches

The 17-acre project is located in the northeastern portion of the Town of Southwest Ranches. The purpose of the project is to provide recreation and open space adjacent to the proposed new City Hall. Recreation facilities will include a playground, fitness trail, picnic pavilions, and wildlife observation decks. A cultural and historical museum is proposed. Approximately three acres of wetlands will be created, and the project will be landscaped with native vegetation. The total cost of this project was \$5,273,484.28.

03-014-FF3 Mills Pond Addition Broward County

The 23-acre project is located east of Interstate 95 and south of Oakland Park Boulevard in the City of Fort Lauderdale. The project is adjacent to the 93-acre Mills Pond Park, an active recreation park, and the Middle River which flows along the east and west sides of the property. The project will preserve and restore a bottomland forest. Management activities will include removing invasive exotic vegetation and planting appropriate native vegetation. An elevated nature trail and canoe/ kayak dock will be provided. The total cost of this project was \$625,971.40.

03-010-FF3 Highlands Scrub Addition Broward County

The almost five acre project is located or Dixie Highway in unincorporated Broward County adjacent to the Countymanaged Highlands Scrub Natural Area. The project is surrounded by highdensity commercial and residential development. This project preserves one of the last remaining areas of scrub habitat in Broward County and will be an important component of a proposed greenway trail along Dixie Highway that will link other recreational and conservation lands in the County. The County will provide recreational amenities, including nature trails, picnic

pavilions, and wildlife observation platforms, and bicycle racks. The total cost of this project was \$1,449,959.50.

02-018-FF2 Florence Hardy Park City of Fort Lauderdale

The just over three-acre project is located in the City of Fort Lauderdale. The project provides additional recreational space in a downtown regional activity center adjacent to the existing Florence Hardy Park. The project is also adjacent to the South Side School, which was built in 1922 and is believed to be the oldest school structure still standing in Fort Lauderdale. An existing parking lot will be removed, and a boundless playground, sand volleyball court, fitness trail, basketball courts, and picnic pavilions will be constructed. The project will be landscaped with native vegetation. The total cost of this project was \$3,884,349.87.









Scrub Jays at Sheraton Plaza Preserve St. Lucie County

02-091-FF2 Indrio Blueway Buffer St. Lucie County

The 105-acre parcel is located in northeastern St. Lucie County along the Indian River Lagoon. The project site is adjacent to a previously selected FCT site, the Indrio Scrub Preserve (01-069-FF1) which in turn is adjacent to the North Indrio Savannahs (95-052-P56). The purpose of the project is to extend the Indrio North Savannahs Greenway. The project will preserve a natural area along the Indian River Lagoon and provide for recreational opportunities. Management activities include removing exotics and hydrological restoration of the wetlands in the mosquito impoundment area. Recreational improvements include a hiking trail and observation platform. The total project cost was \$1,344,775.00.

03-011-FF3 Helene Klein Pineland Preserve Broward County

The 12.2-acre project is located at the corner of Hillsboro Boulevard and Lyons Road in the City of Coconut Creek. The project is surrounded by highdensity commercial and residential development. This project preserves the largest and most pristine of the remaining pine flatwoods tracts in the County and will be an important component of a proposed greenway along NW 71st Place that will link other recreational and conservation lands in the County. In addition to pine flatwoods, the project also includes both basin swamp and marl prairie natural communities. The County will provide recreational amenities,

including nature trails, picnic pavilions, and wildlife observation platforms. The County will preserve and enhance the project's uplands and wetlands. The total cost of this project was \$3,431,145.51.

03-069-FF3 Capron Trail St. Lucie County

The 120-acre parcel is located northwest of Ft. Pierce on Indrio Road and will be developed in conjunction with the adjacent 37-acre county-owned land. The project site will provide a regional park with both active and nature based recreational opportunities. The park will include a swimming pool, soccer fields, baseball fields, picnic shelters, and nature trails. Natural areas on the site will be set-aside as an urban wilderness preserve. The total project cost was \$2,970,260.45.


03-018-FF3 Lely Mitigation Park Collier County

The 99-acre project is located in western Collier County. The project assists the County in addressing regional stormwater issues by providing additional water storage capacity and improving water quality to downstream estuaries. The project contains pine flatwoods and cypress wetland habitats and has been designated as a Strategic Habitat Conservation Area for the redcockaded woodpecker and swallowtailed kite. The habitat will be restored by removing invasive exotic vegetation such as melaleuca trees. The site will be utilized for passive recreation and will include a nature trail and wildlife observation deck. The total cost of this project was \$2,774,250.00.

Newton Beach Park -Jown of Fort Myers Beach Uncommon Friends

Home of Jim and Ellie Newton Preserved in Ft. Myers Beach

In the early years of the 20th century, the Fort Myers Beach home of author Jim Newton and his wife Ellie was the gathering place for an extraordinary group of people. Well known for their hospitality, love of conversation, and interest in discussing the ethical questions of the day, the Newtons entertained and became fast friends with some of the most famous and respected business and intellectual leaders of the time - Thomas Edison, Henry Ford, Harvey Firestone, Dr. Alexis Carrel and Charles Lindbergh. Jim Newton dubbed them his "Uncommon Friends" and wrote a best-selling book about their friendship.

"Most FCT projects have a great story behind them, but this one is at the top of the list of our projects with the most heart," said Kathy Baughman McLeod, FCT's Program Manager. "It is a great example of how much a piece of land, however small, can mean to a community. Preserving the Newton's beachfront home means forever protection of local history, community character and soul."

With support and funding from the Florida Communities Trust and Lee County, the town of Fort Myers Beach worked with the Trust for Public Land, a non-profit land conservation group, to purchase the property from the Newton family after Ellie Newton's death last summer. The one-acre property with its small home is now owned and managed by the Town of Fort Myers Beach. The site will become Newton Beach Park.

Community leaders who wanted to protect the legacy of Jim and Ellie Newton founded the Uncommon Friends Foundation in 1993. The foundation was deeded historical artifacts from Jim and Ellie Newton, which they are hoping will become part of a permanent exhibit.


"Our mission is to educate people of all ages to develop certain traits - a spirit of adventure, sense of purpose, unending personal growth, and a commitment to helping friends," says Julia East, the foundation's executive director.

With its location on a beachfront used by nesting loggerhead sea turtles, the property has environmental as well as cultural and educational components. The site will be used as a backdrop for environmental education classes for both school-age and adult audiences to learn about the natural beach habitat.



- (4) An evaluation of the effectiveness of the projects undertaken in carrying out this part.
- (5) Identification of additional funding, legislation, or other resources required to carry out the objectives of this part more effectively.
- (6) An account of any other trust or department duties established by this part.
