Florida Communities Trust Mission & Accomplishments

What is the Florida Communities Trust?

Florida Communities Trust (FCT or the Trust), which is located in the Department of Community Affairs, administers two state land acquisition grant programs, Parks and Open Space and Stan Mayfield Working Waterfronts. The Trust provides funding in both programs through grants awarded to local governments and non-profit organizations through a competitive process each year to help acquire community-based parks, open space, greenways and working waterfronts. These projects must further the outdoor recreation, natural resource protection or working waterfront needs identified in local government comprehensive plans. There are also a number of criteria in the Trust's competitive scoring process that foster cultural and historical preservation, trail system development, and public access to water. The Trust is governed by a sixmember board that includes the Secretary of the Department of Community Affairs (who serves as permanent chair), the Secretary of the Department of Environmental Protection, and four members of the public appointed by the Governor. These appointees must include a former elected official of a metropolitan municipality, a former elected official of a county, a representative of an environmental non-profit organization, and a representative of the development industry. The Trust is the only state land acquisition program available exclusively for locally selected projects. Unlike other state-administered acquisition programs, the local grant recipient, not the state, holds title to lands purchased through Florida Communities Trust. Each recipient is then responsible for land stewardship and implementing a formal management plan which must be approved by the Trust.

Funding for the Trust

Florida Communities Trust's grant programs are funded through the Florida Forever program. For the Parks and Open Space grant program, the Trust receives 21 percent of the total proceeds from the sale of Florida Forever bonds, resulting in a historical annual appropriation of \$63 million. The Trust also receives another 2.5 percent of the Florida Forever appropriation for the Stan Mayfield Working Waterfronts (SMWW) grant program, totaling \$7.5 million annually at the historical funding level for the Florida Forever program.

The Trust is dedicated to working with communities throughout the state to accomplish a collective goal: acquiring lands for recreation, open space and working waterfronts while furthering their comprehensive plans.



For the first time in the history of the program, Florida Forever received no funding for fiscal year (FY) 2009-2010; as a result, the Trust did not seek grant applications for the Parks and Open Space or Stan Mayfield Working Water-fronts grant programs during the fiscal year.

Meeting Community Challenges

Florida Communities Trust is an integral part of the Department of Community Affairs' efforts to help Florida's communities meet the challenges of growth management, reduce the effects of disasters and invest in community revitalization, all while protecting the state's natural and cultural resources. The Trust helps communities further the goals of their comprehensive plans through land acquisition and innovative non-regulatory solutions to the challenges inherent in the comprehensive planning process.

The Spirit of Partnership

The Trust is dedicated to working with communities throughout the state to accomplish a collective goal: acquiring lands for recreation, open space and working waterfronts while furthering their comprehensive plans. The Trust partners with local governments and non-profit organizations to make this goal a reality. Every project funded by Florida Communities Trust is a partnership. Trust grants foster partnerships among local governments during the acquisition process and, frequently, for management of the properties. Local government applicants often collaborate with environmental and working waterfront non-profit organizations when submitting grant applications. Such partnerships allow communities to better leverage state and local dollars, distribute project management responsibilities, and preserve locally significant lands.

Promoting Economic Revitalization

Trust Parks and Open Space projects often play a significant role in striking the delicate balance between economic growth and resource protection. The process for selecting projects to be funded by the Trust gives special consideration to a variety of economic factors, including whether the project is located within a Florida Main Street District, Front Porch Community, designated low-income community, Rural Area of Critical Economic Concern, or designated urban infill area. A number of projects promote a sense of urban renewal and encourage both new and existing local businesses to operate within these urban areas. Two recent examples include the City of Destin's Captain Royal Melvin Heritage Park and Plaza, which is located in a community redevelopment area and will provide enhanced access to the Destin Harbor, and the City of Port St. Joe's Port St. Joe Waterfront Park, which will create additional recreational opportunities in a designated Waterfronts Florida community. Though no new Florida Forever funding was appropriated for FY 2009-2010, the Trust was able to fund nine additional projects from the 2008 ranking list using previously appropriated Florida Forever funds. A majority of the earlier funded 2008 projects were acquired for much less money than originally anticipated due to lower real estate prices, making funds available for additional projects. Of these nine newly funded projects, the Trust awarded nearly \$6 million in FY 2009-2010 to acquire projects located in areas working toward economic revitalization, contributing toward the improvement of some of Florida's most disadvantaged communities.

Preserving Florida's Cultural Heritage

While the majority of the Trust's projects protect natural resources and provide outdoor recreation, many also help preserve Florida's rich cultural heritage. The Trust has helped save dozens of sites having historical significance at the local, state, and national levels. These sites include Jones's Pier in Indian River County, a historic home site along the Jungle Trail that once served as a destination point for tourists, farm-to-market transportation of citrus and other tropical fruits, and commercial fishing. The list also includes the Harbor Branch Preserve in St. Lucie County, which contains a Native American shell midden listed on the Florida Master Site File. Continuing its commitment to preserve the state's historic past, the Trust awarded nearly \$30 million in FY 2009-2010 to acquire projects that helped preserve historical or archaeological resources.

While the majority of the Trust's projects protect natural resources and provide outdoor recreation, many also help preserve Florida's rich cultural heritage.

Promoting Education

Understanding that education plays a vital part in resource conservation, the Trust places a priority on projects with educational aspects, giving extra consideration to those that provide for interpretative signs, educational classes, and even environmental education centers. Two excellent examples of the Trust's commitment to education are the Big Bend Maritime Center in Wakulla County, which will provide a maritime history museum and education center dedicated to promoting the study, interpretation and preservation of the maritime heritage of the Big Bend region, and Ocean Hammock Park in the City of St. Augustine Beach, which will provide a nature center and museum with classes and programs concerning beach and dune habitats and the animals who inhabit them. The Trust awarded more than \$31 million in FY 2009-2010 to acquire projects featuring education programs to serve Florida's communities.

Other Program Highlights

Florida Communities Trust has given land management and park development greater emphasis this year due to the fact that Florida Forever was not funded by the Legislature for the 2009-10 Fiscal Year. One of the effects of zero funding for the Florida Forever program was an absence of grant applica-

tions to review. Taking advantage of this unexpected hiatus, the Trust initiated an intensified effort to insure proper stewardship of past Trust-acquired properties by grant recipients. There are now approximately 520 local and regional parks in various stages of development thanks to funding provided by FCT from Preservation 2000 and Florida Forever. Though title is held by the local governments and non-profits, the Trust retains ultimate oversight responsibility through deed restrictions. Additionally, communities with FCT parks are required to follow the management plans and park development timelines approved by Trust staff as part of the grant conditions. As part of an overall effort to assure that all community responsibilities are met concerning FCT parks, Trust staff conducted site visits at 230 parks during FY 2009-2010. Nearly half the properties acquired through Trust funding received site visits. The primary goal of the site visits was to confirm that the management of the FCT-funded properties was accurately represented in the annual stewardship reports submitted by the local governments and non-profits managing them. The site visits also served to reinforce awareness of the land management and park development requirements and to reward grant recipients who have fully developed their parks and who have a good track record participate with a relaxed stewardship reporting requirement, from annual reporting to a five year interval.

The break in Florida Forever funding also provided an opportunity to strengthen the program through modification of the rules that provide the framework for the two grant programs administered by the Trust. Using lessons learned in the inaugural Stan Mayfield Working Waterfront grant application cycle, Trust staff worked with stakeholders in the commercial seafood and aquaculture industries as well as staff from the Department of Agriculture and Consumer Services to modify Rule 9K-9, Florida Administrative Code (F.A.C.), improving the grant application criteria. The modified rules for the Stan Mayfield Working Waterfronts grant program were adopted on May 16, 2010. Rule development workshops to improve the Parks and Open Space grant program were also conducted with stakeholders, resulting in a fairly aggressive slate of modifications to Rule 9K-7, F.A.C. (the grant application criteria), which were adopted on February 8, 2010. Minor modifications to Rule 9K-8, F.A.C., on the Trust's acquisition procedures were adopted on February 9, 2010.



Looking to the Future

Trust staff continues to work toward finalizing a long running initiative that will create a comprehensive web-based GIS map of all land acquired through the Trust's Preservation 2000 and Florida Forever grants. The ultimate goal of this project is two-fold: one, to make maps available to the public and decision-makers that provide a comprehensive state-wide or local view of all projects acquired through the Trust's Preservation 2000 and Florida Forever funds, and two, to create an electronic grant application that makes it easier for low-capacity applicants to apply for funds and to be successful in doing so. This project has already produced more accurate and expeditious evaluations of grant applications. The Trust anticipates completing the mapping of FCT acquisitions by late 2010. The Trust will then contract with Florida State University's Florida Resource and Environmental Analysis Center (FREAC) to make the GIS maps and all of the associated attributes of each project available to the public via the internet. Once the maps are fully operational, work will shift to the development of an electronic grant application with ready-made GIS maps for prospective applicants.

Trust staff will also continue to perform site visits on the remainder of the prop-



erties funded through the Trust to complete the comprehensive park management oversight initiative begun in June 2009.

As has always been the case, the Florida Communities Trust Governing Board and Trust staff will continue to foster strong relationships with all of Florida's communities, develop new partnerships and strategies, and work to preserve even more lands for future generations.

There are few places in Florida that equal the natural resource superlatives of the Rainbow River. One of the clearest aquatic systems on the planet, the Rainbow River is Florida's third largest spring and one of the world's longest spring runs. It is also a globally significant resource, providing habitat for 300 plant species and numerous fish and wildlife species. People from across the state are drawn to the natural beauty and tranquility of the river, thus



providing an economic boost for the community.

Situated along the east side of the Rainbow River next to County Road 484, Blue Run of Dunnellon Park is the newest public park in the City of Dunnellon. Named after the river itself, which is historically known as "Blue Run," the park is a wonderful example

of what can happen when multiple partners work together toward a common good.

Because of its natural and economic importance to the City and Marion County, community leaders and residents have long worked to protect the Rainbow River from inappropriate development and provide improved public access. Several years ago, an opportunity to fulfill both of these goals came about when 32-acres along the river near the City's center became available for purchase. For some time Marion County used the northern portion of this property as a take-out point for people launching their inner tubes down the river at a County-owned park. The City of Dunnellon began working with the County and other partners, including the Trust for Public Land and Rainbow River Conservation, Inc., to purchase the property. The City submitted a Florida Forever grant application to FCT in May

2007 and was awarded Florida Forever funding. The park was acquired in March 2008, allowing the community's vision of providing additional green space and protecting precious natural resources along the Rainbow River to come to fruition.

Blue Run of Dunnellon Park opened to the public in 2009 and while development is still ongoing, the park is very popular with residents of Dunnellon. On any given day one might find a family strolling the nature trails, or fishermen catching and releasing sunfish on the three-acre pond. Visitors can also be seen taking their canoes and kayaks out on the river, or floating down the crystal blue waters in their inner tubes. When park development is completed, a paved trail will connect the park to the adjacent Marjorie Harris Carr Cross Florida Greenway. In addition, the park will connect to the Withlacoochee State Canoe Trail, the Great Florida Birding Trail, and the Withlacoochee State Trail, thereby making it possible for even more visitors to access the park.

Due to the dedication of community leaders and the assistance of organizations and agencies like Florida Communities Trust, a piece of land surrounding one of Florida's natural jewels is being preserved in perpetuity. The Blue Run of Dunnellon Park brings people of all ages and backgrounds together with the chance to commune with nature and enjoy the splendor of the Rainbow River.





Ocean Hammock Park

City of St. Augustine Beach

hen residents and visitors drive down A1A Beach Boulevard in the City of St. Augustine Beach years from now, they'll see an oasis of green space and a natural beachfront gem nestled in between development along the Atlantic Ocean. This special place, Ocean Hammock Park, will also serve as a permanent sanctuary where threatened and endangered animal species can thrive and people can come out for a stroll on the beach and simply enjoy nature. Without the vision of community leaders



and the assistance of Florida Communities Trust, this land could have been lost forever to another beachside development project.

Ocean Hammock Park was the last undeveloped tract of privately owned oceanfront land in southern St. Johns County. Situated along the Atlantic Ocean, the property provides habitat or nesting grounds for a variety of listed animal species. Some of the wildlife that can be

found on site include loggerhead, green and leatherback sea turtles, gopher tortoises and the Anastasia Island beach mouse. Because of its location, the property was slated to be converted into a subdivision. However, the City of St. Augustine Beach recognized the environmental and recreational importance the property would have on the community and sought to preserve it as a public park.

In the spring of 2008 the City and St. Johns County worked together to apply for Florida Forever grant funds from Florida Communities Trust to purchase the land for Ocean Hammock Park. The effort to preserve the land received broad community support not only in the City but in St. Johns County as well, as evidenced when County Commissioner Cyndi Stevenson and County staff members attended the FCT Governing Board Meeting in September 2008 to speak in support of the application alongside City Commissioner Rich O'Brien and City residents. Ocean Hammock Park received a high final score at the meeting but did not make the initial cut for funding. Thankfully, the story has a happy ending. The City of St. Augustine Beach ultimately received \$4.5 million in Florida Forever funding from Florida Communities Trust when funding became available due to recent lower real estate values and projects higher on the ranking list not costing as much as anticipated.

Once finished, the Ocean Hammock Park will be a jewel of a city park. Along with the protection of precious natural resources, the park will yield enormous recreational benefits for the community by increasing connectivity to other parks and natural areas in the City, as well as the national East Coast Greenway and the Florida Circumnavigational Saltwater Paddling Trail. Visitors can enjoy a picnic with the family, take a swim in the ocean or view the plant and animal life along the nature trail. Park visitors will also have the opportunity to learn more about the beach and dune habitats and the animals that inhabit them through an environmental education center to be created on the site.

Ocean Hammock Park is a perfect example of the spirit of partnership that is at the core of Florida Communities Trust. The City of St. Augustine Beach, with the assistance of St. Johns County and Florida Forever funds provided by the Trust, has ensured that this local treasure will be protected for many years to come.

'The Stan Mayfield Working Waterfronts Program



Bordered by the Atlantic Ocean on the east and the Gulf of Mexico on the west, Florida has been shaped by a profound connection to the water. Our state's coastline totals nearly 1,200 miles and serves as the backbone for many communities by supporting tourism, recreation opportunities, and providing traditional working waterfronts that help sustain local economies.

Traditional working waterfronts have played a critical role in our history, culture and economy for many years. According to the Florida Department of Agriculture and Consumer Services, Florida's seafood industry provides more than 200 million dinners each year and Florida has more seafood processing plants than any other state in the country. In addition, Florida fishermen

catch more than 90 percent of the nation's supply of grouper, pompano, mullet, stone crab, pink shrimp, spiny lobsters and Spanish mackerel.

Florida's commercial fishing industry has faced a number of challenges in recent years, from hurricane damage to fishing fleets and processing infrastructure to high fuel prices. Concerned about this crucial component of Florida's economy and culture being faced with such adversity, state legislators designed a program that would help preserve the heritage of Florida's traditional working waterfronts and promote their impact on the state.

In 2008, the Legislature created the Stan Mayfield Working Waterfronts Program through the reauthorization of Florida Forever. Named after the late Representative Stan Mayfield, a tireless advocate for Florida's working waterfronts, this new grant program was given to Florida Communities Trust to administer. The program provides funds to local communities and nonprofit working waterfront organizations to acquire parcels of land used for the commercial harvest of marine organisms or saltwater products by state-licensed commercial fishermen. Acquisitions made under the program may also be used for exhibitions, educational venues, civic events, and other purposes that promote and educate the public about the historical, cultural and economic heritage of Florida's traditional working waterfronts.

The first grant application cycle for the Stan Mayfield Working Waterfronts Program was held from October through November 2008. Twelve applicants from coastal communities across the state submitted applications, three of which were ultimately selected for funding. The projects awarded funding were Blue Crab Cove in Brevard County, the Sebastian Working Waterfronts Collaborative in the City of Sebastian, and the Apalachicola Boat Works in the City of Apalachicola, which earned the distinction of being the first project to be acquired through the program in December 2009.

The Stan Mayfield Working Waterfronts Program is just another way that Florida Communities Trust is accomplishing its goal of enriching lives and landscapes throughout the state. Through this program, coastal communities can educate the public about the history of their local working waterfronts and ensure that these facilities will continue operations for generations to come, providing a boost to the local economy through job creation, product sales and tourism.

APALACHICOLA RIVERWALK PHASE VI

RECIPIENT: CITY OF APALACHICOLA PROJECT NUMBER: 08-078-FF8 FCT GRANT: \$1,642,749.00 ACRES: 1.08

The Apalachicola Riverwalk is located in the coastal community of Apalachicola, a designated Waterfronts Florida Community. The City purchased this site to enlarge a previously acquired FCT park site and to further enhance the site as a destination along the planned downtown Riverwalk. Park visitors will be able to view the river from an observation platform, enjoy themselves at the small splash park, utilize horseshoe pits and shuffleboard court, or stroll through the Orman House and Chapman Botanical Gardens directly across the street. The site will be landscaped and enhancements made onsite to improve the water quality flowing into the river from the onsite wetland slough.

FRED GEORGE BASIN GREENWAY

Recipient: Leon County Project Number: 07-102-FF7 FCT Grant: \$1,227,854.99 Local Match: \$1,575,854.99 Acres: 158.17

Fred George Basin Greenway is located on Fred George Road in an area of increasing development in western Leon County and features Fred George Sink, a historically and hydrologically important feature that forms a direct conduit to the upper Floridan Aquifer. With the acquisition of the Greenway, Leon County will help improve the water quality of Fred George Sink by installing floating booms and trash traps to collect floating debris before water reaches the sink, restoring the natural flow of creeks on site, and revegetating uplands and wetlands with native plants. The proposed recreational amenities include a baseball field, wildlife observation platform, fishing pier, picnic pavilion, and a nature trail that will hook up to a countywide system of greenways, trails and trailheads connecting several parks/conservation areas.

BIG BEND MARITIME CENTER Recipient: Wakulla County Project Number: 07-057-FF7 FCT Grant: \$1,444,659.00 Acres: 5.31

The property is located on Dickerson Bay in the coastal community of Panacea and is adjacent to the County-owned Wooley Park. The purpose of the acquisition is to promote the study, interpretation, and preservation of the maritime heritage of the Big Bend region, which stretches from Apalachicola to Cedar Key. The site includes a residence that the County will convert into a maritime history museum. Recreational improvements will include a nature trail, fishing pier, wildlife observation platforms, and picnic pavilions. Wakulla County also will provide canoe/kayak tie-ups on the dock and a launch facility that will improve access to the Florida Circumnavigational Saltwater Paddling Trail. The day-to-day operation of the property, including running the museum and ongoing educational programs, will be managed by Florida Foresight, Inc., a non-profit organization dedicated to enhancing the economic, social and environmental well-being of coastal communities throughout Florida.

PORT ST. JOE WATERFRONT PARK Recipient: City of Port St. Joe Project Number: 08-077-FF8 FCT Grant: \$1,698,015.00 Acres: 3.29

Port St. Joe Waterfront Park is located along St. Joseph Bay in the City of Port St. Joe, a designated Waterfronts Florida Community. Acquisition of this property will provide additional public access to the Bay and serve as an important link in the City's designated St. Joe Baywalk. The recreational waterfront boardwalk will flank the one-half acre of seagrass beds grading into newly revegetated estuarine tidal marsh onsite and connect to other recreational destinations in the area, including the Maddox House Historical Site at Shipyard Cove, which was previously acquired by FCT. The proposed recreational amenities include a fishing and wildlife observation platform, canoe/kayak launch, and picnic pavilions.

The Apalachicola Boat Works project features a building constructed during the early 20th century that will be restored by the Apalachicola Maritime Museum and converted into a facility that provides instruction in the building and maintenance of vessels utilized in the commercial seafood industry. The opening of this shop will provide commercial fishermen and seafood harvesters with access to repair facilities that are currently unavailable in the community, and train student workers in the craft of historic boat building and restoration.

OCEAN HAMMOCK PARK Recipient: City of St. Augustine Beach Project Number: 08-018-FF8 FCT Grant: \$4,510,300.00 Local Match: \$750,000.00 Acres: 11.43

Ocean Hammock Park is located along A1A Beach Boulevard and the Atlantic Ocean in the City of St. Augustine Beach. The property provides habitat or nesting grounds for a variety of animal species, including loggerhead, green and leatherback sea turtles, gopher tortoises, and the Anastasia Island beach mouse. The acquisition will increase connectivity to other parks and natural areas in the City, as well as the national East Coast Greenway and the Florida Circumnavigational Saltwater Paddling Trail. The proposed recreational amenities include a nature trail, kayak facilities, camping areas by permit, wildlife observation deck, and picnic pavilions. In addition, the acquisition will allow the City to provide direct public access to the Atlantic Ocean by way of a raised dune walkover and create much needed off-beach parking areas.

CAPTAIN ROYAL MELVIN PARK AND PLAZA Recipient: City of Destin Project Number: 08-007-FF8 FCT Grant: \$2,010,407.50 Local Match: \$2,610,407.50 Acres: 0.77

Captain Royal Melvin Heritage Park and Plaza is located along U.S. Highway 98 and the Gulf of Mexico. The property will connect to the Harbor Boardwalk, a land-based recreational trail along Destin Harbor tying into the larger City bike trail system. In addition, visitors to the park will be able to access the Florida Circumnavigational Saltwater Paddling Trail, which includes the mouth of Destin Harbor, via canoe or kayak. The City will remove the existing structures on the property and build a permanent location for the Destin Fishing Museum, as well as provide a picnic pavilion, playground, and observation platforms for public recreation and enjoyment.

TOWN CENTER PARK & PRESERVE Recipient: Walton County Project Number: 08-006-FF8 FCT Grant: \$1,167,360.00 Local Match: \$601,840.00 Acres: 6.58

The property is located adjacent to Point Washington State Forest and South Walton High School between U.S. Highway 98 and Choctawhatchee Bay in southern Walton County. Acquisition of this property will provide a community park within the planned Walton County Town Center, a mixed-use development intended to cluster development away from the coast. The property will serve as a community gathering space for people of all ages and provide much-needed passive and active recreational opportunities. The County plans to coordinate a multi-faceted environmental education program with the adjacent high school and other environmental groups. A loop trail will link the recreational amenities, which will include a community recreation center, nature trail, playground, and picnic pavilion, as well as connect to the park to existing multi-use trails in Town Center and the State Forest.

LAKE DAN PRESERVE – PHASE ONE Recipient: Hillsborough County Project Number: 08-022-FF8 FCT Grant: \$6,154,604.62 Local Match: \$6,154,604.62 Acres: 655.34

Lake Dan is located in northwest Hillsborough County near the Pinellas County line and adjacent to the Pasco County line. Acquisition of this property will create a nature preserve in a built out area and provide wellfield protection. There are plans to connect Lake Dan to the 8,000 acre Brooker Creek Preserve in Pinellas County, parts of which were previously acquired by the Trust. The proposed recreational improvements include a fishing pier, wildlife observation boardwalk, playground, picnic pavilion, and hiking trails.

"The primary benefit of this acquisition is that it expands a large conservation corridor stretching through Pinellas County and Hillsborough County. The property is located in southwestern Pasco County adjacent to Eagle Point Park, an existing County-owned park previously funded by FCT. It is one of the last remaining coastal lands in the most densely developed area of the County and features natural communities that serve as habitat for a variety of animal species. Acquisition of the property also protects large areas of salt flats, a very sensitive and fragile natural community. The proposed recreational amenities include a wildlife observation platform, covered picnic pavilion, front-porch style swing, nature trails and at least four geocaches.

BLUE CRAB COVE Recipient: Brevard County Project Number: 08-002-WW1 FCT Grant: \$1,856,896.28 Local Match: \$999,867.22 Acres: 2.79

Located in Merritt Island, this three-acre property is home to Doc's Bait Shop and Ms. Apple's Crab Shack. Brevard County is acquiring the property to ensure its continued use for the commercial harvest of marine organisms, particularly blue crab and mullet. The commercial seafood operations will be expanded to promote greater use of the dockside and landside facilities by local commercial operators. These services include boat storage, equipment storage, and increased wholesale pickup and refrigeration. Several educational and interpretive kiosks will be set up on the property in order to educate the public about the importance of the commercial fishing industry in Brevard County. In addition, an educational facility will be created on the property for the purpose of hosting meetings and classes that highlight the historical, economic, and cultural impact of the county's commercial fishing industry.





SEBASTIAN WORKING WATERFRONT COLLABORATIVE Recipient: City of Sebastian Project Number: 08-003-WW1 FCT Grant: \$2,565,072.90 Local Match: \$535,008.10 Acres: 2.35

The two-acre property is located along the Indian River Lagoon, and represents a public/private partnership between the City of Sebastian and Fisherman's Landing Sebastian, a non-profit working waterfront organization. The goal of the project is to rejuvenate the commercial fishing industry in Sebastian and provide a destination for waterfront and fishing enthusiasts. The acquisition will link several parcels together in an effort to educate the public about the commercial fishing heritage of the community through a retail/wholesale seafood house, exhibitions, educational venues and events. The property also features an existing docking facility that is currently used by commercial fishermen for offloading their catch and by aquaculturists in the cultivation of clams.

HARBOR BRANCH PRESERVE Recipient: St. Lucie County Project Number: 07-027-FF7

Harbor Branch Preserve extends the Indrio Greenway, an 888acre conservation corridor that includes five preserves previously acquired through the assistance of FCT grant funds. The property borders the Indian River Lagoon and enables the reconnection of a 186-acre mangrove marsh wetland to the Lagoon. The property provides habitat for a variety of listed animal species and contains the largest population of the endangered Lakelas Mint plant species found anywhere in the world. Proposed recreational amenities will include a nature trail, wildlife observation platform, canoe launch, and fishing pier.





THOMAS G. PELHAM, CHAIR



Tom Pelham has served as Secretary of the Florida Department of Community Affairs since January 2007. Working with Governor Crist and other state and local leaders, Secretary Pelham leads the Department's efforts to address and manage growth and development issues affecting Florida's cities, counties, and neighborhoods. An attorney

and certified planner with three decades of experience in environmental, land use and governmental law at the state, regional and local levels, Mr. Pelham is serving the people of Florida for the second time as Department of Community Affairs Secretary. ERICK LINDBLAD



Erick Lindblad has served as the Executive Director of the Sanibel-Captiva Conservation Foundation since 1986. He has been instrumental in the Foundation's acquisition of over 1,850 acres of Wildlife Preserve areas on and around Sanibel and Captiva and has been involved in a variety of

land management activities. In addition, the Foundation has an established Nature Center, Native Plant Nursery, Marine Laboratory, and ongoing programs in environmental education, sea turtle conservation, and natural resource policy. During his tenure, the Foundation has grown from a full-time staff of four to over 25 employees, including grantsupported positions and interns. As part of his commitment to the sustainable development of Southwest Florida, Mr. Lindblad serves on Conservation 20/20, Lee County's Conservation Land Acquisition and Stewardship Advisory Council and the Land Management Subcommittee. He also was appointed by the Lee County Board of County Commissioners to serve as the county's representative on the Babcock Ranch Inc. Board, which oversees the management of the state's 71,000-acre Babcock Ranch Preserve in Lee and Charlotte Counties. RUTH STANBRIDGE



Ruth Stanbridge grew up in Indian River County and served as a county commissioner from 1998-2002. A respected historian, she was appointed as the Indian River County Historian in 1997 and owns a small historical and environmental research and grant writing firm in Vero Beach. Ms. Stanbridge has an extensive background dealing

with environmental and growth management issues. She served for 35 years in the Florida Game and Freshwater Fish Commission's Vero Beach Biological Field Office. She was appointed to the Indian River County Planning and Zoning Commission in 1983 at a time when the county's first Comprehensive Land Use Plan was being developed. She was appointed by former Governor Jeb Bush to the Florida Greenways and Trails Council and she also served the Florida Association of Counties as Vice Chair of the Health and Human Services subcommittee.
