2012 Report on Life Insurance Limitations Based on Foreign Travel Experiences

March 1, 2012

EXECUTIVE SUMMARY

The Freedom to Travel Law, Section 626.9541(1)(dd), Florida Statutes, enacted in 2006, defines the conditions under which the refusal of life insurance, or the refusal to continue existing life insurance based on past or future lawful travel constitutes an unfair trade practice. It is not a violation of Florida Statutes to ask life insurance and annuity applicants questions about past or future foreign travel – it is, however, illegal to take adverse action based solely on an applicant's past or future lawful travel plans. Subsection 6 of the referenced statute requires the Office of Insurance Regulation (Office) to report to the President of the Senate and the Speaker of the House of Representatives by March 1 of each year on the implementation of this paragraph. This is the sixth year of this annual report; the first report was issued on March 1, 2007. The reports from 2007-2011 can be found on the Office's website (http://www.floir.com).

Despite improvement, violations in the Florida marketplace relating to the Freedom to Travel Law continue. The Office is vigilant in its efforts to enforce compliance with the statutory requirements. Over the past six years the Office has refined its efforts to obtain, review and report information relating to Section 626.9541(1)(dd), Florida Statutes. The annual survey of insurers is an important tool in gathering information pertaining to compliance with this law. Additionally, the Office performs examinations so as to confirm the accuracy of this self-reporting process and to determine compliance. And, as required, the Office includes in each market conduct examination of a life insurer a review of information relating compliance with the Freedom to Travel Law. When violations of law have been confirmed, administrative action has been exercised as appropriate.

FISCAL YEAR 2010-2011 SURVEY RESULTS

The Office identified four hundred seventy-two (472) entities that wrote life insurance or annuity products during the scope period of July 1, 2010 to June 30, 2011. The Office required these companies to complete an online survey, and achieved a 100% response rate. The survey results revealed the following information:

^{*}Annuity application: the "4" companies asking past foreign travel questions and "7" companies asking future foreign travel questions are not the same companies. The eleven (11) "yes" answers in this section represent eight (8) different companies.

These results show that questions regarding foreign travel are more prevalent on life insurance applications than on annuity applications. It is also showed that:

- > Seven (7) companies reported having a procedure or underwriting guideline in place that could limit the amount, extent, or kind of life insurance based on past foreign travel.
- ➤ Twenty-nine (29) companies reported having a procedure or underwriting guideline that could limit life insurance based on future foreign travel.
- ➤ Ten (10) companies reported having an existing procedure or underwriting guideline in place that either limited or denied a request by an individual to increase the amount of their coverage based on foreign travel.

The survey required companies to self-report any statutory violations related to life insurance and foreign travel. Three (3) companies self-reported that insurance was postponed or denied for a total of seven (7) applicants travelling to Iraq and/or Afghanistan. In those instances, the companies took into account the waiver provided in the "Order Approving Variance" for the countries of Afghanistan and Iraq mentioned below. Two (2) potential violations were also self-reported involving two (2) applications relating to travel to Mexico and Venezuela, and are under review by the Office.

VARIANCES FROM THE FREEDOM TO TRAVEL LAW

Section 626.9541(1)(dd), Florida Statutes, provides for certain circumstances under which insurers can limit or deny life insurance coverage. Such circumstances are tightly constrained, but could be due to an applicant's future travel plans, if "the insurer can demonstrate that insureds who have traveled or intend to travel are a separate actuarially supportable class whose risk of loss is different from those insureds that have not traveled and do not intend to travel." The statute further provides that the Office can grant to insurers a variance to this requirement if coverage is limited or denied based on travel to specific countries whose conditions could adversely impact travelers' health and safety.

The Office found that Monumental Life Insurance Company met the criteria necessary to be granted a variance. An order was issued on February 15, 2008, granting a waiver due to travel to Iraq and

Afghanistan; the waiver was limited to two years, unless otherwise extended. Subsequent orders were issued, further extending the waiver until February 15, 2014. No further requests have been submitted to the Office for consideration of a variance.
