EXECUTIVE SUMMARY

Overview of Funding and Council Meetings

During 2007, the Violent Crime and Drug Control Council funded 71 cases totaling \$1,909,775.84 to support local and state agencies investigating violent crime, major drug and money laundering cases and victim/witness protection and relocation efforts. The Council met in March, June and December 2007 to review funding requests and to discuss crime issues having an impact on Florida's citizens and visitors. The Council's implementation of statewide Regional Coordinating Teams (RCTs) have proven to be very instrumental in assisting the Council in its review of cases involving violent crime, drug related crimes, and investigations of significant money laundering activities.

In 2007, the Council and RCTs addressed several topics of interest relating to emerging crime trends, innovative technology, improved investigative techniques, enhanced communication, and advanced training for law enforcement officers and criminal justice agencies. The 2007 topics of interest included:

The Council continues to hear best practices and case success stories from multiple disciplines. The RCTs provided a network of coordinated efforts for case reviews and intelligence sharing among the law enforcement/criminal justice community and the general public. This "network" of information-sharing was further enhanced by the Florida Department of Law Enforcement (FDLE) when it launched the Council's first website in October 2002.



In February 2007, the FDLE implemented improvements to the website. Today, the Council's website continues to be a viable source of information for the public and the law enforcement community. The enhanced site contains information on Council membership, upcoming Council meetings, minutes/agendas from prior meetings, all applications and procedures to apply for funding, and success stories. Most importantly, the site contains a contact "map" that can search by individual county and locate contacts for the RCTs. Funding Success Stories

Violent Crime Case

Turnpike Homicide Investigation

The Council provided reimbursement funding to the Palm Beach County Sheriff's Office (PBCSO) at its March 2007 meeting, granting a Violent Crime Reimbursement Application in the amount of \$39,867.53 for the *Turnpike Homicides*.

The PBCSO requested and was granted \$39,867.53 to support this proactive criminal investigation. The bodies of four individuals were found on October 13, 2006, approximately 45 feet from Florida's Turnpike in Port St. Lucie. The family (to include a 3-year-old and a 4-year-old) had been shot execution style. The incident made national news and the event became a priority law enforcement issue. Intelligence indicated that Jose Escobedo was a drug courier. It was later determined that Escobedo was transporting cocaine when he and his family were murdered.

The Council also provided reimbursement funding to the St. Lucie County Sheriff's Office (SLCSO) at its June 2007 meeting in the amount of \$100,000 for their participation in the *Turnpike Homicides*.

The SLCSO requested and received the maximum funding amount of \$100,000 for investigating the violent criminal organization responsible for the *Turnpike Homicides*. At the time of the Council meeting, the SLCSO had expended \$156,376 in overtime and investigative expenses. The SLCSO initially assigned eight detectives and two crime scene investigators to the effort on a full-time basis, which was reduced to two full-time detectives.

Major Drug and Money Laundering Case

Operation Creole Reflections

The Council provided funding to the Fort Lauderdale Police Department (FLPD) at its April 2003 and May 2005 meetings, granting two drug awards totaling \$100,000 for *Operation Creole Reflections*.

The FLPD was awarded Council funding to combat identified Haitian drug traffickers in Fort Lauderdale. The investigation continued from June 2003 until April 2006, which resulted in the arrests of 51 people on drug trafficking charges.

This joint investigative effort by the FLPD, included the following participating agencies: Drug Enforcement Administration, Alcohol, Tobacco & Firearms, Immigration and Customs Enforcement, United States Border Patrol, United States Postal Service, Broward County Sheriff's Office, Lauderhill Police Department, Coconut Creek Police Department, Margate Police Department, Wilton Manors Police Department, Hollywood Police Department, and the Hallandale Beach Police Department.



As a result of this investigation, a Federal Grand Jury returned a 32 count indictment charging 18 individuals with drug trafficking, money laundering and firearms charges. The court also authorized seven search warrants that were simultaneously executed on December 12, 2006. To date, the investigation has resulted in the arrests of 19 defendants and the dismantling of this organization in South Florida. Additionally, law enforcement seized approximately 10 kilograms of cocaine, ½ kilogram of crack cocaine, more than \$800,000 in U.S. currency, four firearms, 11 vehicles, and four residences valued at approximately \$1.4 million.

On August 6, 2007, two of the defendants went to trial in Fort Lauderdale's Federal Court. Upon conclusion of the trial, within two hours, the jury reached a verdict of guilty on all counts for both defendants. The U.S. Attorney anticipates 7 to 15 additional arrests in a second round of indictments.

Victim/Witness Protection and Relocation Case

Lake Worth Police Department

The Council initially awarded Victim/Witness Protection funding to the Lake Worth Police Department (LWPC) at its June 2007 meeting in the amount of \$5,547.77. The relocation effort was subsequently granted reimbursement funding in the amount of \$1,269.73 on a conference call meeting of the Council's Victim and Witness Protection Review Committee on September 26, 2007.

On February 13, 2006, the LWPD responded to a call at a residence in Lake Worth, where they found two gunshot wound victims. Police determined that 27 rounds had been shot from an assault rifle. The case was investigated and the defendant was subsequently charged with two counts of attempted 1st degree murder and shooting into an occupied building.

On February 12, 2007, the LWPD responded to a call at the above-mentioned victims' residence. One of the victims indicated that he had received a threatening telephone call from an unknown caller and had seen vehicles outside his residence occupied by unknown Hispanic males. The telephone call was received one day before the anniversary date of the attempted murder of the two victims in February 2006.

State Attorney Barry E. Krischer deemed the witnesses critical to the prosecution and certified the witnesses as eligible for relocation, pursuant to Section 914.25, Florida Statutes. The LWPD requested and was granted two separate reimbursements totaling \$6,817.50.

On May 15, 2007, this case was closed after a trial by jury. The defendant was found guilty and sentenced to 40 years in the Department of Corrections on charges of attempted 2nd degree murder with a firearm; attempted involuntary manslaughter with a firearm; and shooting into an occupied building.



VIOLENT CRIME AND DRUG CONTROL COUNCIL

In order to address the critical statewide issues of violent crime in Florida, the 1993 Legislature passed the Florida Violent Crime Act of 1993. Section 943.031, Florida Statutes, created the Florida Violent Crime Council within the FDLE to address and develop strategies to combat violent crime occurring in Florida. The 2001 Legislature amended the statute, renaming the Florida Violent Crime Council to the Florida Violent Crime and Drug Control Council. The Council's mission is to provide updates on initiatives that produce meaningful and effective results in Florida's effort to curtail violent crime, drug trafficking, and money laundering. In an effort to fulfill its mission, the Council places emphasis on five initiatives:

- Duties and Responsibilities
- General Membership
- Regional Coordinating Teams (RCT)
- Violent Crime Investigative Emergency and Drug Control Strategy Implementation Account
- Victim/Witness Protection Account

Duties

The duties and responsibilities of the VCDC include:

- Disburse reimbursement funds from the Violent Crime Investigative Emergency and Drug Control Strategy Implementation Account.
- Review and approve those funding requests that meet the criteria from the Victim-Witness Protection/Relocation Account.
- Inform the FDLE Commissioner of programs that provide grants to criminal justice agencies for violent crime prevention and investigative programs. This includes enhanced community-oriented policing, additional undercover officers and other investigative officers to assist with violent crime investigations in emergency situations.
- Inform the FDLE Commissioner on learned methodology that may assist in the prevention of violent crime, drug trafficking, and money laundering.
- Inform the FDLE Commissioner on enhanced criminal justice training programs that address violent crime.
- Inform the FDLE Commissioner of the performance of the RCTs.
- Monitor the activities of the RCTs that review cases involving violent crimes, drug related crimes, and investigations of significant money laundering activities by:
- Ensure the RCTs respond to violent and drug-related crimes as requested by a sheriff, police chief, or other law enforcement official.
- Ensure the RCTs: provide forensic, investigative and technical expertise and facilitate communications and cooperation among law enforcement entities; report to the Council on trends in each region and training provided to law enforcement agencies; and review and approve all violent crime investigative funding requests for the upcoming Council meeting.



- Ensure the RCTs coordinate the identification and development of multi-agency or statewide drug control operations within their regions to achieve the state's goal of reducing drug-related crime as articulated by the Office of Drug Control.
- Ensure that each RCT falls under the direction of the FDLE Special Agent in Charge for the region in which the team operates.
- Ensure that each RCT is comprised of representatives from state, local, and federal law enforcement and prosecuting entities working within their respective region.
- Ensure that each RCT reviews, approves and endorses all matching drug investigative requests for the upcoming Council meetings.
- Ensure all funding requests referred to the Council are supported by the RCT.

General Membership

As prescribed by Section 943.031, Florida Statutes, the Council membership is comprised of 14 members. Eight members of the Council are standing members by virtue of their positions, and six are appointed by the Governor. Council members receive no compensation, but are reimbursed for per diem and travel expenses. Members appointed by the Governor serve two-year terms and the standing members serve as long as they hold office or employment which was the basis for their appointment to the Council. The FDLE provides the support necessary to assist the Council in the performance of its duties. The standing members are:

VIOLENT CRIME INVESTIGATIVE EMERGENCY AND DRUG CONTROL STRATEGY IMPLEMENTATION ACCOUNT

The Violent Crime Investigative Emergency and Drug Control Strategy Implementation Account provides reimbursement funding to state and local law enforcement agencies involved in complex violent crime investigations and trials. It provides matching (supplemental) funding for drug-related investigations and investigations of significant money laundering activities. Since its inception in 1993, the Council has awarded more than \$8.5 million to local criminal justice agencies for violent crime investigations.

During its sixth year of funding drug and money-laundering investigations, the Council provided \$1,645,000 in drug control funding to 36 cases involving partnerships between 22 lead agencies, including local, state and federal agencies. These cases target major drug trafficking organizations located in the State of Florida that are engaged in the distribution of cocaine, heroin, methamphetamine, MDMA, prescription drugs and cannabis. These funds support the cooperative efforts of multiple agencies at the local, state and federal level to dismantle these drug organizations through lengthy and complex investigative efforts, including pen registers, wire intercepts, undercover operations, surveillance, controlled purchases and financial analysis. The cases significantly contribute to achieving the state's goal of reducing drug-related crime as articulated by the Florida Office of Drug Control and the Governor's Drug Control Strategy.

VICTIM/WITNESS PROTECTION ACCOUNT

The Victim/Witness Protection Program authorizes law enforcement agencies to provide protective services, including temporary relocation services, under specified circumstances. Section 914.25, Florida Statutes, enables the lead law enforcement agency to seek reimbursement from the Council for expenses incurred in providing protective and relocation services for victims/witnesses certified by the prosecuting State Attorney or Statewide Prosecutor on or after July 1, 1997.



ACCOMPLISHMENTS AND RECOMMENDATIONS

- **Request appropriation of \$1 million to replenish the Violent Crime Investigative Emergency and Drug Control Strategy Implementation Account.** \$500,000 will be allocated to the General Revenue Fund and \$500,000 will be allocated to the Operating Trust Fund for violent crime investigations. During the 2007 Legislative Session, an appropriation of \$1 million was authorized for violent crime investigations. However, the appropriation amount was reduced to \$200,000 due to Florida's budgetary shortfall.

During the past 14 years, the Council has provided either partial or full funding for investigations or trials of many high profile cases from the Violent Crime Investigative Emergency and Drug Control Strategy Implementation Account.

Between January 1, 2007 and December 31, 2007, the VCDC funded three violent crime cases to three agencies totaling \$155,221.05. An agency or county that experiences one of these types of crimes and lacks sufficient funds to provide the proper investigation or trial conditions can apply for reimbursement of up to \$100,000 per year.

- **Request appropriation of \$2.5 million for match drug funding to replenish the Violent Crime and Investigative Emergency Drug Control Strategy Implementation Account.** During the 2007 Legislative Session, an appropriation of \$2.5 million was authorized for the matching drug funding for multi-agency or statewide drug control or illicit money laundering investigative or task force efforts. This funding was appropriated to meet the critical needs of the local agencies in their investigation of major drug offenses/organizations. However, the initial appropriation was reduced to \$925,000 due to Florida's budgetary shortfall.

Between January 1, 2007 and December 31, 2007, the VCDC funded 36 matching drug control and illicit money laundering investigations for 22 lead agencies totaling \$1,645,000. The successful investigation of major drug trafficking and money laundering organizations is dependent on the availability of funds to support the costly investigative techniques necessary to dismantle these groups.

- **Request appropriation of \$500,000 to continue the Victim/Witness Protection Program and increase window for providing funds.** An appropriation of \$500,000 was authorized for the Victim/Witness Protection Program.

During the 2007 Legislative Session, an appropriation of \$500,000 was authorized for the Victim/Witness Protection Program. However, the initial appropriation was reduced to \$100,000 due to budgetary shortfall. A Victim and Witness Review Committee within the VCDC is responsible for reviewing and either approving or denying, in whole or part, each of the requests for this type of funding.

Between January 1, 2007 and December 31, 2007, the VCDC funded 32 victim/witness protection cases for 15 agencies totaling \$109,554.79.
