Abstract: Section 414.1251(3), Florida Statutes, requires the Department of Children and Families (DCF) to submit an annual report to the Legislature to ensure accountability and assess the effectiveness of the Learnfare program. DCF shall include the number of students and families reported by school districts as out of compliance, the number of students and families sanctioned as a result, and the number of students and families reinstated after becoming compliant. This report contains FY 2016-17 data from both DCF and the Department of Education (DOE). The data is summarized as follows:

- 1. For the period of July 1, 2016, through June 1, 2017, DOE reported **5,902** students and families were out of compliance.
- 2. For the period of July 1, 2016, through June 1, 2017, DCF imposed a sanction on **718** students and families as a result of being out of compliance.
- 3. For the period of July 1, 2016, through June 1, 2017, DCF reinstated **230** students and families after complying with the Learnfare program.
