#### **Plans for FY 2019-20**

This regulatory plan has been prepared by the Office of Insurance Regulation ("Office") in accordance with section 120.74, Florida Statutes, for the 2019-20 Fiscal Year.

## A. Rulemaking Necessitated by Changes to the Florida Statutes Pursuant to Section 120.74(1)(a), Florida Statutes

Pursuant to section 120.74, Florida Statutes ("F.S."), the Office has reviewed the legislation passed in the 2019 Regular Session and has determined that the following revisions will need to be made to the Florida Administrative Code.

Chapter 2019-57, Laws of Florida, creates section 627.7152, F.S., which requires the Financial Services Commission ("Commission") to create a rule listing required data to be reported to the Office regarding residential and commercial property insurance claims paid in the prior calendar year under an assignment agreement. The Office will create rules to implement this statute. A Notice of Rule Development has not been published. The Office anticipates publishing a Notice of Proposed Rule in 2020.

Chapter 2019-100, Laws of Florida, creates sections 627.6387, 627.6648, and 641.31076, F.S., which require the Commission to file a description of the program on a form and requires insurers to submit certain information to the Office, so it may to determine the baseline for the savings calculation. The Office is creating Rules 690-240.001 and 690-240.002, F.A.C., to implement these statutes. A Notice of Rule Development has not been published. The Office anticipates publishing a Notice of Proposed Rule by the end of 2019.

Chapter 2019-108, Laws of Florida, amends section 440.381(2), F.S., to state the sworn statements by the employer and the agent are not required to be notarized. Rule 69O-189.003, F.A.C., will be amended to remove the notarization requirement contained in the rule. On February 2, 2019, the Office published a Notice of Rule Development. On August 6, 2019, the Office published a Notice of Proposed Rule. The Office anticipates filing the rule for final adoption by the end of 2019.

Chapter 2019-129, Laws of Florida, amends and creates new sections in Chapters 624, 627, and 641, F.S., and creates a definition for "short-term health insurance." The creation of this definition requires the deletion of subsection 690-154(16), F.A.C., which defines "short-term limited duration insurance." On July 24, 2019, the Office published a Notice of Rule Development. The Office anticipates publishing a Notice of Proposed Rule by the end of 2019.

Chapter 2019-160, Laws of Florida, amends and creates new sections in Chapter 651, F.S. The Commission will amend and create new rules in Chapter 193, F.A.C., to implement the new requirements of Chapter 651, F.S. A Notice of Rule Development has not been published. The Office anticipates publishing a Notice of Proposed Rule by the end of 2019.

The Office believes that Chapters 2019-18 (bill 925), 2019-82 (bill 617), 2019-83 (bill 673), 2019-35 (bill 7091), and 2019-137 (bill 23), Laws of Florida, can be implemented without additional rulemaking. The text of the chapters provides sufficient clarity to allow for implementation.

No other legislation from the 2019 Regular Session either mandates or necessitates additional rulemaking by the Commission.

# C. Update on Rulemaking Necessitated by Changes to the Florida Statutes from the 2018-19 Regulatory Plan Pursuant to Section 120.74(1)(c), Florida Statutes

Chapter 2018-131, Laws of Florida, made substantial changes to section 628.4615, F.S. Section 628.4615(11), F.S., was amended to allow a person to rebut a presumption of control by filing a disclaimer of control with the Office on a form prescribed by the Commission. Initially, the Office planned to develop and incorporate forms in Rule 69O-207.004, F.A.C., to implement this subsection. The Office published a Notice of Rule Development on November 1, 2018, in Volume 44, No. 214, of the Florida Administrative Register. Subsequently, the Office

determined the disclaimer of control should be part of an application to acquire a specialty insurer that will comprise Rule 69O-136.090, F.A.C. The Office anticipates publishing a Notice of Proposed Rule by the beginning of 2020.
