RE: Fiscal Year 2022-23 Annual Report on Activities Sponsored through the Court Education Trust Fund

Dear President Passidomo and Speaker Renner:

In compliance with section 25.384, Florida Statutes, and on behalf of the Florida Supreme Court, I am submitting this report on activities sponsored, in whole or in part, through the Court Education Trust Fund during fiscal year 2022-23. Attachment I summarizes trust fund expenditures. Attachment II catalogues educational activities conducted. Attachment III details work on educational publications.

The Florida Court Education Council not only provides oversight of trust fund expenditures, but it also oversees the planning, development, and implementation of educational activities. A skilled staff of professionals provides assistance to the Council through curriculum design, faculty training, content development, legal review, materials development, and program coordination. These educational programs and courses are directed and primarily taught by volunteer judges who have been trained to serve as faculty. This collaborative effort between the Council, judges, and staff leads to an educational framework that is recognized annually as one of the most comprehensive and innovative judicial education programs in the nation, whose participants consistently provide outstanding evaluations.

The 2022-23 fiscal year was the first full-year of in-person programming since the outbreak of the Coronavirus Disease 2019 (COVID-19) pandemic. Although in-person learning remains the touchstone of Florida's judicial educational programming, the Office of Court Education continues to develop infrastructure to provide distance learning courses as a vital component and permanent option for the delivery of high-quality educational content to judges and court personnel.

Additionally, during this reporting period, the Cornerstone Learning Management System was fully deployed for all judges in Florida's 20 judicial circuits and six district courts of appeal. The system serves as a database to track continuing judicial education credits, in addition to serving as a platform to deploy on-demand learning modules. The next implementation phase of this project will be to incorporate access for judicial assistants and other court personnel. This step is important in our goal of expanding access to the system to the more than 3,500 court employees that serve our state.

Furthermore, the Council has continued to offer guidance and oversight to the Court Publications Committee, which is a

subcommittee of the Council and is responsible for the creation and maintenance of various publications that are housed in an online resource library. The library is available on the court system intranet and is designed to provide judges and court staff immediate access to these resources. This reporting period focused on expanding the library through the creation of new publications.

I thank the Council for its continued commitment to the support of these efforts, even while facing challenges. During this reporting period, the 2022 College of Advanced Judicial Studies was cancelled due to Hurricane Ian, and property damage to the venue prevented the program from being rescheduled. The Council helped to ensure the continued availability of content to meet the educational needs of judges and court staff.

On behalf of the Court, I also thank the Florida Legislature for its continued support, without which our judicial education efforts would not be possible. I welcome any feedback on how the judicial branch can enhance its provision of programming to judges and court personnel. I would be pleased to address any questions or provide further information.
