The sole purpose of the Foundation for Indigent Guardianship, Inc. (FIG), is to support public guardianship within the Office of Public and Professional Guardianship and its Mission: "To ensure that every indigent Floridian who requires the services of a public guardian or guardian advocate has access to a qualified guardian." (In order to financially support these efforts FIG established The State of Florida Public Guardianship Pooled Special Needs Trust (SFPGPSNT) in 2006 and has distributed over \$1,000,000.00 for public guardian programs.) The Foundation continues to be the founding trustee with Advocates and Guardians for the Elderly and Disabled (AGED) serving as the administrative trustee.

Results obtained by the organization during the past fiscal year are address in their attached annual report.

4. A brief description of the plans of the organization for the next 3 fiscal years:

FIG looks forward to continuing to collaborate with the Office of Public and Professional Guardians by supporting the goals of the office, in the best interests of the state, and in accordance with the adopted goals and mission of the Department of Elderly Affairs and the Office of Public and Professional Guardians.

Annual Report
2018 - 2019

The Foundation for Indigent Guardianship, Inc., (FIG) is a 501(c)(3) nonprofit direct support organization of the Florida Department of Elder Affairs (DOEA) as provided by Chapter 744.2105, Florida Statutes. FIG's sole purpose is to support the Office of Public and Professional Guardians.

FIG is the administrative trustee of the Florida Public Guardianship Pooled Special Needs Trust (FPGPSNT). FIG established this pooled special needs trust to supplement funding for Florida's 17 public guardian programs. Anyone in need of a pooled special needs trust is encouraged to use the FPGPSNT since the residual funds, upon the death of a beneficiary, go directly to support public guardianship in Florida. Information regarding FIG's FPGPSNT can be found at <http://trustaged.org/the-florida-public-guardianship-pooled-special-needs-trust/>. During fiscal year 2018-2019 ten new trusts were established and twelve were closed due to the death of the beneficiary. As of June 30, 2019, there are 58 subaccounts.

Between July 1, 2018, and June 30, 2019, awards totaling \$19,547.54 were made by FIG to public guardianship offices from the residue of subaccounts in the FPGPSNT. The following programs were recipients of these funds:

Council on Aging – Osceola County - \$4,416.00
Council on Aging of Volusia County - \$4,472.55
Guardianship Program of Dade County - \$10,658.99

Over the past year, FIG increased its marketing efforts related to the financial needs of public guardianship and the FPGPSNT. In addition, six educational programs were sponsored around the

state with the assistance of the staff of Advocates and Guardians for the Elderly and Disabled (AGED).

FIG is working to develop a website. When this website is operational, a link will be posted on the OPPG website so an interested person or organization can make a charitable contribution to help public guardians care for Florida's most vulnerable citizens.

During the previous fiscal year FIG provided funding through OPPG for a study examining actual costs of all 17 state public guardian programs in Florida. The study is using provider models, characteristics, needs, and outcomes of individuals served, and cost savings realized, to determine an appropriate allocation of funds for these programs. Prior to this current study, public guardians (and the Florida Legislature) had been working with a funding formula based on 2009 data. Preliminary information was provided to the Legislature this year and funding for public guardians in Florida was increased. It is anticipated that when the final report is provided to the Legislature, funding will be brought in line with true costs to better be able to serve this deserving population (indigent persons in need of guardianship services).

During the 2018 – 2019 fiscal year, FIG was pleased to again host a reception for the staff of public guardianship offices at the Florida State Guardianship Association's annual conference. Outstanding employees from each of the 17 offices were awarded Certificates of Appreciation. In addition, Pro Bono awards were given to private practice attorneys for the work they contributed to public guardianship programs.

FIG encourages attorneys specializing in guardianship throughout the state to seek out their respective public guardians and offer pro bono services.
