# EXECUTIVE AGENCY ADJUNCT ADVISORY BODY REPORT



Chapter 2024-87, Laws of Florida, requires each executive agency that has an adjunct advisory body to annually upload a report by August 15 to the Florida Fiscal Portal. The report must include the information detailed below.

**Adjunct Advisory Body:** Statewide Judicial Nominating Commission for the Judges of Compensation Claims

2. Provide a brief description of the purpose for which each advisory body is created.

The Statewide Judicial Nominating Commission interviews candidates for appointment or reappointment as Judges of Compensation Claims. Their recommendations, nominations or decisions are directed to the Governor. Their decision not to re-appoint is final under the statute, but any nomination for reappointment leaves the ultimate decision in the Governor's discretion.

## 5. Provide a brief summary of the work plan for the advisory body for the current fiscal year and the next two fiscal years.

The commission will meet bi-annually in each fiscal year, unless circumstances require an expedited or special meeting. The commission works on a schedule dictated largely by the expiration dates of judicial appointments (4-year terms), and will consider 4-6 (generally) candidates for reappointment each fiscal year. Vacant judicial positions are similarly posted for those meetings, and candidates interviewed. Nominations are forwarded to the Governor with applications and recommendations or other supporting materials.

# 6. Provide the amount of appropriated funds and staff time used in each fiscal year to support the advisory body.

Staff time: approximately 50 hours annually

Funds Expended (travel/meeting items): approximately \$3,100 annually

# 7. Provide a recommendation, with supporting rationale, to continue, terminate, or modify the advisory body.

The Statewide Judicial Nominating Commission is a statutory corollary to the Constitutional process of judicial appointment. It is transparent, publicly accessible, and necessary. The process affords consideration of a broad population of potential applicants and serves admirably in narrowing applicant pools for Gubernatorial consideration and appointment or reappointment. To eliminate this process, would potentially create public perception of distinction between the Judges of Compensation Claims and other (constitutional) judges. That
