Statutory Authority: 683.231 Citizen Support Organization for Florida Missing Children's Day

- (1) The Department of Law Enforcement may establish a citizen support organization to provide assistance, funding, and promotional support for activities authorized for Florida Missing Children's Day under s. 683.23.
- (2) As used in this section, the term "citizen support organization" means an organization that is:
 - (a) A Florida corporation not for profit incorporated under chapter 617 and approved by the Department of State.
 - (b) Organized and operated to conduct programs and activities; raise funds; request and receive grants, gifts, and bequests of money; acquire, receive, hold, invest, and administer, in its own name, securities, funds, objects of value, or other property, either real or personal; and make expenditures to or for the direct or indirect benefit of the department in furtherance of Florida Missing Children's Day.
- (3) The citizen support organization is not a registered lobbyist within the meaning of s. 11.045.
- (4) The citizen support organization is specifically authorized to collect and expend funds to be used for awards; public awareness and awards ceremonies, workshops, and other meetings, including distribution materials for public education and awareness; travel; Internet and web-hosting services; administrative costs, including personnel costs; costs of audits; and costs of facilities rental.
- (5) The activities of the citizen support organization must be determined by the department to be consistent with the goals and mission of the department and in the best interests of the state and approved in writing by the department to operate for the direct or indirect benefit of the department. The approval shall be given in a letter of agreement from the department.
- (6) (a) The department may fix and collect charges for the rental of facilities and properties managed by the department and may permit, without charge, appropriate use of administrative services, property, and facilities of the department by the citizen support organization, subject to this section. The use must be directly in keeping with the approved purposes of the citizen support organization and may not be made at times or places that would unreasonably interfere with opportunities for the public to use such facilities for established purposes. Any money received from rentals of facilities and

properties managed by the department may be held in the Operating Trust Fund of the department or in a separate depository account in the name of the citizen support organization and subject to the provisions of the letter of agreement with the department. The letter of agreement must provide that any funds held in the separate depository account in the name of the citizen support organization must revert to the department if the citizen support organization is no longer approved by the department to operate in the best interests of the state.

- (b) The department may adopt rules with which a citizen support organization must comply in order to use department administrative services, property, or facilities.
- (c) The department may not authorize the use of any administrative services, property, or facilities of the state by a citizen support organization that does not provide equal membership and employment opportunities to all persons regardless of race, color, religion, gender, age, or national origin.
- (7) The citizen support organization shall provide for an independent annual financial audit in accordance with s. 215.981. Copies of the audit shall be provided to the department, the Office of Policy and Budget in the Executive Office of the Governor, and the Cabinet.

Description of Mission and Results:

The Florida Missing Children's Day Foundation (FMCDF) was formed in 2010 and its mission is to financially support Florida Missing Children's Day (FMCD). Each year FMCDF collects contributions from law enforcement agencies, businesses, and private donors to provide financial support for the event. The donations are used for operational costs to put on the event including rentals of equipment, facilities, catering, award purchases, award prizes, promotional materials, etc. FMCDF also funds the award prizes to citizens receiving a FMCD award to include the citizen of the year award, school bus operator of the year award, regional essay contest winners, state wide essay contest winner, and the national anthem contest winner(s). FMCDF also reimburses a portion of the travel/hotel expense for impacted missing person families attending the event. The FMCDF provides vital financial support for FDLE's ability to put on the event. This event relies solely on donations.

Description of Plan for Next 3 Years:

The next 3 years is to continue in the same direction. The Foundation is committed to financially supporting FMCD to ensure that each year the State honors and recognizes missing persons and impacted missing person families. FMCD also highlights exemplary citizens, first responders, and other individuals who make positive impacts in missing person issues in Florida. The FMCDF supports the education, safety and protection of all children by contributing educational materials to FDLE for distribution around the state at safety events targeting Florida's citizens.

CODE OF ETHICS**

Section 112.3251, Florida Statutes was effective July 1, 2014 and requires every citizen support or direct-support organization created or authorized pursuant to law to adopt its own ethics code. The Florida Missing Children's Day Foundation, Inc. (FMCDF) is a citizen support organization created under the authority of Section 683.231, Florida Statutes.

It is the policy of the FMCD that the Directors and Officers (Directors) hold their positions for the benefit of the public. They are bound to uphold the Constitution of the United States and the State Constitution and to perform efficiently and faithfully their duties under the laws of the federal, state, and local governments. They are bound to observe, in their official acts, the highest standards of ethics consistent with this code of ethics and the advisory opinions rendered by the Florida Commission on Ethics with respect hereto regardless of personal considerations, recognizing that promoting the public interest and maintaining the respect of the people in their government must be of foremost concern.

As a FMCDF Director, I agree and understand that I will not:

- 1) Solicit or accept anything of value to me, including gift, loan, reward, promise of future employment, favor, or service, based upon any understanding that the vote, official action, or judgment of the Director would be influenced thereby.
- 2) Accept any compensation, payment, or thing of value, on behalf of me or my spouse or minor child, when such Director knows, or, with the exercise of reasonable care, should know, that it was given to influence a vote or other action in which the Director was expected to participate in his or her official capacity.
- 3) Corruptly use or attempt to use my official position or any property or resource which may be within my trust, or perform my official duties, to secure a special privilege, benefit, or exemption for myself.
- 4) Disclose or use information not available to members of the general public and gained by reason my official position, except for information relating exclusively to governmental practices, for my personal gain or benefit or for the personal gain or benefit of any other person or business entity.
- 5) Vote on any matter that I know would inure to my special private gain or loss.
- 6) Failure to observe the Code of Ethics may result in the removal of that person from their position and/or may result in the Florida Department of Law Enforcement terminating its Agreement with the FMCDF.
