SUBJECT: Use of Force Report - 4th Quarter 2024

As required by Florida Statute 943.6872, the Office of Agricultural Law Enforcement has uploaded the Use of Force Report to the Florida Incident-Based Reporting System (FIBRIS) that is managed by the Florida Department of Law Enforcement for the 4th Quarter of 2024 (October 2024 – December 2024). A qualifying Use of Force incident includes serious bodily injury, death, or the discharge of a firearm at or in the direction of a subject. Agencies also must submit a “zero report” for those months in which they did not have a qualifying incident. Please see the pages 2 through 4 for submissions.
