Agriculture Feed, Seed, and Fertilizer Council

Statutory Authority: s. 570.451, F.S.

Purpose of Objective of Advisory Body:

The Agriculture Feed, Seed, and Fertilizer Council (AFSFAC) serves as a statewide forum for the coordination of feed, seed, and fertilizer-related activities and receives reports of relevant enforcement activity conducted by FDACS, including the number of inspections, the number of administrative actions, the number of complaints received and investigated, and the dispositions of complaints; provides advice to FDACS on the conduct of relevant enforcement activities; receives reports on disciplinary actions; and makes recommendations to the Commissioner of Agriculture for actions to be taken concerning the regulation of agricultural feed, seed and fertilizer.

Summary of Work Plan for The Next Three Fiscal Years:

The AFSFAC advises the department on feed, seed, and fertilizer enforcement issues. This council serves as a statewide forum for coordinating feed, seed, and fertilizer-related activities. It is tasked with the following duties: Provide guidance to and enhance communication between the Florida Department of Agriculture and Consumer Services and other appropriate agencies and interests regarding enforcement specific to seed, feed, and fertilizer issues.

Funds and Staff Time Used:

The council holds two to three meetings annually and devotes approximately 175 hours to supporting the council. The advisory body does not receive any specific appropriated funds. The department utilizes base appropriations to support the council's functions.

Should this advisory body be terminated? No

Why?

The AFSFAC serves an important function for the department by maintaining open communication regarding enforcement issues with the seed, feed, and fertilizer industries.

Alligator Marketing and Education Advisory Council

Statutory Authority: s. 570.232, F.S.

Purpose of Objective of Advisory Body:

The Florida Alligator Marketing and Education (FAME) council is focused on increasing education and awareness of the sustainability of alligators through farming and the oversight of wild alligators by the Florida Fish and Wildlife Conservation Commission. A perennial goal is to promote alligator leather (in raw, processed hides and finished products) and alligator meat. The alligator industry funds FAME through a marketing order, which receives money from nuisance, private land trappers, and eggs collected and retained from public waters.

Summary of Work Plan for The Next Three Fiscal Years:

FAME promotes the alligator industry through events such as the Florida Taste of Agriculture and the dissemination of printed materials. FAME focuses on small trade shows promoting alligator hide products to leather workers. Some of the shows targeted by FAME are the Southwest Leatherworkers Trade Show, the Rocky Mountain Leather Show, and the Pendleton Leather Show. FAME is also in the process of putting together a direct marketing campaign that will target leather workers. To promote meat, FAME attends the Seafood Expo North America trade show.

Funds and Staff Time Used:

Staff time ranges from 100 to 200 hours per year. Currently, no appropriated funds exist to support the advisory body. The department utilizes base appropriations to support the council's functions.

Should this advisory body be terminated? No

Why?

FAME is an effective grassroots way to promote the alligator. The alligator industry entirely funds FAME. The council promotes alligator-derived products from Florida producers.

Why?

The department believes that the advisory body's current structure meets the needs and mission set in statute and does not require modification.

Amusement Device and Attraction Advisory Committee

Statutory Authority: s. 570.232, F.S.

Purpose of Objective of Advisory Body:

The Amusement Device and Attraction Advisory Committee was created pursuant to the authority granted in s. 570.232, F.S. Its purpose is to consider and advise on industry-related matters.

Summary of Work Plan for The Next Three Fiscal Years:

Each fiscal year, the Florida Amusement Device and Advisory Committee meets semi-annually. During these meetings, the board works with the department to ensure that new regulations are understood and industry members are well advised of policy changes that may occur based on these changes. The board will continue to provide insight to the department on changes in the industry on the state and national levels.

Funds and Staff Time Used:

During the committee's bi-annual meetings, department staff time was minimal since staff combined the early February meeting with the Florida State Fair and the late fall meeting with consultation visits with the exempt facilities. Approximately 14 hours are spent per year supporting the committee. The advisory body does not receive any specific appropriated funds. The department utilizes base appropriations to support the council's functions.

The department believes the Florida Amusement Device and Attraction Advisory Committee benefits the department as its purpose is to consider and advise on industry-related matters. The meetings allow the department to share their knowledge on current or upcoming issues that occurred at the state and national level and gather information from board members to assist with fulfilling the department's duties.

Aquaculture Review Council

Statutory Authority: s. 597.005, F.S.

Purpose of Objective of Advisory Body:

The Aquaculture Review Council (ARC) seeks to formulate and recommend to the commissioner rules and policies governing the business of aquaculture by studying and evaluating aquacultural issues, providing aquaculture industry recommendations for research and development to be included in the annual revision of the Florida aquaculture plan, and annually submit to the Commissioner a prioritized list of research projects to be included in the department's legislative budget request.

Summary of Work Plan for The Next Three Fiscal Years:

The ARC selected research proposals to be funded during FY 23-24 and will rank research and development proposals to receive FY 24-25 funding. The council will also update the Florida Aquaculture Plan and Research and Development Priorities. For the next two fiscal years, ARC will hear end-of-project presentations for projects funded in FY 23-24. ARC will make revisions to the Florida Aquaculture Plan and Research and Development Priorities, revise and put out a call for Statements of Interest for aquaculture research and development projects for FY 25-26, review the FY 25-26 Statements of Interest, and request proposals from projects of interest, and review and rank the proposals to receive FY 25-26 funding.

Funds and Staff Time Used:

No specific funds were appropriated for ARC projects in FY 21-22 and FY 22-23. Staff spent approximately 200 hours facilitating and attending quarterly in-person meetings, reviewing Statements of Interest and Full Proposals, creating and distributing binders of Statements of Interest and Full Proposals to ARC members, and communicating with ARC members. The department utilizes base appropriations to support the council's functions.

In FY 23-24, \$500,000 recurring was appropriated for ARC projects. Staff spent approximately 480 hours facilitating and attending quarterly in-person meetings, reviewing Statements of Interest and Full Proposals, creating and distributing binders of Statements of Interest and Full Proposals to ARC members and communicating with them, drafting and managing contracts for funded projects, and communicating with ARC members and Investigators.

Should this advisory body be terminated? No

Why?

The ARC plays a critical role in furthering Florida's aquaculture industry by recommending research and development priorities for inclusion in the annual revision of the Florida aquaculture plan and reviewing and ranking aquaculture research projects.

Babcock Ranch Advisory Group

Statutory Authority: s. 259.1053(4), F.S.

Purpose of Objective of Advisory Body:

The Babcock Ranch Advisory Group assists the department by providing guidance and advice concerning the management and stewardship of the Babcock Ranch Preserve.

Summary of Work Plan for The Next Three Fiscal Years: N/A

Funds and Staff Time Used:

The advisory body does not receive specific appropriated funds. The department utilizes base appropriations to support the council's functions, and no staff time is used to support the council.

Should this advisory body be terminated? Yes

Why?

The Babcock Ranch Advisory Group duplicates efforts with the ten-year land management plan review process. Currently, a system is in place to solicit expert and public guidance for the Babcock State Forest Land Management Plan. These plans aim to incorporate, evaluate, and prioritize all relevant information about the site into a cohesive management strategy, allowing for appropriate access to the managed areas while protecting the long-term health of the ecosystems and their resources. Once a draft land management plan is developed, it is presented to the public at a formal public meeting and on the department's website. The objectives of the formal public meeting are to receive public input regarding issues and opportunities that should be addressed in the 10-Year Land Management Plan. With this input, the plan is further amended and finalized to be sent to the Acquisition and Restoration Council (ARC) for consideration. After any necessary changes are made and ARC approves the plan, it is presented to the Governor and Cabinet for adoption. Additionally, the group's work is contingent upon recommendations of membership from the Governor and Cabinet. No recommendations have been received. The department recommends eliminating the group.

Board of Professional Surveyors and Mappers Board

Statutory Authority: s. 472.007, F.S.

Purpose of Objective of Advisory Body:

The Board of Professional Surveyors and Mappers regulates individuals and businesses performing work that falls within the scope of Ch. 472, F.S. It carries out a wide variety of duties, including setting the standards of practice for the profession.

Summary of Work Plan for The Next Three Fiscal Years:

The work plan for the Florida Board of Professional Surveyors and Mappers includes the processing of new applications to submit to the board for review and approval or denial, as well as applications to restore null and void licenses at each of its quarterly meetings held throughout the state. The plan also includes bringing complaints filed against licensees before the Board's Probable Cause Panel to determine if there is probable cause to move forward with further investigation and propose disciplinary actions for board review and approval. For licensees whose discipline includes survey review, the board will consider expert consultant reports and the submitted surveys to determine if the licensee has passed the survey review. The work plan also includes monitoring legislation to determine if statutory changes will result in mandatory rulemaking and to continually review the rules and make changes if it is determined that they are necessary for clarification. The board will also take up other matters of interest or concerns as needed.

Funds and Staff Time Used:

The department devotes approximately 100 to 300 hours per year. The advisory body does not receive any specific appropriated funds. The department utilizes base appropriations to support the council's functions.

Should this advisory body be terminated? No

Why?

The Florida Board of Professional Surveyors and Mappers is necessary to carry out statutory requirements in Chapter 472, F.S. and 5J-17, F.A.C. This includes licensing surveyors and applying and monitoring disciplinary actions when required. This advisory body provides valuable insight on issues pertaining to its subject matter. The diverse perspectives brought forward by these industry experts assist the Commissioner in staying informed on important topics relating to that area, as it pertains to the Department of Agriculture and Consumer Services.

Citrus Budwood Technical Advisory Committee

Statutory Authority: s. 570.232, F.S.

Purpose of Objective of Advisory Body:

The Citrus Budwood Technical Advisory Committee provides advice, guidance, and recommendations to FDACS on matters pertaining to citrus germplasm introduction, nursery stock certification, testing procedures, and other relevant citrus regulatory issues.

Summary of Work Plan for The Next Three Fiscal Years:

The committee's work plan is consistent from year to year while remaining flexible to accommodate new tasks and issues. A core concern for the committee for the next two fiscal years will center around the timely introduction of HLB (citrus greening) tolerant citrus varieties—growers, nurserymen, and regulators will work together as it relates to new variety introductions, testing methodologies, rules, and regulations to help the industry deal with this severe disease.

Funds and Staff Time Used:

The committee does not receive any funds, and the total staff time used was estimated to be 10 hours per fiscal year. The department utilizes base appropriations to support the council's functions.

Should this advisory body be terminated? No

Why?

The Citrus Budwood Technical Advisory Committee (CBTAC) was formed to address new regulatory concerns proactively and placed the decisions in the hands of those affected, i.e., growers, nurserymen, researchers, etc. Having industry stakeholders as voting members empowers the growers.

Should this advisory body be modified? No

Why?

The department believes that the advisory body's current structure meets the needs and mission set in statute and does not require modification.

Endangered Plant Advisory Council

Statutory Authority: s. 581.186, F.S.

Purpose of Objective of Advisory Body:

The Florida Endangered Plant Advisory Council (EPAC) advises and assists the department by reviewing plant species included in and proposed for the Florida endangered, threatened, or commercially exploited plant list.

Summary of Work Plan for The Next Three Fiscal Years:

The council's work plan is consistent from year to year while remaining flexible to accommodate new tasks and issues. The council will review the plant species listed on the Regulated Plant Index. The review aims to determine if any changes need to be made to the list and if any native plants should be added. The Regulated Plant Index is in place to prevent the illegal harvesting of native flora without the landowner's consent. The council will also work with the Division of Plant Industry in the Department of Agriculture and Consumer Services to evaluate grant applications from the Endangered and Threatened Native Flora Conservation Grants Program. Grants are provided through this program to qualifying nonprofit corporations for the protection, curation, propagation, reintroduction, and monitoring of endangered or threatened native flora.

Funds and Staff Time Used:

The council does not receive any funds, and the total staff time used was estimated to be 10 hours per fiscal year. The department utilizes base appropriations to support the council's functions.

Should this advisory body be terminated? No

Why?

The Endangered Plant Advisory Council's primary responsibility is safeguarding Florida's native flora. The rationale for continuing this council is that it provides guidance to the department regarding plant species at risk of being endangered, threatened, or commercially exploited in the state. Additionally, it promotes the growth and cultivation of these species.

Should this advisory body be modified? No

Why?

The department believes that the advisory body's current structure meets the needs and mission set in statute and does not require modification.

Food Safety and Food Defense Council

Statutory Authority: s. 500.033, F.S.

Purpose of Objective of Advisory Body:

The council serves as a forum for presenting, investigating, and evaluating issues of current importance to the assurance of a safe and secure food supply to the citizens of Florida.

Summary of Work Plan for The Next Three Fiscal Years:

The council considers the development of appropriate advice or recommendations on food safety or food defense issues. A meeting is currently being planned for Fall 2024 to discuss ongoing developments. The council intends to hold meetings twice per calendar year, targeting once in the spring and once in the fall.

Funds and Staff Time Used:

Currently, no appropriated funds exist to support the advisory body. The department utilizes base appropriations to support the council's functions. Staff time is approximately ten hours per year.

Should this advisory body be terminated? No

Why?

The council provides valuable insight into food safety and defense issues. The diverse perspectives brought forward by these industry experts assist the Commissioner in remaining informed on important topics related to this area.

Should this advisory body be modified? Yes

Why?

The department would recommend changes to statute to alter the council's membership. Specifically, it would move the following members to ex officio members, allowing a quorum to be more easily obtained:

- Chair of the Agriculture Committee of the Senate or their designee
- Chair of the committee of the Senate with jurisdictional oversight of home defense issues or their designee
- Chair of the Agriculture Committee of the House of Representatives or their designee
- Chair of the committee of the House of Representatives with jurisdictional oversight of home defense issues or their designee

Florida Consumers' Council

Statutory Authority: s. 570.543, F.S.

Purpose of Objective of Advisory Body:

The purpose of the Florida Consumers' Council is to advise and assist the department in carrying out its duties. The membership is intended to be diverse in knowledge and experience to best represent the interests of Florida consumers.

Summary of Work Plan for The Next Three Fiscal Years:

The Florida Consumers' Council has recently appointed new members that more accurately represent the industries regulated by the division. The council plans to foster a dialogue between the various industries and the department on regulatory issues.

Funds and Staff Time Used:

The council does not currently receive any specific appropriated funds. The department utilizes base appropriations to support the council's functions. For fiscal year 2021-2022, the department devoted approximately 13 hours to the council.

Should this advisory body be terminated? No

Why?

The Florida Consumers' Council members are experts in their fields and are vested in protecting the people of Florida. The council is beneficial as it assists the department in carrying out its consumer protection duties. The council is key in disseminating information to and from the department and regulated industries.

Should this advisory body be modified? No

Why?

The department believes that the advisory body's current structure meets the needs and mission set in statute and does not require modification.

Florida Coordinating Council on Mosquito Control

Statutory Authority: s. 388.46, F.S.

Purpose of Objective of Advisory Body:

The Florida Coordinating Council on Mosquito Control (FCCMC) operates under the authority of Section 388.046, Florida Statutes, and is tasked with several responsibilities. Some are conducted yearly; others are as situations requiring the council's input arise. The council seeks to develop and implement guidelines to assist the department in resolving disputes arising over the control of arthropods on publicly owned lands, develop and recommend to the department a request for proposal process for arthropod control research, identify potential funding sources for research or implementation projects and evaluate and prioritize proposals upon request by the funding source, and prepare and present reports, as needed, on arthropod control activities in the state to other governmental organizations, as appropriate.

Summary of Work Plan for The Next Three Fiscal Years:

The council plans to guide and enhance communication between the department and other appropriate agencies and interests. It will also set priorities for research funded through FDACS grants. As needs arise, it will seek to provide guidance to mosquito control programs and other arthropod control-related agencies to reduce duplication of effort, maximize efficient use of existing resources, implement best management practices and available technology, and evaluate arthropod control methods that protect the public health and the state's natural environment.

Funds and Staff Time Used:

Hours worked in support of council responsibilities were approximately 330 per year. The department utilizes base appropriations to support the council's functions and distributes mosquito control funding provided through legislative appropriations from the State's Solid Waste Trust Fund. A portion of the funds (\$500,000) is for mosquito control research. These funds specifically support applied and basic research into the practical methods of control used by Florida mosquito control programs, including research into the prevention of mosquito-borne illnesses. Any public university or college in Florida may conduct the research.

Should this advisory body be terminated? No

Why?

The FCCMC serves a critical need when disputes arise between land managers representing state lands deemed environmentally sensitive and biologically highly productive. The council also provides networking opportunities for the different agencies and points of contact for the department in case of communication issues between land managers and mosquito control programs.

Should this advisory body be modified? No

Why?

The department believes that the advisory body's current structure meets the needs and mission set in statute and does not require modification.

The diverse perspectives brought forward by these industry experts assist the Commissioner in staying informed on important topics relating to that area, as it pertains to the Department of Agriculture and Consumer Services.

The department has found it increasingly difficult to maintain a full council, and recommends amending s. 573.112(1), F.S. to eliminate the requirement to have alternate members.

Florida Forestry Council

Statutory Authority: s. 589.01, F.S.

Purpose of Objective of Advisory Body:

The council considers and studies the entire field of forestry by advising, counseling, and consulting with the department in connection with the promulgation, administration, and enforcement of all laws and rules relating to forestry. The council additionally considers all matters submitted by the department to offer suggestions and recommendations regarding changes in these laws and rules.

Summary of Work Plan for The Next Three Fiscal Years:

The council annually conducts one in-person meeting and handles business by email as needed throughout the rest of the year.

Funds and Staff Time Used:

The preparation of reports takes roughly eight to ten hours for each section; the administration review by the director takes approximately five hours; the administrative preparation of meeting packets and assembly of packets takes approximately eight hours; and the annual meetings average three to four hours. The department utilizes base appropriations to support the functions of the council.

Should this advisory body be terminated? No

Why?

Through its insights and policy recommendations, the council provides valuable insight into the field of forestry. The diverse perspectives brought forward by these industry experts assist the Commissioner in remaining informed on important topics related to this area.

Florida State Fair Authority

Statutory Authority: s. 616.251, F.S.

Purpose of Objective of Advisory Body:

The Florida State Fair Authority (FSFA) was statutorily created by Chapter 616, Part III, F.S. As a separate corporate body, the appointed Board oversees the Authority's staff. The authority is responsible for staging an annual fair to serve the entire state.

Summary of Work Plan for The Next Three Fiscal Years:

In the last eight fiscal years, FSFA has invested over \$28.4 million in capital improvements at the Fairgrounds. The Fair Authority has funded approximately \$23.3 million from operating proceeds, with the remaining \$5.1 million funded by the Legislature. FSFA has identified long-term needs of \$77.6 million to maintain and enhance our current facilities and \$60.0 million for opportunities to expand our facilities to keep the Fairgrounds viable for the foreseeable future. The FSFA currently generates a positive annual cash flow from operations, but the Fair Authority's existing cash reserves are insufficient to address the long-term capital needs and expansion opportunities. Statutorily, the FSFA also lacks the ability to borrow funds to meet these needs. Replacement of infrastructure and equipment and any other critical needs will dominate our expenditures from operational cash flow. Assuming more robust financial results in FY 2025, the Fair Authority will push to increase its operational funded capital back to \$3.5 to \$4.0 million in FY 2026. This will allow the Fair Authority to allocate approximately 50% of its capital to higher-impact items in its long-term plan.

Funds and Staff Time Used:

Pursuant to s. 599.012, F.S., the department shall use the funds deposited in the trust fund to develop and coordinate the implementation of the State Viticulture Plan, promote viticulture products manufactured from products grown in the state, and provide grants for viticultural research.
